

Doctors now legally able to discuss marijuana as treatment option

Last Thursday marked a first for physicians and patients in the state of Missouri. On December 6, Missouri physicians could legally begin discussing medical marijuana as a treatment option with patients. With voters approving medical marijuana in the General Election, the wheels are turning to get physicians, patients and dispensaries in a position where it will be medical marijuana is a legal option for treatment of a variety of ailments.

Local physician Dr. Lisa Roark, MD, was a vocal proponent of medical marijuana

leading up to the election. With the change in law last Thursday, she said she is already discussing medical cannabis as an option for patients with a variety of issues. She said since last Thursday, she's met with over 20 patients from all over the state wanting to get the process started to receive their medical marijuana cards.

Dr. Roark said that while she is meeting with patients, the actual treatment options aren't available yet, but she is giving letters of intent to her patients. She said, "Basically what I'm doing is going ahead and getting records if it's not a

patient I regularly see. I make sure I go through their whole health history and see what they've tried in the past and decide together with the patient if it is appropriate for them. I give them a letter that they have a qualifying condition, but I also advise them that since we have no legally available medical marijuana that I cannot guarantee their legal protection because even if they have a qualifying condition and it's legal in our state, which it is, there is no legal cannabis.

"It means they would have to break the law to have that"

At least one county's pros-

ecutor's office in Missouri, Jackson County, announced they would no longer prosecute cases for simple marijuana possession after voters approved the initiative, despite the current definition of the law.

Locally, Barry County Prosecutor Amy Boxx said her office will continue to use the current legal parameters of

marijuana, regardless of a letter. She released the following statement: "The Barry County Prosecutor's office will continue to follow the law as it exists at the time an alleged offense occurs. Each situation will be reviewed on an individual, case by case basis; determining whether sufficient evidence exists to file charges. The law is

ever changing, based upon the will of the people. However, until a new law becomes effective, the prosecutor's office is charged with upholding the current version of the law and holding individuals accountable for violating the same."

Barry County Sheriff Gary Davis shared Boxx's sentiments on the matter, as well. He said,

Former Barry County man sentenced to 17 years for sex with minor

A former Barry County man was sentenced to 17 years incarceration for travelling to Tennessee for illicit sex with a minor, according to a press release by the U.S. Attorney's office of the Western District of Missouri on Monday. Michael Peterson, 35, of Morristown, Tenn., was sentenced on Friday, Dec. 7, by U.S. District Judge Roseann Ketchmark.

Peterson had pled guilty to the crime on April 25, 2018, after being indicted by a federal grand jury in March 2015.

According to original affidavits of probable cause by Task Force Officer Tim Williams with the Southwest Missouri Cyber Crimes Task Force, Peterson, who was 32 at the time, and the 15 year-old victim had sexual intercourse in March 2014 in Cassville, and the investigation was initiated by the Cassville Police Department.

According to Williams, Peterson and the victim exchanged multiple photographs via SnapChat on their cell phones as well as illicit conversations. A warrant was initially issued through Barry County for statutory rape in the second degree, but officers were unable to

locate Peterson to serve it.

Officers eventually located Peterson in Morristown, Tenn., where he was living with the victim, who was pregnant with Peterson's child, and her biological mother. Peterson stated in an interview that he had been living with the victim since June 2014. The victim's mother was aware of the sexual nature of their relationship and allowed Peterson to live with her daughter, according to the court papers.

The victim was taken into protective custody of the state of Tennessee and placed in foster care pending an investigation, according to the affidavit.

In the press release from earlier this week, it confirms the initial statements by officers that he lived with the child victim and her mother and helped pay for rent and groceries. The child of Peterson and the victim was born on February 26, 2015.

The case against Peterson was prosecuted by assistant U.S. Attorney Ami Harshad Miller. It was investigated by the Southwest Missouri Cyber Crimes Task Force, Immigration and Customs Enforcement's (ICE) Homeland Security Investigations (HSI) and the FBI.

CoxHealth announces new \$42 Million Monett hospital plan

On Monday, December 15, CoxHealth released an official statement announcing their plans to break ground on a new facility in Monett. The project is expected to cost around \$42 million and will be located on Highway 60.

The new hospital will replace the current facility, built in 1953, which began as St. Vincent's Hospital. It became part of CoxHealth system in 1993 at 801 North Lincoln Avenue. It is currently one of two CoxHealth critical access facilities in the area, the other being Barton County Hospital in Lamar.

"Our current hospital has served the community well over these six decades, but we believe it's time to grow and a new facility is part of that," said Darren Bass, president of Cox Monett Hospital, in an official statement on the CoxHealth website. "We're very excited for this project and believe it will raise the standard of care we're able to offer patients in this region."

The construction of the facility comes about as part of CoxHealth's mission to provide health care to rural communities where access to medical care is limited.

"When someone is having a heart attack or a stroke, time is of the essence to ensure optimal recovery. Critical access hospitals like Cox Monett are vital to offering that care for patients," said Steve Edwards, president and CEO of CoxHealth, in the official statement. "It's a privilege to be able to offer this level of service in a rural area where it's so desperately needed."

The new facility will be along Highway 60, east of Lowe's on the land currently occupied by the Bryce Oaks Golf Club.

Courthouse steps replaced thanks to donation

Thanks to a donation, the Barry County historic courthouse has much-needed new marble steps on the west entrance. The Stehlik family, who have a long history in Barry County, donated the marble to the county to have them replaced during an outside rehab of the courthouse this fall.

Barry County presiding commissioner Cherry Warren said without the Stehlik family's contributions, the county would not have been able to replace them. He said, "When we looked at the steps to be replaced, we were looking at the cost of the concrete and we wouldn't have been able to do this without the donation from Corky, Herschel and Brenda. We probably wouldn't have steps without them."

At a recognition event at the courthouse, commissioner Wayne Hendrix said, "I just

want to say thank you for the contribution. It looks great, and we couldn't have done it without you all."

The steps on the courthouse deteriorated due to salting during winter months. When a handicapped ramp was installed, the steps on the west side were covered in concrete, as well. The decision to use stone would make the steps true to the original concept when the courthouse was built in 1913. The remaining steps on south and east sides are still original."

The Stehliks were represented at a gathering to thank them for their contribution by Herschel Stehlik, Corky Stehlik and Brenda Cardin. They

have a long history in Barry County, according to Warren. He said, "Herschel has as much interest in this courthouse as I do, and I love this courthouse."

Corky shared the family decided to donate the stone to the courthouse as a way to preserve family legacy in a way. He said, "Barry County has been good to us. It's a small way for us to give back. My mom and dad had the lumber business for 38 years and I've been in the concrete business for 43 years, and Brenda taught school here for 20 years."

Herschel said, "We're happy to do what we could"

The family's decision to donate the stone, which is a

Napoleon gray marble, came with one condition. Corky said, "The request was that the stone come from Phenix Marble Company."

Herschel was born in Phenix and his family had a long history working for the stone company until it closed in 1943 before eventually being revived. With the commissioners' approval, the Stehliks donated the marble that came from an area where the family has roots, as well.

Herschel shared that his father, his grandfather and three of his uncles worked at Phenix Marble Quarry. Herschel penned in a memoir, "At one time, the quarry employed about 200 people and shipped

marble all over the country. That marble was used to build the Missouri Capital Building, the First and Calvary Church in Springfield, the New York Stock Exchange, the Fine Arts Museum in San Francisco and many other buildings across the country."

The stone used in the steps on the courthouse also has a small fossil in it in the shape of a heart. Corky said, "A fossil in one of the steps is in the shape of a heart and is symbolic and very fitting."

Warren concluded, "On behalf of the Barry County commissioners, the office holders and Barry County citizens, we want to show our appreciation for the contribution

of the Stehlik family."

“Medical marijuana without a doctor’s prescription is still basically illegal. Once they get the cards and it’s within the law, that will be different. But it’s still illegal today.

“There are no legal dispensaries in the state, and when they get us the changes in rules and regulations, we’ll get on board.”

Despite the risk, Dr. Roark said medical conditions of some patients consider it worth the risk. She said, “I tell patients, I can’t tell you this letter will protect you. It’s not going to hurt, but realistically, you could still go to jail for using marijuana for medical purposes.

“One of my patients is a kiddo who has waited and waited, and they have horrible seizures. There are these debilitating conditions that could kill them within a year. People think this was legalized just so people can smoke pot, but until you’ve seen it or lived it, you just don’t understand.

“Even if some people don’t support it, I still think it’s the right thing to do for patients.”

For patients who do qualify, the Department of Health and Senior Services has until June 4, 2019, to develop an online application and post it. They then have until July 4, 2019, to begin issuing cards to patients with a doctor’s recommendation.

It will then be August 3, 2019, when applications for facilities or dispensaries will be accepted and then approval of the August applications will be made December 3. Essentially, it is still about a year out before medical marijuana will be available for purchase. For patients who will grow their own plants, it could be sooner once they receive their cards.

Dr. Roark said, “When I can file with the Department of Health, I will, but it is still a wait until June 4.”

In order to ensure she is

providing patients with accurate and thorough advice, Dr. Roark has taken the initiative to get educated on marijuana’s medicinal uses. She said, “I’ve actually done online CMEs (Continuing Medical Education). I’ve also been to several large events with educational seminars. It still doesn’t count as CME because it wasn’t legal in Missouri, but I’ve still gone out of my way to get educated.

“There has been no doctor education because it’s been illegal up until now.”

Because of Dr. Roark’s outspokenness on the topic, patients have scheduled appointments from all over the state, including from up around Kansas City and St. Louis. She said that since they are non-members of her clinic, those appointments are treated like any other physical open to the public, which is \$100. For members, the appointment is free as usual.

She said, “We are just charging like we do for any physical. Whether it is a Boy Scout physical or a foster care physical. It’s

just like any other physical for the certification.

“There are going to be a lot of physicians not doing these certifications whether it’s because they work for a larger medical facility that won’t allow it or they don’t understand the benefits. I wanted to make sure that people have the medical care they need for this.”

Dr. Roark also plans to open a dispensary in Cassville to provide a location for patients to purchase their medication locally.

While the earliest a dispensary could open would be later 2019, she still responded to questions about conflict of interest. She said, “There are going to be 24 dispensaries in our congressional district. I don’t feel like I have a monopoly on it by any means. They can go to any dispensary. They don’t have to go to Cassville. In fact, a lot of people I’ve done certifications on are not from Cassville.

“I’ve been very outspoken about my support and they know they’ll get the help they need if they come to me. If I

was the only one with a dispensary, yes, it would be a conflict, but we’ll have a minimum of 24 just between here and Joplin and Springfield basically.

“I just certify that they actually have a medical condition. The Department of Health will actually issue those cards and make the final decision.”

When the dispensary opens, it’ll be in the same location as a former well-known doctor from Cassville. Dr. Roark explained, “The building we purchased to do the dispensary isn’t in city limits. It was annexed out for Doc Mary when they only could have one doctor’s office in town. I’ve al-

ready contacted the city to annex back in.

“The whole reason why I want to do this in Cassville is I want this revenue to come back in town so we have that tax revenue locally. It’s not in my personal interest, but it’s the right thing to do for the community.”

SLT New director bringing new ideas to hometown theater

There’s a fresh face in the halls of Southwest Schools this year. Taking over for the now retired Wyatt Hester, Chelsie Leroy is the new drama teacher as well as the new director for the Southwest Little Theater.

Leroy said she’s been told more than once that she has some big shoes to fill. “I was told by my principal, Mr. Roller, not to fill anyone’s shoes but rather to make my own,” said Leroy. “One of the stipulations of my hiring was that I was to bring my own uniqueness to the program.”

Leroy was a former student of Mr. Hester and attended Southwest from kindergarten on through 12th grade. “I was never all that

interested in acting,” said Leroy. “I was always more interested in the technical stage aspects of theater, but Mr. Hester put me on stage and made me act. I fell in love with it.”

Ms. Leroy came in to the program in her own unique way. “This is technically still my student teaching,” said Leroy. “Through that, I’ve had to be observed by my university as well as my cooperating teacher.”

Leroy began her college career through dual credit courses at Crowder College before finishing the bulk of her education through Missouri Southern State University. She will graduate in spring 2019.

“I went to see one of the Southwest plays this past summer,” said Leroy. “While I was

there, I asked Mr. Hester if he had any advice as far as getting my applications out there, and he asked if I would be interested in taking his spot.”

Under new leadership, the theater program faces its share of challenges. The lights that originally lit the theater were owned by Mr. Hester and left with him. Much of the set and costume design also belonged to Hester.

“Thankfully, the drama department has its own account that Mr. Hester left pretty full for us,” said Leroy. “I’ve been handling a lot of the new set design myself. It’s been stressful, sure, but I think it all works really well.”

Leroy faced some additional challenges from the student body itself.

“There were parents and students worried,” said Leroy. “I had students that wanted to drop the class when they found out that Mr. Hester wasn’t going to be returning, Thankfully, once the year got started, everyone saw that I was continuing the work Mr. Hester had been doing.”

Leroy has some new ideas for the program that tie in to her own love for the arts. Having to wait for the lights for the theater to come in, she’s had ample time to prepare her students for challenges other than acting .

“I used the time to educate them on other roles in the theater,” said Leroy. “I’ve been teaching them more about stage design, costuming and other technical aspects of theater.”

Leroy’s directorial debut with the Southwest Little Theater will be Friday, December 14. The theater will perform their take on Dr. Seuss’ ‘How the Grinch Stole Christmas,’ starring Isaac Starr as the titular Grinch.

“Preparations have been stressful,” said Leroy of the performance. “I understand now

why Mr. Hester always seemed so stressed out around performance time.

“The first challenge we ran into was just deciding what we would be performing. We’ve done ‘A Christmas Carol’ a few times before. I wanted to give everyone something that they had never seen from Mr. Hester.”

Leroy eventually settled on The Grinch due to the class response to the piece when reading the script in class.

“We were ten minutes before the bell,” said Leroy. “So, I asked everyone to put their Chromebooks away and some of the kids were like ‘No, Ms. Leroy, please keep going.’ They just wanted to read it for five more minutes.”

The Southwest Little Theater will have its first production of ‘How the Grinch Stole Christmas’ on Friday, December 14, at 6 p.m. There will be showings on Saturday, December 15, at 3 p.m. and 6:30 p.m. The Friday show will be preceded by ‘Christmas Tea,’ presented by the middle school students followed by three short skits. The Saturday showing will begin with a presentation of Charles Dickens’ ‘A Christmas Carol’ before the main play.

One arrested in Monett narcotics search warrant execution

A Monett man was arrested after a narcotics search warrant was served at his residence on West Scott Street last week. Joshua Planchon, 28, is charged with delivery of a controlled substance.

The Cassville Middle School gym served as the setting for this non-conference clash. The Bulldogs entered the contest with a 4-2 record, while Cassville owned a 3-2 slate. Barrett Milleson's team was still searching for its identity after bookending the Marionville Tournament title with losses to Berryville and Neosho.

Back on December 4, Blue Eye drilled Berryville, 58-44. That's the same Berryville team that handed Cassville a 74-65 season-opening loss. Based on that one common opponent, Blue Eye was favored going into Tuesday's game. The Bulldogs also owned a decided height advantage, and a serious shooting threat named Andrew Mitchell.

Southwest crowns Robbins as Tip-Off Queen

“We plan to break ground in March 2019,” stated Janell Patton, press representative of CoxHealth Monett. “We expect to be moving in two years after that.”

There’s no word yet on what will be done with the current facility once the new facility opens, though CoxHealth is currently looking in to the options, according to Patton.

“We’re still looking at a lot of different organizations,” said Patton. “We’re hoping to find one that can put a facility that size to good use.”

Though CoxHealth made the announcement, some of the finer details of the construction have yet to be decided upon.

“We haven’t awarded any construction contracts as of yet,” stated Patton. “This is still relatively new, and we’re still getting some things together re-

garding funding.”

The 70,000-square-foot facility will offer an enhanced Emergency Department, multiple operating rooms and an attached office building that will house physician clinics, 40 exam rooms, as well as a cardiac rehab facility.

“We hope to grow, but we’re not ready to say whether or not we’ll be expanding any services,” said Patton.

The facility is currently expected to cost \$42 million.

“We have \$35 million of that coming from CoxHealth itself,” stated Patton. “The other seven million we hope to get through fundraising.” There is no word yet on what those fundraising efforts will entail.

Plans to expand or rebuild CoxHealth in Monett have been in the works for over a decade. “We’ve had

the land since 2005,” said Patton. “This has been a long time coming.”

The community reaction to the announced construction has been largely positive. Patton made a special note about how much support the announcement had received even on the first day.

“It’s been overwhelming to hear the amount of support and feedback,” said Patton. “I keep looking at Facebook at all of our likes and shares. We just feel so blessed to have such a wonderful and supportive community.”

CoxHealth of Monett will remain operational until it moves to its new location sometime in 2021. For more information, contact CoxHealth Monett at (417) 235-3144 or online at coxhealth.com.

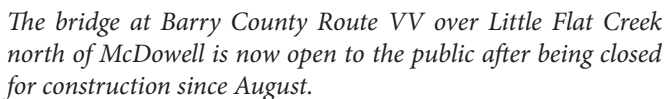

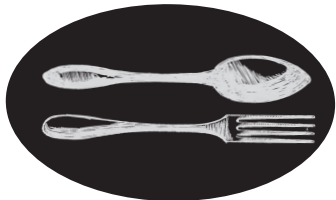
