

Community mourns loss of Wheaton Fire Chief Bob Lombard

Barry County is mourning the loss of Wheaton Fire Chief Bob Lombard this week. Lombard, who served with the department for 62 years, 51 of those as chief, passed away peacefully in his home, surrounded by family on Friday, December 15.

Last year, Chief Lombard, his family and fellow volunteers gave interviews in celebration of his 50th year as fire chief. At that time, Bob said he signed up to volunteer with Wheaton Fire when he was 18.

When Bob first volunteered with the department, they were funded by dues paid from the community. In 2013, voters in the Wheaton community voted to change the department to a fire protection district funded by a property tax levy. Over all those years of change, Bob was the constant presence in the community and dedication to the department helped to make it what it is today.

Larry Prewitt, a volunteer with the department from 1981 to 1996 and current chairman of the fire protection board, said training was always paramount to Bob's vision and operation.

Bob's son, Lindy, said it was his father's influence that showed him what it was to be dedicated to the community. For his 50th celebration, Lindy shared, "The dedication he has to the people of the community to protect and serve them is unbelievable. I heard that from the guys on there

now and former volunteers, and that's what I've learned. The reason I'll stay with it, it's seeing the sacrifice he has made for our community to protect and serve."

That heart of service passed on not only to his son, but to his grandsons, as well. His son, Lindy, has been with the fire department for 41 years, and Bob's grandsons, Stuart and Taylor, have been volunteering with the department for 18 years and eight years, respectively.

Stuart called his grandfather his greatest role model and said in all of the years, he never once heard a negative word from Bob about his service to the community.

Last year, Taylor said, "He's my biggest role model. He would do anything for anybody my whole life. I wanted to follow in his footsteps."

Lindy summed up the feelings that many people who knew Bob shared over the years. He said, "He is definitely my hero."

Bob is survived by his wife, Kay; his son, Lindy; his grandsons, Stuart and Taylor; and great-grandchildren as well as many other family and friends.

Lombard's funeral service was Tuesday, December 19. Lombard's full obituary is on page 5A.

Officers find, charge man involved in Eagle Rock hostage incident

An Eagle Rock man who was the subject of a SWAT raid and subsequent manhunt last week is now in custody and charged with burglary and violation of an order of protection. James Leroy Walls, 43, of Eagle Rock, was booked into the Barry County Jail on Thurs-

day, December 14, at 2 p.m. On Friday morning, December 15, Barry County Sheriff Gary Davis said, "We filed yesterday on James Leroy Walls. He is the individual involved in the hostage situation this week."

Davis added that they did not request kidnapping charges against Walls, but instead asked for burglary

to a witness who had been inside, Walls was holding two women and a child hostage inside. The witness also told officers Walls' vehicle was blocking the driveway where no other vehicles could leave the property.

Once officers were able to interview the victims inside the home, they said Walls had broken into the

Walls was charged with burglary in the first degree and violation of a child protective order on December 14. He is currently being held in the Barry County Jail in lieu of a \$50,000 cash-only bond.

Sex offender found guilty by jury, sentenced to three years

A homeless man from Cassville was found guilty of rape in the second degree and sodomy in the second degree. The same jury recommended three years incarceration with the Department of Corrections on the rape charge and one year incarceration in the jail for the sodomy charge. Matthew O'Leary, 31, will have a formal sentencing hearing in front of Judge Alan Blankenship on February 26, 2018.

According to the affidavits of probable cause by the Barry County Sheriff's Department Detective Robert Evenson, O'Leary forcibly raped and sodomized a victim on Private Road 1120 in Cassville on August 18, 2015. The report states that O'Leary used force to the sexual acts on the victim and she was unable to get away. Officers reported the victim tried to get away from him or stop him from doing the acts to her.

The jury trial began on December 6 and the jury returned their verdict of guilty on

December 7. O'Leary is being held in the Eagle Rock on Thursday Barry County Jail until his sentencing hearing.

O'Leary is also awaiting trial on separate Patrol crash report, a truck charges after he was arrested for the rape. On March 27, 2017, officers reported that O'Leary Highway F and his the other possessed a metal object that had been sharpened on the edges and could be used as a weapon as well as a baggie of amphetamine. Carter C. Fletcher, 16, of O'Leary was charged with possession of a Eagle Rock, was driving weapon in a county jail and possession of a a 2005 Chevrolet pickup controlled substance in a county jail.

Then, on May 11, 2017, officers reported that O'Leary manipulated the lock on his cell to exit his cell without permission. O'Leary was seen by officers walking around the pod Fletcher crossed the cenarea and refused to go back into his cell. O'Leary was charged with escape/attempted escape from confinement for that incident.

O'Leary is slated to have a jury trial on those three charges on March 14, 2018, in the courtroom of Judge Jack Goodman.

was towed from the scene by Brice's Towing of Cassville. The Corolla was towed from the scene by Wilson's Wrecker, of Washburn.

Ball's death was the 109th fatality for Troop D this year.







I grew up in the early eighties and part of our Christmas tradition was the long pilgrimage home-an eight-hour road trip with my mom that would often stretch well into the early winter evening.

As any seasoned traveler knows anticipation has a way of making the last hundred miles of any journey feel exponentially longer than all the miles that came before it. By the time the sun went down, the beautiful bond between mother and child had deteriorated into what could best be described as a hostage situation.

Whether she was the hostage, or I was, is unclear, as reports differ widely, but one thing is certain: in the days before electronics brought peace on earth and lit up the backseats of every vehicle, there wasn't much left to do once it got dark but look out the window

and watch the miles slip by. I remember my heart leaping with excitement every time I saw Christmas lights twinkling in the distance; every year they would seem to light the way home.

Even decades after moving to Cassville, it never feels more like home here than it does during the holidays. I grew up as an only child sandwiched between two huge sprawling families. A lone island in a raucous, jubilant sea of cousins. Coming home to Cassville for Christmas was like stepping through the wardrobe into Narnia. My greataunt's house would overflow with family, their faces at once as foreign and as familiar to me as the stars. I loved them all, fiercely.

Things change. Things stay the same. When I went to college, the long car ride with my mom was traded for long layovers alone. When I got older, I began hanging the lights that guided others, something that eventually inspired an idea for a lighting contest, with a twist, one that would be accessible to everyone, regardless of circumstances. A lighting contest inspired by those long car rides, and then childhood excitement of coming home for the holidays.

It's been bittersweet to see the Festival of Lights become a reality. When I see the lights shining in the dark, I can't help but be reminded of those that have gone out, of the people whose light shaped everything I understand about love and family and Christmas.

My grandpa, Mike Petty, passed away this month,

his loss forever tattooed on our hearts. He was a true light, an inspiration to all those lucky enough to know him. Grandpa had a joyful exuberance for life. He was shamelessly silly and infectiously funny. He worked hard, played hard, laughed often and loved with absolute devotion. He took life in his hands and rolled it between his fingers until it became an adventure, and with a flick of his wrist, his adventures seemed to turn into opportunities he could pluck out of thin air. He was fiercely loyal, funny, and kind.

I share this all with you just to say that I hope that everyone can take a moment to reach out to those people


the breathtaking shadow of in your life who may be haunted by the memories of Christmas past, because the shadows cast by the memory of those we have lost can be particularly dark this time of year.

Golden man wanted for child sodomy released on lowered bond

A Golden man who was the subject of a search after allegedly sexually abusing a child appeared in court two weeks ago and was released on a lowered bond. The Barry County Sheriff's Department posted on their Facebook page on Novem-

ber 2 that they were seeking tips or information about the whereabouts of Octavio Richard Ochoa, 33, of Golden. Ochoa is reported to be from the Arrow Point/ Golden area.

Ochoa appeared in court with his attorney Mark Hammond, of Chesterfield, on

December 1, posting bond and avoiding any jail time while he awaits trial.

According to court documents by Judge Robert Foulke, Ochoa was released on a lowered bond of \$4,900, and that Ochoa now resides in St. Louis County. Ochoa posted 10 percent of that bond, \$490.

According to the affidavits of probable cause, Ochoa committed both statutory sodomy and child molestation on a girl under the age of 12. The charges state that Ochoa assaulted the girl in June of this year. Ochoa allegedly touched the girl under her bra and demanded she remove her pants so that he could touch her sexually. The victim told officers that she was afraid of Ochoa.

Ochoa is charged with sodomy in the first degree as an aggravated offender and child molestation in the second degree with a child under the age of 12.

Ochoa is to appear in court for a preliminary hearing on February 6, 2018.






65-65 with 4:50 to play.

Cassville Community Foundation awarded Rural Ozarks Health Initiative Grant

A collaborative project addressing access to mental health services in Cassville, Aurora and Mountain View was one of three proposals selected for the Rural Ozarks Health Initiative (ROHI), a three-year grant program to address priority health issues in communities or regions served by the CFO's rural affiliate foundations.

Cassville The Com-Foundation-led munity proposal will address the shortage of mental health professionals in rural communities through the use of virtual technology, providing web-based assessments by trained mental health specialists to expand access and improve the quality of behavioral health care in Barry, Lawrence and Shannon counties.

"This program will enable Mercy to expand its network of high-quality mental health providers into our remote areas, transforming the way health care is delivered," said Cassville Community Foundation Board President Mike McCracken, who spent 20 years serving on the Mercy Hospital Cassville board of directors. "Any time we can help improve the care and quality of life in our community we must do everything in our power to make this happen, and this

project is truly a gift to our area."

ROHI is a partnership between the CFO and Missouri Foundation for Health to provide \$750,000 in a multi-year grant opportunity to rural affiliates of the CFO. Three projects, including this one, will receive a \$50,000 grant per project for three years, totaling \$150,000 for each awardee. A one-to-one local match is required, one-half of which can include verifiable inkind resources.

Cash and in-kind support for the Cassville project comes from the Mercy Hospital Cassville, Mercy Hospital Aurora, Mercy Hospital Mountain View, Cassville Community Foundation, the Aurora Area Community Foundation, Mercy Health Foundation, and Clark Mental Health. Projects in Monett and Carthage also were selected to receive ROHI grants.

A volunteer grant committee selected the proposals based on collaboration among partners; commitment by the community or region to address the identified issue(s); demonstrated need; and ability to sustain the initiative beyond the three-year grant.

"Rural Missouri has consistently shown worse health outcomes and less accessibility to quality healthcare than our urban areas. We are grateful that the Missouri Foundation for Health is partnering with us to help address those disparities," said CFO President Brian Fogle.

A second phase of ROHI grants will make available \$100,000 annually for smaller-scale proposals in cities not covered by the larger ROHI programs. Applications for the first year of this program open on Jan. 8, 2018.

About Missouri Foundation for Health: Missouri Foundation for Health is a resource for the region, working with communities and nonprofits to generate and accelerate positive changes in health. As a catalyst for change, the Foundation improves the health of Missourians through partnership, experience, knowledge, and funding.

About the Community Foundation of the Ozarks: The CFO is a regional public charitable foundation that holds about 3,000 funds for donors, nonprofit partners and 49 affiliate foundations. Founded in 1973, the CFO has made grants and distributions of more \$300 million and currently holds assets of more than \$283 million as of Sept. 30, 2017.
