

Cassville Intermediate reopening flooded classrooms

It's been a long time coming, but barring any unforeseen circumstances, flooding repairs and mitigation to the Cassville Intermediate School building will be complete by the beginning of November and all displaced classrooms should be back in the old, but improved classrooms.

According to Cassville R-IV director of facilities and operations Dusty Reid, "We waxed the interior floors last week and assembled furniture and have started moving furniture into the classrooms today. Our goal is to get the teachers an opportunity next week to decorate their rooms."

"I'm not sure exactly when we will have the kids in. Toward the end of October, we expect students and teachers to be in their class-

rooms."

The damage at the intermediate originated from intense flooding in December 2015. However, according to Cassville R-IV Superintendent Richard Asbill, that was the third flooding or water damage incident to the building since it was built in 2008. He said, "It had only been used for two months before it flooded the first time. That was in March of 2008, then there were two more incidents that were inconvenient with some significant water introduced through the concrete slab and wall areas since then. But the most damaging was December 2015."

It was after that flood that the school opted to do an overhaul of the downstairs classrooms in the intermediate. Fifth grade classrooms, Title I rooms,

special education rooms and the nurse's office were all temporarily moved to a portion of the current middle school.

Once demolition began, another flood struck in July 2016. The most recent flood, which also brought water into the building was April 2017. However, the water in that incident was minimal. Reid said, "In April, we had a lot of rain and the basement filled up, but it never got up over the original slab. We had dug a lot of trenches and pipes around the original slab and we pumped it out quicker than it could come in."

The Cassville R-IV School Board approved \$1.56 million in repairs, however, a few weeks later, they amended that budget to allow for some project changes. Initially, the

district expected damage estimates to be over \$2 million. When the bids came in much lower, the district was

pleasantly surprised.

Dr. Asbill said, "Once we had an initial expectation of what this would cost, the

original bid came in lower.

That gave us the opportunity to add the two additional wet wells."

Holly changes things up at local Price Cutter, gets to know community

"Have you tried the ribs?" "No, really, have you?" It seems like any time Price Cutter has come into conversation in the last few months, that is what I've been asked. So I popped down to Price Cutter in Cassville to talk to the man behind the smoker, Dwayne Holly.

Holly is the new store

director at the Cassville location. He's been with the company for ten years and got his start in the meat department in Bartlesville, Okla. Prior to his career with Price Cutter, he worked for Cloud's Meats in Carthage for 14 years.

So, even after moving up to a management role, Holly kept going with his passion if on a smaller scale.

He smokes some of the best ribs in town and uses it as a way to get to know his customers.

"You can't just let them sit on the grill. You've gotta do it right. You have to have hickory, not just any kind of smoke," Holly shared.

Standing outside of the store at the smoker, tongs in hand, I caught up with Holly and talked with him

about his impressions of the Cassville store and what he has been working to change since he's been there.

He said, "I like being out here and talking with the customers because it's a different atmosphere. We talk about anything from what they're doing that day to issues with the store and what they'd like to see inside."

The benchmarks of Holly's policies are cleanliness, variety and stocked departments. He said, "Customers are noticing how clean the store is. Our new bakery manager has more variety and keeps it stocked. The produce manager has revamped produce with more selections and keeps it fuller. We've changed things up."

He continued, "Willis in the meat department is just the best. I don't have to worry about it even though I miss it."

He may not be in the meat department, but he definitely knows how to cook it. "At the grill, the customers see me on a personal level, and that's important,

Shell Knob man arrested after repeated harassmment incidents

A Shell Knob man was charged with aggravated stalking after violating an order of protection multiple times. Sean T. Hooten, 39, of Shell Knob, is currently being held in the Barry County Jail in lieu of a \$50,000 cash-only bond.

According to affidavits of probable cause, Hooten has been under the rule of an order of protection since June 21 of this year. Since then, Hooten has violated that order multiple times, resulting in multiple misdemeanor and felony charges leading up to the aggravated stalking charge.

According to the report, Hooten violated the order on July 7 by texting the victim and causing emotional distress. Again, the order was allegedly violated on July 9 when Hooten showed up at the victim's residence and got into an altercation with the victim's brother.

On August 25, Hooten was texting the victim again. Then, on September 24, Hooten broke into the victim's residence and took a nine year-old child.

While in the Barry County Jail, Hooten called the victim again from the jail phone on September 28.

In October, Hooten continued contacting the victim, calling her and messaging her on Facebook on October 2 and by Facebook messenger again on October 4.

When officers made contact with Hooten, he told officers that he had tried to contact her because he had been told she had been tortured and killed by Barry County judges, prosecutors and the sheriff's office.

During these events, the victim claimed she feared for her life and suffered sleep deprivation and anxiety.

In previous probable cause statements since June, officers detail the alleged incidents over the three and a half months since an order of protection was granted for the victim. In that span of time, Hooten was charged with two counts of harassment in the first degree, class E felonies, and two counts of violating an order of protection, misdemeanors, as well as attempted escape from confinement and assault in the third degree on a special victim, class E and class F felonies, respectively.

After being arrested for alleged harassment, Hooten attempted to escape the Barry County Jail by trying to gain control of a deputy's jail keys, striking him multiple times and causing contusions on his right arm and an abrasion on his neck. A second deputy was injured on his hand. Both had to seek medical treatment at Mercy Hospital in Cassville.

Seligman man charged with sodomy, molestation

A Seligman man was arrested and charged with molestation and two counts of sodomy for alleged sexual misconduct that spanned almost three years. Kenneth Ivan Short, 61, of Seligman, is charged with statutory sodomy in the first degree - deviate sexual intercourse with a person under the age of 14, child molestation in the second degree of a child less than 12 years old, and statutory sodomy in the second degree.

According to the affidavits of probable cause, the sexual abuse took place from October 2014 to August 2017. Short is accused of having multiple types of sexual contact with the victim starting when the child was under 12 years old. According to the report, Short forced sexual contact on the victim in exchange for giving the child

special privileges and activities.

Short is currently being held in the Barry County Jail in lieu of a \$75,000 cash-only bond.





Cassville traffic stop yields meth arrest

A Cassville man is charged with methamphetamine use after officer allegedly found a baggie in his wallet during a traffic stop. William M. Hendricks, 33, of Cassville, is charged with possession of a controlled substance and unlawful use of drug paraphernalia.

According to the affidavits of probable cause, the Barry County Sheriff’s Department initiated a traffic stop for failure to stop at a stop sign on State Highway 37. The 2014 GMC Sierra, driven by Hendricks, was also related to a trespassing case with the Cassville Police Department.

When Hendricks was giving the officer his license, the officer said he saw a clear baggie attached to his wallet, which Hendricks tried to conceal in his hand.

After being placed under arrest, Hendricks admitted to using a pipe in the vehicle to smoke methamphetamine daily. The baggie, which had a white crystal-like substance in it, field-tested positive for methamphetamine, as did the pipe.

Hendricks is currently being held in the Barry County Jail in lieu of a \$25,000 bond, cash, corp. surety or 10 percent.

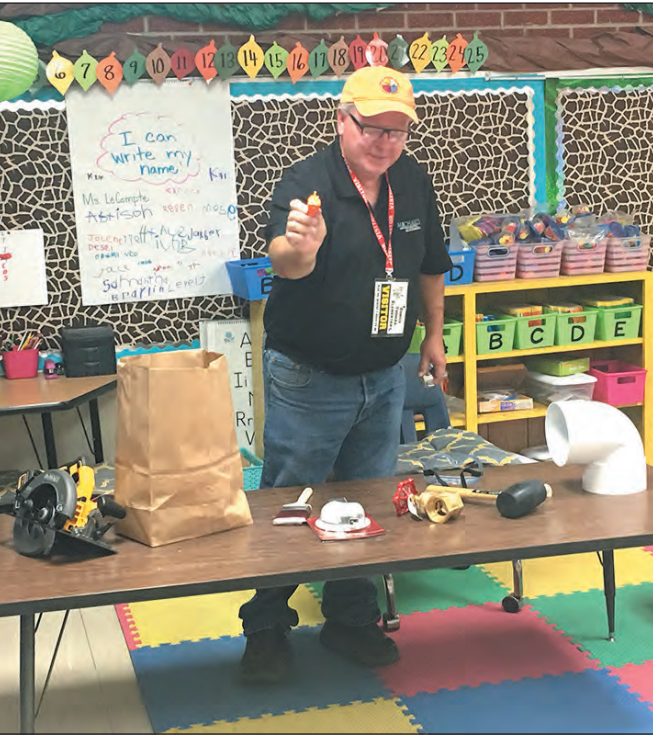

The school was already having a pier well drilled to prevent water from gaining access to the basement level of the school in the event of another heavy rain.

Asbill continued, "When we went into the repair portion of the project, the challenge was how to estimate exactly how much it would cost to repair and mitigate an existing building. When we came up with our budget estimates and what we were working toward, the original base bid of the project was lower than we anticipated. Which that is a good thing. Based on that, we evaluated two additional pier wells that would be considered strictly improvements to the project."

The base bid of the project, \$1.56 million, changed to \$1.991 million with the additional two pier wells.

The first phase of the mitigation project was to build an internal drain system in each of the flooded classrooms. Perforated 12-inch pipes were installed around the perimeter of the classrooms before the slabs were re-poured. Those pipes are fed to a central drain in the middle of the floor.

The second phase was directional boring. Three 15-inch pipes run under the building and take the water away down to drain at Flat Creek. The classroom French drain systems will be connected to the directional boring lines. Each room has a removable panel

to access the pipes draining any water that might breach.

Finally, the school had a six-foot diameter concrete perforated pipe that goes 40 feet into the ground outside of the Intermediate building with three pumps inside. The pump is designed to kick in when any groundwater seeps into the pipe. Since the well pipe is below the Intermediate class-

rooms, it will pump water out to the directional boring lines before it reaches the school. If a large influx of water reaches the well, there is an additional drain line to control overflow.

Overall, the project is running about \$2.9 million. However, the school's insurance is paying approximately \$1.5 million. Then there is a possibility that the school's portion will be less

once a final ruling is determined on the FEMA grant.

The initial FEMA grant was done incorrectly by FEMA representatives, so the school is appealing the denial to help cover flood damage. Dr. Asbill said they are requesting between \$650,000 and \$700,000 from FEMA, and the initial request did not accurately represent the scope of the disaster.

Letter to the Editor

What comes to your mind when you hear “serve and protect”? Law enforcement is constantly receiving a bad rap. Protesters slamming law enforcement, criminals with no regard for law, the list goes on. Even children are taught to disrespect the law by the parents who themselves break the law. But still every day our law enforcement officers get up, get dressed, put that badge and gun on and go out their door leaving their family, not knowing what the day/night will bring.

In 1992, my father Clinton R. Clark decided he wanted to go into law enforcement, it had been a dream he always wanted to do. Upon completion of the Police Academy, he became a reserve deputy for Barry County. He was so honored to work with the department and the county he had grown up in.

Sadly, in November of 1996, my father was faced with one of the most horrifying cases that would forever impact his life, and the lives of his brother officers. His brother officer, Christopher Castetter, a deputy of Barry County, had been shot while responding to a domestic dispute.

I think we all remember that case. I remember all the chaos and all the crying and the pain. That was the first time I had ever seen my father cry. Our whole county, town and law enforcement family was devastated.

Little did I know, my father, alongside Chief McCracken, was the arresting officer that took down the man who took the life of their friend and comrade.

Later, my father became a key witness in that case: Missouri vs. Clayton, and Clayton was sentenced to death for the crime. Then, dad began his career with the City of Wheaton. Working days at Exeter School as the director of maintenance and security, then off to Wheaton to work nights there. When my father started at Wheaton, he was

told by people it was a rough and rowdy town, and that no law enforcement would ever be able to tame the town. But my father had a mission to protect and serve the great people of that town.

As Chief of Police little did he know what he would be getting into. Multiple drug busts, arrests, traffic tickets, etc., but with consistent presence soon showed the town of Wheaton that he was there to stay. Throughout the years, my father grew to love his career and spent many selfless nights away from family and special family events to dedicate himself to the job he loved so much.

When he retired from the Exeter School and went full time for the City of Wheaton, another case impacted not only his life but the lives of Stella, Missouri, residents. Missouri vs. Collings drew media, FBI, and numerous law enforcement to the City of Wheaton. This case hit hard, but my father along with all the departments involved never gave up, and with the compassion and dedication my father had, it soon came to an end.

Many years later, and a lot of trips to Rolla, Missouri, grueling testimony as key witness again, my father helped to put another criminal behind bars and on death row. It was the second time I ever saw my father cry and suffer for such a innocent young life taken. I thought then my father is more our hero than ever.

Throughout the rest of his career at Wheaton, there has still been the occasional drug bust, disputes, you know, the usual things law enforcement officers are made to deal with every day. But every day, no matter the weather, no matter how he was feeling, he always was there. Protect and Serve was his job and he made sure that was exactly what he did. He always wore his badge proudly.

My father had a stroke in

August of this year. Due to the stroke, he was forced to retire from a career that he loved so much. When you think retirement, you think monthly pension, golf courses, retreats and the occasional out of town trip. But that isn't the case here. For my father, there is no retirement pension, no nothing. Just stress and worry. His career was quickly ended. No one can ever prepare for a major health change. If the stroke would have never happened, my father would still be doing the job he loves.

Now, we see him suffer yet again, this time at the hands of the city government. I would like to know how our city leaders sleep at night knowing there is no pension for our police officers.

We all need to become aware of this current situation. Cities who have police departments should offer retirement packages to their officers. I know that on a couple of occasions, the retirement package offers had been presented to the city government, and each time shot down.

Why wouldn't they want to give back to the officers who have worked many years protecting them? Why turn them away as if they never mattered in the first place?

In the previous months, I have contacted the Governor, our senator Clare McCaskill, to try and get answers. And it all comes back to “It's a city government matter, State doesn't get involved”.

I am truly heartbroken. My trust and respect for our local officials is shattered. I would like to make all people aware of this situation, not just the police departments run by city government. That way, no one else will be devastated like my father has been. Was his 26 years of service just a waste?



The Dawgs had wasted two golden scoring opportunities as the chance to take a commanding early lead fizzled against the determined Cassville defense. Aurora's size advantage with its mammoth offensive line seemed less significant after that impressive opening drive, and the Wildcats responded in critical situations with game-changing stops.

The Cassville offense finally came to life with Logan Carlin and Tolbert finding running room on counter plays through the heart of the Aurora line. Then on 3rd-and-2 from the Cassville 46-yard line, Haney appeared stopped for no gain. But the Wildcat quarterback broke free and escaped down the east sideline for a 27-yard gain.

Carlin crashed the line on three consecutive plays to gain a first down in the red zone. On 3rd-and-1, Tolbert blasted into the end zone from six yards out with just 39 seconds left on the clock. The PAT failed, but the Wildcats were on the board, trailing 7-6 at halftime.

The Dawgs tried a little trickery to open the second half. Peyton Weathermon tried a short squib kick but the Wildcats were ready, covering at their own 48-yard line.

Cassville drove the short field in just nine plays. Haney froze the defense with a convincing fake to Tolbert, then scored off left tackle on a 4-yard sprint. On the 2-point conversion attempt, Haney followed the extra blockers in the wishbone into the end zone to give the Wildcats a 14-7 lead at the 7:51 mark of the third quarter.

Aurora went exclusively to the pass on the next possession. Lee led the Dawgs down the field, hitting Kaden Clark with a seam route for a 20-yard gain to the Cassville 15-yard line. But Johnny Medina killed the drive, making an acrobatic interception.

Three running plays gave Cassville a new set of downs and set up the biggest offensive play of the game.

"First down Wildcats at their own 17-yard line, Haney hands to Tolbert up the middle. He breaks through the line, cuts outside and the safety can't get him down! Tolbert is running free down the Cassville sideline! 83 yard! TOUCHDOWN CASSVILLE!"

Drake Reese drilled the extra point and the Wildcats took a 20-7 lead with 2:59 left in the third quarter.

But Aurora wasn't done. Lee led his offense down the field again. His 23-yard scramble to the Cassville 28-yard line set up a 33-yard scoring pass to Clark at the pylon. The 2-point conversion try failed though, and Cassville still led, 20-13.

Another squib kickoff led to another short field opportunity for the Wildcats. Tolbert was feeling it after his long touchdown run and he shed tacklers on five straight carries, bouncing off right tackle for a 2-yard scoring run early in the final quarter. Reese's pop-up PAT was short on style but good enough for a point and the Wildcats extended their lead to 27-13.

The Cassville defense finally wore out the Aurora line, sacking Lee twice on the following crucial possession. Trailing by two touchdowns, the Dawgs were forced to punt on 4th-and-31 after Wyatt Goade planted Lee in the backfield. Then on the next Aurora possession, Carlin ripped through the line and tripped Lee for a 5-yard loss on 4th-and-10. The Wildcats took over at the Aurora 36-yard line with just three minutes left to play.

Tolbert finished off his monster offensive night with a 27-yard scoring burst and Cassville's lead grew to 34-13 with 1:55 remaining.

Aurora drove the field with a desperate stat-builder drive to the Cassville red zone, but the Wildcats protected the end zone. Lee threw incomplete for Lauffer in the end zone on the game's final play and the Wildcat Nation celebrated a 34-13 victory.

The Wildcats improved to 5-3 on the season, while Aurora slipped to 4-4. The Wildcats finish the regular season on Friday night at Mt. Vernon. Kickoff is set for 7 PM.

Missouri Hunter Education now available all online

Missouri Department of Conservation (MDC) offers an all-online hunter-education course for Missouri residents 16 years or older to provide a more flexible and convenient option to become hunter-education certified. The all-online course includes videos and animation to teach hunter safety, firearm safety, ethics, regulations, and wildlife management.

“The way adults are learning is ever changing. More individuals are utilizing mobile applications and online tools to educate themselves,” MDC Hunter Education Coordinator Kyle Lairmore said. “This option provides individuals the flexibility to learn at their own pace and at a time they choose.”

Students will receive a temporary hunter-education certificate once they complete and pass the 60-question final exam with an 80 percent or higher. Individuals 15 years or younger are still required to complete the blended hunter education course requiring both a knowledge portion and in-person skills session to receive certification.

Missouri’s hunter education course is required for any hunter born on or after Jan. 1, 1967. Hunters who plan to hunt during a Missouri firearms season or are acting as an adult mentor must first complete an approved hunter-education certification program and provide proof of completion unless:

- 15 years of age or younger and will be hunting with a properly permitted adult mentor 18 or older.
- Born before Jan. 1, 1967.
- Disability exemption from MDC’s Protection Division.
- 16 years of age or older and have purchased an apprentice hunter authorization and will be hunting with a property permitted adult mentor 18 or older.
- Landowner or lessee hunting on self-owned land or land of residence.
