Opening Day expected to reel in over a thousand anglers

With Opening Day of trout season just around the corner, this Friday is sure to reel in a large number of anglers coming from near and far to catch their limit at Roaring River State Park. Although the weather looks to be a little chilly, no snow or ice should deter those headed for a weekend of fishing.

This year, Opening Day, March 1, falls on a Friday. Fridays usually mean a large number of anglers will fish the frigid waters at Roaring River, hoping to take home a stringer full of prize-winning rainbow trout. This Friday’s temperatures are supposed to be chilly when the opening gun is shot with time-of-press predictions around 30 degrees, but that never stops the dedicated fishermen of Roaring River’s waters from casting their lines. The high for Friday is around 49 degrees as the day progresses.

Hatchery manager Paul Spurgeon said hatchery staff anticipate between 1,600 and 1,800 anglers to turn out on Opening Day. “Fridays are usually a little busier, but it always depend on the weather,” he said. “We start stocking Wednesday with around 6,000 trout.”

There will also be 100 lunkers, weighing at least three pounds each, released into the water. All of the fish for Roaring River will be brought in from Mauntauk State Park’s hatchery. Roaring River’s hatchery has been out of commission since the fall when much-needed repairs and improvements began.

Since the hatchery and raceways were closed, no fish could be raised on site. Now that some of the concrete work on the raceways is complete, staff will be able to care for some fish on site to stock with. “The lower six raceways, we will be using our recirculation pump to run those. We will bring in truck loads of fish and hold them in there.”

In preparation, staff has been able to do a lot of maintenance around the hatchery prior to the catch-and-keep season starting. Spurgeon said having the hatchery closed opened up staff to complete projects that cannot be tackled when they are operational. “They are patching concrete and some things like that. They’ve gotten a tremendous amount of work done this season. We’re going to be bringing fish in and stocking them out from the raceways and operating like that until June at the very earliest. If we get a flood or something, it might take longer. They are making quite a bit of progress right now.”

Initially, Missouri Department of Conservation planned for the hatchery repairs at Roaring River to be complete in spring, but various construction delays prevented that.

Other than the fish coming from Montauk, it will be Opening Day business as usual on Friday. This year, catch-and-keep trout season will begin at 6:30 a.m. after the opening gun is fire. The honor this year will go to long-time local news columnist Bob Mitchell.

Lady Bulldogs claim District Champ title

“IN THIS MOMENT”

It was a moment years in the making. This is why players shoot literally thousands of free throws in practice over a career.

The Wheaton Lady Bulldogs fought back from an 11-point second quarter deficit, then nailed 13 of 15 fourth quarter free throws to claim a 60-54 victory over the top seeded College Heights Lady Cougars on Saturday night in the Cardinal Dome at Webb City. This championship was won at the line, where the Wheaton girls calmly hit 20 of 23 tosses for the game. College Heights hit only 9 of 18 attempts, wasting a 27-point performance by Emily Colin.

It was the first district basketball title for the Lady Bulldogs since 1994, coming after Wheaton lost in championship games the last two years. Wheaton lost to Walnut Grove in Class 1 District 5 finals both times: 71-47 in 2018 and 64-29 in 2017.

Wheaton met the stat requirement, scoring 60 against the powerful College Heights girls. Jessica Lombard’s girls are now a perfect 13-0 this season when they score 60 or more points.

What. A. Game.

The Class 2 District 12 girls basketball final pitted Wheaton against College Heights. Purdy’s post-season party plans popped

when Wheaton poured a 59-40 semifinal win on the Lady Eagles’ parade.

Saturday’s title tilt saw the 20-7 Lady Bulldogs taking on the 19-7 Lady Cougars in a rematch of their January 25 contest, won by College Heights, 56-44. That game was representative of a crazy year in the Ozark 7. It was a year where Wheaton lost to both College Heights and McAuley, then beat Verona, a winner over both Joplin private schools.

College Heights is all about the inside-outside tandem of Colin and Grace Bishop. The dynamic duo poured in 41 of the 54 points for the Lady Cougars. While Wheaton’s Hallie Mitchell was deadly from

both the free throw and three point lines, she had a lot more support from the balanced Lady Bulldogs attack.

The first quarter saw a toe to toe battle, with Wheaton taking a 10-9 lead when Rachel Lacey followed a miss at the 2:05 mark. But College Heights, led by Colin’s 9 first quarter points, scored the next three baskets. Then, Mitchell drove and willed in a hook from the right side of the lane as the clock expired to cut the lead to 15-12.

Colin was a beast on the boards as well as in the scoring column. The Lady Cougars owned the boards at both ends, and thwarted the Wheaton inside game with intimidating blocks.

A 12-2 run gave College Heights a 21-12 lead, a lead that grew to 27-16 when Kaynahn Burk converted a strip steal into a snowbird layup with 3:40 left in the half.

Mitchell finally connected from three land, and she and Rachel Lacey sank free throws to cut the lead to 29-23. Monica Hinojosa added to the scorebook with the last bucket of the half, pulling Wheaton closer at 29-25.

Zoie Simpson scored on back to back possessions to complete a 13-2 Wheaton run and tie the score at 29-29. Colin answered with a pair of treys in the next two minutes to guide the Lady Cougars back in front, 37-32.

Seligman PD applying for grant for new software

Seligman Police Chief Matt Phillips is working on ways to give his department the ability to more effectively and independently patrol the city. To move the department forward, Phillips is applying for a grant that will allow the city to purchase new software to aid in record management and reporting crimes.

Phillips’ grant request was approved by Seligman City Council to apply for hopes of getting assistance in purchasing the new software from the Edward Byrne Memorial Justice Assistance Program. The program offers financial assistance to qualifying local law enforcement branches in the purchase of new equipment.

The new software, the National Incident Based Reporting System (NIBRS), will allow Seligman P.D. to better network with other software used by local prosecutors and court

clerks to cut down on the time involved in field paperwork.

“It’s going to take a lot of time out of the process,” said Phillips. “We can just scan the back of driver’s licenses, and the person’s information will just pull up for us.”

“It’ll do our property and evidence, any reports that we write, our summons and anything that we need to submit to the state,” Phillips continued. “It’ll automatically upload those things where they need to go which will cut down on the time we spend on paperwork.”

According to Phillips, the grant, if accepted, will make \$17,949 in funds available to the Seligman Police Department for the software. Of that money, \$9,448 will pay for a one-time use fee for the software, and the remaining \$8,501 would pay for the annual usage fee.

If the department's initial grant request is approved, an annual renewal grant request will need to be filed in order to pay for the yearly \$8,501 usage fee. With the help of the grant, the NIBRS software won't come at any cost to Seligman taxpayers.

Phillips says that the current system used by most law enforcement for field reporting, Omnigo, has a variety of flaws that make filing paperwork in the field time consuming and arduous.

The current system has little to no networking with other reporting systems, such as the Show-Me Court system used by prosecutors and other Missouri legal officials. This means in order to file paperwork and get it in to the hands of prosecutors and other departments, Seligman Police must file their paperwork and then manually transfer it to those systems.

Phillips also says that Omnigo system has flaws regarding its scanning and records that the new NIBRS system would do away with entirely.

"[Omnigo's] scanning on licenses takes a little more time," said Phillips. "It's not actually scanning the barcode, it's scanning the whole license. In the amount of time it takes to scan it, you could enter it all in by hand."

Under the new NIBRS system, Seligman officers would only need to scan the barcode located on the back of a driver's license to pull up the records of a given individual.

Phillips's grant application request was approved by Seligman City Council on Monday, February 11. The grant was then submitted to the Edward Byrne Memorial Justice Assistance Program and currently awaits approval.

Cassville, Monett Schools partnership to help special needs students

Cassville Schools is hard at work this year making moves to not only improve their community relations, but also to ensure a brighter, more successful future for all students that pass through their doors. Part of ensuring the directive is making certain those within the school requiring special attention have adequate facilities to address their educational needs.

Recently, Cassville has been forging a partnership with a facility in neighboring Monett to help address the needs of students with Individualized Education Plans (IEPs) and special education needs.

This behavioral center, currently undergoing renovations and expected to be open in August 2019, will be located near the Monett Elementary School and will feature facilities for both students with IEPs and students on the Autism spectrum.

"What Monett is doing with some partner school districts, Cassville being one of those partners, is to establish a behavior center in Monett that we will be able to access," said Dr. Richard Asbill, superintendent of Cassville Schools. "We could access it with our students, and, even if we didn't have students that would be accessing services, we would be able to have teachers access the training component to learn how to work with students with behavior needs and special needs."

Asbill explained that the partnership will go to help better serve students who have difficulties operating within the standard educational guidelines.

"The students that we're talking about are special needs students," said Asbill. "They are students that would potentially have individualized education plans and their needs will have potentially already been identified, either through us or one of their developmental needs providers."

Asbill went on to elaborate that the school would not only be a resource for students but also serve a source of knowledge and off-site job training for teachers to help them better understand and handle special needs students in the classroom.

"It would be a center that would not only be providing individualized instruction for students but also, teachers who can go there for the support system and hands-on training."

This partnership will help Cassville handle the burden of transportation for students, with the hope that taking them from their usual environment and allowing them to learn in a more controlled space geared toward their specific educational needs will help them better learn how to work within the bounds of a traditional classroom.

"For a student who has an IEP or may benefit from these types of services, we would transport them to Monett where they may participate in that program for a part day, a full day, two weeks, or even a full semester. It just depends on each individual student and their needs."

Asbill went on to express optimism toward the partnership, explaining that this new system would go a long way towards helping students who have difficulties learning in a traditional setting adjust and be successful.

"This would help us bridge some of the gaps between special education and regular education," said Asbill. "When we're looking at the behavioral center support system, we're going to be able to look at opportunities for students and if a student can go up and receive support and come back and be successful in a regular education environment, that's great. If we can provide a student with half-day or even full-day services and they can be successful, that's great, too. It's all about the individual student and their behavioral needs."

Construction and renovations for the Monett facility are expected to be complete in August, thus opening the possibility of the facility being able to serve students in various local school districts at the beginning of the 2019-2020 school year.



I hope to see many people come together and ask why the county never kept the bridge up every three to four years when it was mandatory service every two years.

It is because of the county not keeping up the maintenance that it has become dilapidated to its ruined self. To me that says neglect.

Wildcats fall to CJ in District opener

Wildcat Takedown Club sends 21 wrestlers to Seneca

On Monday night at Webb City, both Class four District 12 quarterfinal games saw upsets by teams that had won only 4 games during the regular season. First, McDonald County erased a 10-point halftime deficit and stormed to a 58-51 win over Monett. Then, Carl Junction rode a 29-point performance by Trenton Smith to a 65-54 victory over Cassville.

The upstart teams had one common denominator: a skilled, classic center. Cooper Reece led Mac County with 28 points while dominating the paint. Smith, the all time leading scorer in Carl Junction history, terrorized Cassville, flushing the rim three times. Even though his most impressive dunk was waved off by a traveling call, Smith dazzled with a highlight reel game when the Bulldogs needed it the most.

Ethan Hoppes led Cassville with 17. DJ White and Carson Roller both reached double figures, scoring 16 and 13, respectively.

It wasn't enough.

Cassville played a tough first quarter, taking a 14-13 lead when White hit his second trey at the 2:30 mark. That was the fourth triple of the quarter for Cassville. but Smith finished the period with a pair of free throws and an inside bucket to give CJ a 17-14 lead at the first break.

Then, under the impressive domed ceiling of the Webb City basketball palace, the proverbial roof fell in on Cassville.

In the second quarter, the Bulldogs switched from their casual 2-3 zone and extended pressure on the perimeter. The Wildcats could neither score for outside nor solve Smith in the lane. Those scoops, floaters, and putbacks that propelled Cassville to a 14-11 regular season record disappeared with the 6-6 center guarding the paint.

Carl Junction took control with a 15-3 run to take a 32-19 halftime lead.

The Cassville offense came alive in the third, but Carl Junction extended the lead with a 15-13 quarter for a 47-32 advantage at the final break.

Skip Brock owned the Big 8 when he was at Mt. Vernon. Now at Carl Junction, Brock continues to be a thorn in the side of his former conference opponents.

The fourth quarter was classic Brock, with the Bulldogs calmly running clock but always looking to score. The lead reached 20 points with six minutes remaining as the scoreboard read 54-34.

While Cassville would score late against the CJ subs, the game was never in doubt and was not as close as the 65-54 final would suggest.

The Wildcats finished

the season at 14-12. Carl Junction improved to 5-20 and advanced to a Wednesday semifinal game against Neosho. McDonald County moved into a semifinal march against host Webb City.

The loss to Carl Junction extended Cassville's losing streak in district openers to eight years. That includes 2012 when the Cats were seeded second and received a first round bye. The Wildcats have not won a district game since 2011 when they defeated McDonald County and Aurora to claim the Class 4 District 12 championship.

Lady Wildcats lose to Monett

The Cassville Lady Wildcats lost their Saturday Class 4 District 12 quarterfinal game to Monett, 56-38. The Lady Cubs squeezed Cassville in every quarter, building on an early lead. After trailing 26-15 at halftime, Cassville put up 15 points in the third quarter. But Monett scored 21 in that frame for a 47-30 lead and controlled the clock in the final eight minutes to take the win.

Kaesha George led Monett with a game-high 22 points. Madry McCrackin was the only Cassville player in double figures, scoring 16.

The Lady Wildcats finished their season with a 6-18 record.

Cassville's Artherton speaks on historic State wrestling medal

Cassville wrestler Keaton Artherton has had a spectacular senior year. After edging his way into the fourth place spot at District Finals in Monett on February 9, Artherton finished his senior wrestling season off with a tremendous comeback from an early round loss that won him fourth place overall at state finals in Columbia on February 16.

Artherton began the tournament with a heart-breaking loss in the final ten seconds of his first round.

"I was pretty down, it wasn't looking good for me," said Artherton. "I knew it was my senior year, and I needed to fight my hardest."

Cassville wrestling coach Nathan Fortner said he knew Keaton was walking in to hard fought struggle based on their tri-

als getting to state. Through the nerves of competition, Fortner said he came to admire Artherton's tenacity.

"This is the toughest district I've ever seen. We're not in an easy district to qualify for state in," said Fortner. "I used to coach at Seneca. I've been around state before, but I've never coached someone like Keaton. It's hard to lose your first match and come back to the medals."

Artherton took this motivation and fought hard later on that evening, taking home a 2-1 win over his opponent in the second round. This earned Keaton a spot in the semi-finals later that evening.

"It feels good that I could that I could battle back after the first loss," said Artherton.

Hot off his previous victory and with a renewed

fighting spirit, Artherton fought hard and reversed his luck from his first round, pinning his opponent in the final seconds of the match. This not only won Keaton the match but also guaranteed him a spot in the finals the next day and, more importantly, a place on the podium.

During the competition, coach Fortner, himself a former wrestler, said that he felt nervous for his wrestler as he would have to rely on his training to get him through.

"I think I'm more nervous as a coach than I was as a wrestler," said Fortner. "It's out of my control what they're doing out there."

Artherton, however, said he had no such reaction and what he needed to do was clear to him.

"I went to state for the first time during my junior year so, I got all those

nerves out of the way then," said Artherton. "This was my senior year and I knew that I had to do what I had to do to win."

Artherton kept his momentum up in his first round of the finals, taking down yet another opponent with a pin and winning himself the opportunity to wrestle for third in the next round.

Unfortunately for Artherton, he went on to lose his final round of the day, landing him in fourth place.

"He went through some really tough kids to get to that podium," said Fortner. "I know it took a lot of heart and Grit. He does everything the right way. He manages his weight and never misses practice. He deserves and earned this."

Artherton and coach Fortner don't despair, though. In the three years

that wrestling has been a varsity sport at Cassville, Artherton is the first wrestler to get this far at a state competition.

"I wanted to win it, but, it was a hard fought match," said Artherton.

"Both matches he lost were heartbreakers," said Fortner "Both matches that he lost were in the last few seconds. He was winning to the very end of both of them and then just got tripped up. He could have been on the very top of the podium."

Keaton and the team trained hard for the event, running through drills and live practices on a daily basis.

"I practiced every day. Morning, noon and night. I was pushing myself," said Artherton.

"Any time [the team] wants to come in and do an extra workout, we'll come

in in the morning and drill," said Fortner. "We'll spend a little extra time working on the little things."

Artherton says that while he was initially glum he didn't place higher on the podium, his family has helped keep him grounded and encouraged him to be proud of his accomplishments.

"My family supports me," said Artherton. "They knew I was down that I didn't get the top of the podium. But they keep reminding me that this was the best I could do, especially after that first loss."

Keaton Artherton is hanging up his pads and tights, ending his wrestling career on a high note. He is expected to graduate this spring and plans on spending the next two years doing mission work for his church, the Church of Latter Day Saints of Cassville.

Habitat soon to resume progress on home construction

The seventh family in need in southern Barry County will soon have a clean, safe home thanks to efforts of the local Habitat for Humanity chapter that oversees projects in southern Barry County.

The local chapter broke ground on their newest construction, the property on the corner of Oak Hill Drive and 8th Street in Cassville, last November. The structure currently has foundation poured and the wooden framework for the floors and porch constructed.

David Hermann, president
of the Habitat for Humanity of

South Barry County, is optimistic about the project.

"I am absolutely touched by these individuals," said Hermann. "When they get in there the first time after we're finished and see this home that is not only their's, but they helped build, they get emotional."

The project is currently estimated to take approximately nine months to complete, with Hermann estimating that their time line for completion shouldn't run over 12 months in total. According to lead builder, Denny Ball, construction on the property has been

on hold until the weather is more permissible.

This is the Habitat for Humanity of South Barry County's seventh housing project since opening their Cassville branch in 2006.

Once the structure is completed, it will total roughly 1,088 square feet, with three bedrooms, one bathroom and two porches. The porch on the back of the property will have a ramp in order to make the structure more accessible to those with mobility issues.

In order to qualify for Habitat housing, applicants are required to have a source

of income, either a current residence in Barry County or a desire to move to the area, and they must fill out an application showing need, which can be found at the Cassville OACAC office.

"We're different than a charity," said Hermann. "Our houses go to the recipients at cost, and the recipients have to put in the work, too."

All Habitat for Humanity home recipients are tasked with 300 hours of what the charity calls sweat equity. This is a system by which the recipient of the home is tasked with some part of the work going in to the home.

Currently, recipients have a variety of ways of putting in those hours. They can work on their future Habitat home or they can volunteer to work at the Habitat for Humanity ReStore.

The ReStore in Cassville sells tools, furniture and other donated materials at a fair price. There are also home items and a variety of new materials, such as paint.

"There's always work that needs done around the ReStore," said Hermann. "If anyone ever tells you that there isn't, just call me. I'll show you where the work is."

Another way recipients can volunteer is by offering to help on the construction site. Those qualified to run power equipment or possess a working knowledge of construc-

tion can volunteer to help with the building of the structure. Those without prior construction knowledge can still volunteer to work on site, either helping with interior elements of the home or by doing minor tasks on the construction site.

The ReStore is open from 9 a.m. to 5 p.m. Monday through Friday and 9 a.m. to 12 p.m. on Saturdays. According to Hermann, the ReStore is always open to volunteers regardless of if they are involved with Habitat for Humanity. Volunteer hours are open and flexible.

"A whole day, half a day, one hour, even," said Hermann. "Anyone can volunteer for as long as they want or need to."

The ReStore's profits go to help pay for homes for people in need.

People can also help on new home construction. "We always need more hands on the construction site," said Hermann. "Even if it's just grabbing a hammer for someone or holding a ladder, whatever someone can do."

Hunters harvest 12,080 deer in alternative methods portion

Preliminary data from the Missouri Department of Conservation (MDC) shows that deer hunters in Missouri harvested 12,080 deer during the alternative-methods portion of the fall firearms deer season, which ran Dec. 22 - Jan. 1. Of the total harvest, 3,081 were antlered bucks, 1,586 button bucks, and 7,413 does. Top harvest counties were Callaway with 304 deer harvested, Osage with 278, and Franklin with 263.

Barry County's totals were 86 total deer harvested with 20 of those antlered bucks, 12 of those button bucks and 54 does.

Let's Get Growing Garden Workshop beginning Mar. 9






