

Purdy fourth graders make a big impact for tornado-victims

On Tuesday evening, April 4, tornado sirens went off across southwest Missouri, including in Barry County. Many students at Purdy Elementary heard the sirens, hunkered down in basements and shelters with their families. Thankfully, when those students awoke the next day, they went to their classrooms as usual, but for some McDonald County students, they weren't so lucky.

Around 6:30 p.m. on Tuesday, an EF-2 tornado tore through McDonald County, destroying Goodman Elementary. The roof was torn off the building, supplies scattered everywhere. The school's teachers and administrators, as well as students, were left with little to salvage, and most of the county didn't even have power until later in the week.

The devastation was intense, and for Purdy students, it opened up a discussion about what that would have been like if it had happened to them. That idea

bloomed into a huge relief effort that filled dozens of boxes with supplies for the students and teachers who lost nearly everything in their desks and classrooms to the storm.

One of Purdy's three fourth grade teachers, Melissa Horn, showed her students some of the drone footage of the destruction to the school. She said, "This all started the day after the storm, and the kids had a lot of questions. They were worried as we watched the drone footage on the SmartBoard. They all seemed to have the thought that, 'You know what? That could be us.'"

It was that discussion that led students to want to help. Horn spent her second year of teaching at Goodman Elementary, and a Cassville alumna, Crystal (Boles) Wilson, currently teaches at Goodman, as well as Bekah (Crawford) Griffith. Horn made the arrangements and gave her students a plastic tote to fill with supplies to send to their fellow fourth graders a

Five charges for man arrested at swimming area

A Cassville man racked up five charges after being arrested near a well known swimming area last week. According to the affidavits of probable cause by the Barry County Sheriff's Department, Chance Lane Henson, 21, had a gun and drugs on him when they questioned him.

On Monday, April 10, Deputy Dave Ruark with the Barry County Sheriff's Department went to a low water bridge on State Highway Y and Farm Road 2140. Once there, Ruark questioned Henson, who allegedly had a .57 caliber Colt Lawman Mk III in his possession. Henson is a convicted felon and unable to possess a

firearm.

Henson was also in possession of a baggie of rock methamphetamine, a glass pipe for methamphetamine, a methadone pill and alprazolam (generic Xanax) pills, according to the report.

Henson is currently being held in the Barry County Jail in lieu of a \$45,000 bond.

Cassville man charged after screwdriver threat

A Cassville man is in custody and charged with unlawful use of a weapon after allegedly threatening police officers with a knife and screwdriver. Michael Ernest Irving, 42, was being held in the Barry County Jail until he posted a \$15,000 bond.

According to the affidavit of probable cause by Cassville Police Department officer Colt Beck, he responded to a report of a violation of an order of protection on Saturday, April 15, around 11:20 a.m. at an apartment

on 10th Street. Once there, residents claimed Irving was in the bedroom.

Irving was locked in the bedroom yelling that if officers came in, he would stab himself with a knife, according to the report. Irving then allegedly held a screwdriver in a threatening manner toward Beck and himself before calming down and being taken into police custody.

The petitioner of the order of protection was in the basement of the residence during the incident.

The grass-roots movement has drawn additional marchers and more attention over the years, including annual participation from Bikers Against Child Abuse (BACA). This year, SEK BACA will sell hot dogs on site and answer questions about their organization.

Million March Against Child Abuse coincides with April's designation as Child Abuse Awareness Month. The free event will have signs for participants who don't make their own. Drinking water is provided and everyone is asked to wear the recognized colors for the march of blue or white. Even those unable to walk are encouraged to attend and bring

a chair to hold a sign.

Over the years, MMACA has grown to over 100 cities. The walks are sponsored by Children Without a Voice (CWAV), out of Atlanta, Georgia. Director Lin Seaborn stated, "Children are the world's greatest natural resource and should be protected above all else on earth. Nine drug charges for
Exeter woman after traffic stop

A Cassville traffic stop results in nine different drug charges for an Exeter woman over the weekend. According to the affidavit of probable cause, Heather Dawn Sartin, 29, of Exeter, was in a vehicle stopped in the Pizza Hut parking lot when she was found to have methamphetamine and paraphernalia. When Sartin was booked into the jail, she allegedly had over five grams of methamphetamine and over four grams of marijuana on her person.


Cassville Police Department officer Colt Beck stopped a vehicle around 11:05 a.m. on Sunday, April 16. During a consensual search of the vehicle, Beck found a metal

lic spoon with methamphetamine remnants on it, as well as a digital scale and methamphetamine. When Sartin was asked to empty her pockets, Beck reported that she acted nervous, but did not produce anything during her self-search.

When Sartin was booked into the Barry County Jail, female jail staff searched her, finding a green glass methamphetamine pipe, oxycodone pills, diazepam, 4.8 grams of marijuana, and 5.2 grams of methamphetamine.

Sartin was charged with three counts of delivery of a controlled substance, three counts of possession of a controlled substance, delivery or possession of a controlled sub-

stance at a jail, unlawful possession of drug paraphernalia and possession of marijuana. Sartin is currently being held in the Barry County jail in lieu of a \$50,000 bond.



Did you know?

One of the ways homeowners can keep their lawns looking lush and green is to aerate the turf when the need arises. Aerators perforate the soil with small holes. These holes allow air, nutrients and water to penetrate all the way to the roots, helping them grow deep and strong. Deep, strong roots are essential to healthy, lush lawns. While aeration can help many lawns, not every lawn will necessarily need to be aerated. Lawns that get heavy use, such as those that are often played on by children or pets, will likely benefit from periodic aeration. Feeling the lawn also can help homeowners determine if it needs to be aerated. Lawns that dry out quickly or feel spongy may be overcome with thatch, which can prevent lawns from getting the air, water and nutrients they need to thrive. Lawn care professionals recommend aerating lawns that contain thatch that is more than one-half inch. Thatch also can foster grub infestations, providing another benefit to removing it and aerating a lawn. When to aerate depends on the type of grass. Homeowners should consult with a lawn-care professional about the best time to aerate their particular lawns, but it's generally recommended that cool-season grasses be aerated in early spring or fall, while it's best to aerate warm season grasses in late spring.

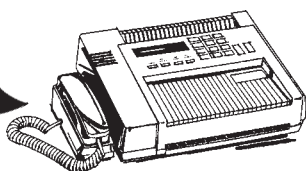

Purdy Schools launches new bus fleet

In the words of Purdy R-2 School District Superintendent Steven Chancellor, Friday, April 7, was, "...a great day to be an Eagle!" Joe Crabtree, Regional Sales Manager for Midwest Transit Equipment, of Nixa, oversaw the delivery of five of six buses to District Transportation Coordinator Julie Keeler. The district purchased two buses and leased four in order to establish what Chancellor described as a "routine replacement cycle."

Each of the new buses

holds 72 passengers, which increases the number of possible riders on several of the district's routes. They are also driver- and maintenance-friendly, each with a standardized engine, transmission and chassis. Chancellor noted, "The process of maintaining our buses will be far more efficient now that every bus is the same."

The district's top priority in the acquisition of the buses was increased student safety. "The buses are designed to run qui-

eter on the roads, which means a quieter, safer interior. These buses are also designed specifically for the types of roads our drivers encounter each day. They have newer, better suspension and transmission, which provides an added element of safety.

One of our new buses is perfectly designed for the hilly terrain common in the McDowell community."

As students left the building at the close of day, they boarded the new buses added to the Purdy fleet. The excitement was palpable as kids checked

out their new rides and greeted their drivers with big eyes, huge grins and gasps of delight. One young rider exclaimed, "The new buses are awesome. Thank you to whoever got them for us."

Transportation Director and Bus Driver Julie Kee-

ler beamed as her riders boarded for the trip home. "It's an exciting day, not only for the drivers and the school district, but also for the kids. It's exciting to see them excited about their new buses."

Barry County courts send 4 to prison in the month of March

• **Roland Seth Adams**, plea to unlawful use of a of Aurora, made an Alford weapon. Adams received

a suspended imposition of sentencing and three years supervised probation.

In November 2014, Adams was arrested following an incident where he was intoxicated and threatening three people, one of them being a 14 year old, with a 12 inch hunting knife. Officers reported that Adams yelled profanities at the victims and lunged at them with the

knife. Adams eventually succumbed to officers and was disarmed before being taken into custody. He denied any wrongdoing in the situation at the time of his arrest.

Adams is to serve probation until March 20, 2020.

• **Shane Marshall Beck**, of Cassville, pled guilty to possession of a controlled substance in May 2014 for charges originating in 2012. Beck's probation has since been revoked, and he is to serve 120 days of shock incarceration as part of his

original seven year sentence with the Department of Corrections.

On February 7, 2012, the Barry County Sheriff's Department investigated a residence where Beck was living. In Beck's room was a water bong, propane torches, distribution baggies with white residue that field tested positive for methamphetamine, hemostats, digital scale, glass pipe with burnt residue and two cut straws.

• **Sean Swaffar Berry**, of Belton, pled guilty to DWI-

Alcohol as a persistent offender. Berry was granted a suspended execution of a three year incarceration sentence with the Department of Corrections and four years supervised probation.

On September 26, 2015, Berry was arrested for driving while intoxicated after failing a field sobriety test near Campground 3 at Roaring River State Park on Highway F. Berry told the officer he had been drinking. He also had prior driving while intoxicated convictions.

Berry is to serve probation until March 20, 2021.

• **Everett Kenneth Davis**, of Exeter, pled guilty to possession of a controlled substance. Davis received a suspended execution of a seven year incarceration sentence with the Department of Corrections and five years supervised probation.

On February 2, 2016, Davis was stopped at the entrance of Walmart. He was in possession of digital scales and distribution baggies. He also had two baggies of methamphetamine.

Davis is to serve probation until March 28, 2022.

• **George Randall Davis**, of Golden, pled guilty to receiving stolen property. Davis received a suspended imposition and five years supervised probation.

On three different days between August and November 2016, Davis burglarized a residence on State Highway J in Golden. Included were an \$800 saddle, \$200 Dura Flame infrared heater, and a \$300 window unit AC, all from a house he was renting. He pawned the items at Sho-Me Cash and Pawn.

Davis is to serve probation until March 20, 2022.

• **Jeremy F. Donahoo**, of Aurora, pled guilty to resisting arrest for a felony

and tampering with a motor vehicle in the first degree, both in 2015. Donahoo has since violated the terms of his probation and is to serve his original sentences, four years incarceration for the resisting charge and seven years incarceration for the tampering charge.

In July 2014, Donahoo was arrested after fleeing on foot from officers with the Barry County Sheriff’s Department. Donahoo was caught and found with multiple blank checks on his person belonging to someone else. The checks had been stolen. Then, in August while in police custody, Donahoo had to be transported from the jail and kicked out the back window of a transport vehicle resulting in over \$200 in damage.

• **Waylon Floyd Enck**, of Pineville, pled guilty to possession of a controlled substance. Enck received a suspended imposition of sentencing and five years supervised probation.

Enck’s charges originated in November 2015. An officer pulled him over on State Highway 76 in Exeter. He initially gave false information, and when he did give officers his wallet, there was a baggie of methamphetamine inside.

Enck is to serve probation until March 21, 2022.

• **A J Hunter**, of Purdy, pled guilty to assault in the third degree. Hunter received a suspended imposition of sentencing and two years unsupervised probation.

In August 2015, Hunter and two other men went to the Rowdy Beaver. Hunter and the other two attacked a man at his home near the bar, pulling him off the porch and kicking and punching him while he was on the ground.

Hunter is to serve probation until March 20, 2019.

• **Kaitlan M. Jacobs** pled guilty to burglary in the second degree. Jacobs received a suspended imposition of

sentencing and five years supervised probation.

In October 2015, Jacobs burglarized a home on Claire Street to steal clothing.

Jacobs is to serve probation until March 21, 2022.

• **Terri Lynn ones**, of Noel, pled guilty to four counts of receiving stolen property and two counts of burglary in the second degree. Jones received a suspended execution of a seven year incarceration sentence with the Department of Corrections and five years supervised probation.

years incarceration with the Department of Corrections.

- **Amber Rose Merritt**, of Cassville, pled guilty to theft/stealing of \$500 or less in value. Merritt was sentenced to one year incarceration in jail.

In August 2012, Merritt broke into a home and stole a laptop, video game system and DVDs. She was a roommate in the house at the time and was seen taking the items.

• **Derek Ryan Mettlach**, of Cassville, pled guilty to burglary in the first degree

in 2014. His probation has since been revoked and he is to serve five years incarceration with the Department of Corrections.

In 2014, Mettlach kicked into a door of an apartment in Monett. When he was inside, he tried to steal electronics but was confronted. Then, he left, broke a different window and climbed back into the same apartment to steal.

- **Samuel Schenck**, of Granby, pled guilty to forgery in 2012. Schecnk's probation has since been revoked and he is to serve five years incarceration with the Department of Corrections.

Schneck's original charge was from a bad check written in October 2010.

- **Kenny Dale Shepard** pled guilty to non-support with the total arrears

in excess of 12 months. Shepard received a suspended imposition of sentencing and five years unsupervised probation.

Shepard was in total arrears for \$28,597.59 for his minor child.

Shepard is to serve probation until March 21, 2022.

• **Kathryn Susanne Small**, of Cassville, pled guilty to aggravated stalking as a first offense. Small received a suspended imposition of sentencing and four years supervised probation.

In May 2016, Small sent a series of threatening text messages to the victim, accusing them of child molestation and threatening to rape, slaughter and murder the victim's associates. She also claimed to be an archangel.

Small is to serve probation until March 20, 2021.

- **Jason A. Stewart**, of Purdy, pled guilty to DWI-drug intoxication as a persistent offender. Stewart received a suspended execution of a three year incar-

ceration sentence with the Department of Corrections and five years supervised probation.

Stewart is to serve probation until March 30, 2022.

- **Crystal Vega**, of Exeter, pled guilty to theft/stealing of a credit card in 2014. Vega's probation has since been revoked and she is to serve five years incarceration with the Department of Corrections.

Vega stole a debit card in 2014.

- **Timothy Michael Wiott**, of Shell Knob, pled guilty to distribution of a controlled substance and possession of a controlled substance. Wiott received a suspended execution of a seven year incarceration sentence and five years supervised probation.

Wiott's residence was searched in August 2016. Drug paraphernalia, methamphetamine and more were found in the home. Three children lived in the home at the time

Wiott is to serve probation until March 20, 2022.

Source Water Assessment

To access the maps for your water system you will need the State-assigned identification code, which is printed at the top of this report. The Source Water Inventory Project maps and information sheets provide a foundation upon which a more comprehensive source water protection plan can be developed.

Why are there contaminants in my water?

Drinking water, including bottled water, may reasonably be expected to contain at least small amounts of some contaminants. The presence of contaminants does not necessarily indicate that water poses a health risk. More information about contaminants and potential health effects can be obtained by calling the Environmental Protection Agency’s Safe Drinking Water Hotline (800-426-4791).

Contaminants that may be present in source water include:

Is our water system meeting other rules that govern our operations?

The Missouri Department of Natural Resources regulates our water system and requires us to test our water on a regular basis to ensure its safety. Our system has been assigned the identification number MO5010730 for the purposes of tracking our test results. Last year, we tested for a variety of contaminants. The detectable results of these tests are on the following pages of this report. Any violations of state requirements or standards will be further explained later in this report.

In 2004, Jamie Vest, of Stoutland, became the first Missouri girl to win the state cross country meet four times during her high school career.

On Monday, Vest reminded the running world she is still around with a sensational top-40 finish in the women's division at the Boston Marathon. She hit the finish line in 2:50:23 for the 26.2 mile point-to-point course. That is eight minutes faster than she ran in winning the 2015 Dallas Marathon.

Two other notable southwest Missouri runners toed the starting line at Boston. Joplin's Jenna Mutz ran a strong 3:17:18 in the wind and the heat, finishing 508th among the thousands of

women runners. Veteran distance runner Mark Plucinski, of Carl Junction, struggled in the latter stages of the race. At age 62, he still managed to break the 4-hour barrier, running 3:55:14.

USA runners captured high spots in both elite divisions. Olympian Galen Rupp placed 2nd overall in 2:09:58, trailing the individual cham-

Seven American women placed in the top 15, led by Jordan Hasay and Desiree Linden in 3rd and 4th, respectively. Hasay clocked a 2:23 flat, while Linden checked in with a 2:25:06. The women's champion was Edna Kiplagat of Kenya. The 37-year old posted a winning time of 2:21:52.



county away.

One Purdy student, Will Henderson, 10, talked about what he thought about after the tornado came through. "I was thinking about how we heard the sirens, and my family was going crazy getting everyone safe, and then this happened to another school. At the end of the day, Goodman School was basically blown up by that tornado," Henderson said.

Another student, Amarie Burt, 10, said, "My first thought was how bad the destruction was. The roof was

just torn off."

While the kids said they wanted to help, they had no idea the project would become as big as it did.

As the word spread

throughout the community, more people and teachers began stepping up, collecting supplies and helping. It went from Horn's class to a fourth-grade-wide project to pro-

vide relief to educators at the school where the devastation was so severe.

Horn said, "We had this clear tote, about a paper box size, and we thought if we could fill it, it would really help. But all of a sudden, it blew out of control and all of these people wanted to help. We even got some donations from Monett and Southwest Schools. It spiraled into such a bigger project."

She added, "The students really thought about what it would be like. They said, 'Our books that we love would be gone. Everything would just be gone. It could have been us.' So when someone is down, you help them up. And then if you're down, someone helps you up. That's just what you do. It's the right thing to do."

The school district's bookkeeper came up with a way to help that incorporated reading and the school's 5th/6th grade basketball tournament. Anna Marie Erwin, the school's bookkeeper, approached the athletic director about offering free admission to the tournament if a book was donated to Goodman Elementary. This coincided with the school's

buy one-get one free book fair, and students, parents, teachers and administrators alike donated stacks of books. In all, they collected 169 books and \$77 in cash donations to purchase additional books. Erwin delivered those books directly to Neosho where they are organizing donations.

Amarie said, "I like to read. I would miss the books."

As the collection came to an end last Thursday, April 13, the students reflected on what they would miss most if the tornado had ripped through their own classroom. Quincy Hartwigsen, 10, said, "I thought it was horrible because I couldn't imagine it happening to us. Everything was just destroyed."

He added they collected a lot of essential supplies for the students, like pencils and glue.

Will concluded his thoughts about the Goodman devastation and why they had worked so hard to collect supplies. He said, "I was kind of thinking, if this happened to us. We would be doing the same thing we're doing now, but without our school. We would be in a gym with curtains hanging everywhere. It would be hard."

Purdy Schools superintendent Steven Chancellor said, "I'm really proud of the kids, and we are happy to help. It was great to see everyone band together, and it wasn't just Purdy. We started the book collection at the tournament, and we had equal donations from surrounding communities like Exeter and Wheaton and all around. It was most definitely a community recognizing that a school needed our help, and we all needed to pitch in."

Purdy School fourth graders were able to donate over a dozen boxes of supplies, including backpacks, paper and more, to fourth graders at Goodman Elementary, who lost everything in the tornado.

Give turtles a brake on Missouri roadways

The Missouri Department of Conservation (MDC) encourages motorists to give turtles crossing roads a brake. Turtles are struck by cars throughout warmer months, but are at special risk this time of year because they are on the move. Young males make up most of the travelers as they search for territories of their own and for females. Females are also crossing roads in search of nesting sites. Comfort is also a factor. Like other reptiles, turtles are cold-blooded so basking on warm asphalt feels good on cool spring days.

MDC encourages motorists to slow down when they see a turtle in the

road and check to be sure they can safely steer around it. If helping a turtle cross a road, keep human safety as the number-one concern. Check for traffic and move the turtle across the road in the direction it is traveling.

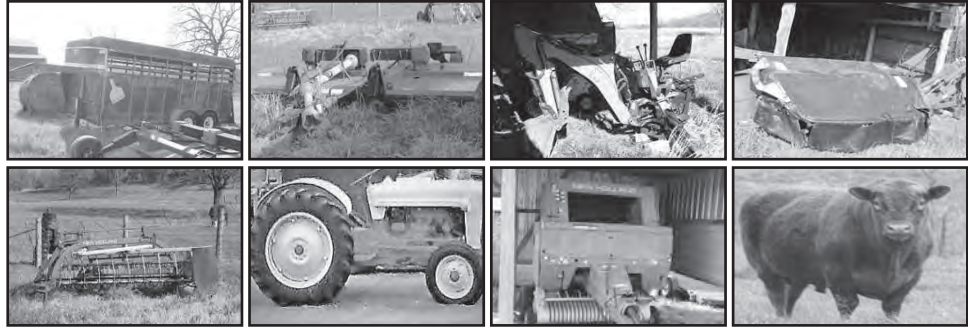
