# Mark your calendars for summer school

After conducting a survey of parents in their districts, most public schools in Barry County are opting to offer 2020 summer school classes. Dates, class times and other pertinent details follow for the schools who made information available by press time.

Cassville Schools: May 27 – June 30 | 8 a.m. - 2:30 p.m.

In accordance with the CDC and the Barry County Health Department, Cassville Schools will follow health and safety guidelines based on established state and federal re-opening recommendations.

In-person, seated summer school classes are offered to incoming Kindergarten -

6th Graders. Teachers will focus on fourth quarter curriculum and instruction.

In an effort to practice social distancing, we will utilize both the primary and intermediate buildings and both cafeterias.

Breakfast will be served to students from 7:40 - 8 a.m. Breakfast and lunch is free for all students who attend summer school.

An early room will be made available at 7 a.m. in the primary and intermediate buildings.

To enroll your child in summer school, please return a registration form to your student's teacher or the building office. Forms can be found on the school's website at https://cassville.k12. mo.us/

K-6 students will have the opportunity to attend activities at the Cassville Aquatic Center. This will be done on a rotation to allow plenty of room for students to maintain distance, thus, each child will not visit the pool every week. At this time, the aquatic center is the only scheduled field trip.

First grade students will be participating in the YMCA Water Safety program. These students will be given more information about this program from their classroom teachers.

Health and Safety **Guidelines**:

We will strive to follow safe social distancing practices by class.

# YMCA lifeguards refresh skills at Aquapalooza

Lifeguards from eight Ozarks Regional YMCAs gathered Saturday, May 16, at the Monett Y's indoor pool for training. The event, called "Aquapalooza," included review and practice of lifesaving techniques for the 80plus lifeguards who attended from facilities located in Bolivar, Lebanon, Hollister, Springfield, Monett, Cassville and Camp Wakonda, near Ash Grove.

"Aquapalooza is an annual training program for all of our lifeguards," Erin Shaw,

YMCA Chief Operations Officer, said. "This is our sixth year to conduct it in Monett. We've had this one scheduled since February, right before COVID-19 broke out. We weren't sure if we would be able to go ahead with it, or if we would need to postpone. When the county opened back up, we decided to hold it as planned, in anticipation of a June 1 pool-opening date."

Shaw emphasized the June 1 pool-opening date is still subject to change, though. "It will depend," she said,

"on whether we see an increase in cases of COVID-19 between now and then."

During Aquapalooza, life guards were divided into five groups, which rotated between different instructors, who reinforced different skill sets.

The community room featured "customer relation skills," as Shaw put it.

"When working in a pool setting, there are rules that need to be followed," Shaw said, "and, occasionally, there

On October 17, 2019, a four-wheeler accident near her home left 15-year-old Jailee Mitchell in critical condition. Now, six months later, she is home and healing from the injuries she sustained.

October 17 was a day like any other for Jailee and her mom, Beverly Mitchell. While her dad, John Mitchell, was out of town, Jailee helped her mom finish up chores. After taking the trash out, she hopped on her fourwheeler to ride down the long lane to the road to get the mail.

About 30 minutes had passed when Beverly Mitchell realized Jailee hadn't come back. After calling and mes-

saging her, with no response, Beverly tried calling her older daughter, Bailee, and her sister, Edith, who both lived in separate houses nearby. Neither of them had seen nor heard from her.

By that time, alarmed, Beverly drove down the lane, then turned onto the road toward her sister's and daughter's houses. Halfway between the two places, she discovered Jailee lying facedown in the road, with blood coming from her ears, nose and throat. The four-wheeler was still running nearby.

immediately Beverly called 911. She was advised not to move Jailee from the location where she lay, but to turn her on her side to keep her airway open. Beverly's nephew met the ambulance at the top of the road so it wouldn't miss the turn, while her niece made calls to Jailee's dad and sister.

When the ambulance arrived, paramedics intubated Jailee on site, before whisking her away to a waiting helicopter, where she was airlifted to Mercy, in Springskull to relieve the pressure. Jailee spent three weeks in the intensive care unit, and was then transferred to a regular room.

As Jailee's condition improved, doctors advised her parents that Ranken Jordan Pediatric Bridge Hospital in Maryland Heights - a suburb of St. Louis - would offer the best chance for Jailee's rehabilitation, a process that could take some time. Ranken Jordan provides rehabilitation to children recovering from acute illness or injury - one of only a handful **JAILEE from FRONT** 

of facilities that do so. However, there was one obstacle. Ranken Jordan required insurance, which Jailee did not have.

John Mitchell had started a new job which required travel shortly before Jailee's accident, but wisdom dictated that he resign in order to be present for the ordeal Jailee was facing.

So, with the help of hospital personnel, John and Beverly applied for Medicaid for Jailee. The application was approved two days later and Jailee was transferred to Ranken Jordan.

Jailee progressed well during her first month at the rehabiliation facility. She relearned to eat and talk. However, due to several strokes she'd experienced, she was unable to move her left arm.

Later, though, due to narrowing of the ventricles in her skull, fluid began to build up around her brain, creating pressure and causing symptoms which mimicked another stroke. She began losing some of the skills she'd recently relearned. She was rushed to Barnes Jewish Children's Hospital in St. Louis, where they determined a shunt would need to be inserted to relieve the pressure on her brain.

A surgeon in Springfield performed the required surgery. After the swelling on her brain receded, her skull flap was replaced, and she returned to Ranken Jordan for continued rehabilitation.

Jailee relearned to talk, regained use in her right side,

# Shell Knob man wins big


William Davis of Shell Knob stopped at White Oak Station, located at 1225 Ridgedale Road in Ridgedale, before going to work. But instead of purchasing the \$5 and \$10 Missouri Lottery Scratchers tickets he usually buys, Davis chose a \$20 game - "\$5 Million Big Money." He scratched the ticket in his truck and uncovered a \$100,000 prize.

"It blew me away. I was speechless," Davis shared.

a simple, "Wow, it is real!" More than \$18.3 million

in unclaimed prizes remain in the "\$5,000,000 Big Money" Scratchers game. All current Missouri Lottery Scratchers tickets can be scanned on the Lottery's mobile app and on Check-A-Ticket machines at retail to determine if a ticket is a winner.

In the most recent fiscal year, players in Taney County, where the winning ticket was sold, won more than \$11.5

Cassville Middle School Life Skills teacher, Cheryl Dubuque, said even though it's been a wild ride this year, she's pleased with her students' accomplishments.

"We were able to finish a project that we started last August," Dubuque said. "I want to thank Litho Printers for making it possible."

The end result of the class's labor is a printed and bound book Dubuque's 11 students created themselves.

"Our original plan was to write a book about historical sites in Barry County, but as we progressed, our plan evolved. # **Barry County Advertiser Years Past**

50 Years Ago BCA, Volume 3, Number 23, Cassville, Missouri, Wednesday, May 13, 1970 Two CHS Speech Students Honored By NFL

Two students from the debate class of Cassville High school have won top honors in the National Forensic League. Debby Curry, senior, daughter of Mr. and Mrs. Paul Curry, has recently received the fourth and highest of the four degrees, that of Distinction. On March 27, 2020, President Trump signed the Coronavirus Aid, Relief and Economic Security Act (CARES) Act into law. The CARES Act is a \$2 trillion relief package to address the economic fallout related to the COVID-19 public health emergency.

Section 18003 makes funds available from the Education Stabilization Fund for grants to State Education Agencies for elementary and secondary school emergency relief.

Section 18005 of the Act provides that Local Education Agencies (LEAs) receiving funds from the Elementary and Secondary School Emergency Relief Fund must provide equitable services to non-public schools as required under section 1117 of the ESEA. However, control of these funds and title to materials, equipment and property purchased with such funds must remain with the public school district, and be administered by the public LEA. Public school districts will need to consult with non-public school officials to determine how the services will be provided to the non-public schools.

Allowable Uses Applicable to Non-Public Schools

- 1. Any activity authorized by the ESEA of 1965, including;
- The Individuals with Disabilities Education Act (20 U.S.C. 1400, et seq.) ("IDEA"),
- The Adult Education and Family Literacy Act (34 U.S.C. 463, et seq.),

• The Carl D. Perkins Career and Technical Education Act of 2006 (20 U.S.C. 2301, et seq.) ("the Perkins Act"), or

• Subtitle 8 of title VII of the McKinney-Vento Homeless Assistance Act (42 U.S.C. 11431, et seq.). 2. Coordinating the preparedness and response efforts of local educational agencies (LEAs) with state and local public health departments and other relevant agencies to improve coordinated responses among such entities to prevent, prepare for and respond to COVID-19.

3. Providing principals and others school leaders with the resources necessary to address the needs of their individual schools.

4. Developing and implementing activities to address the unique needs of low-income children or students, children with disabilities, English learners, racial and ethnic minorities, students experiencing homelessness, and foster care youth through activities that include how outreach and service delivery will meet the needs of each population.

5. Developing and implementing procedures and systems to improve the preparedness and response efforts of LEAs.

9. Purchasing educational technology (including hardware, software and connectivity) for students who are served by the LEA that aids in regular and substantive educational interaction between students and their classroom instructors, including low-income students and students with disabilities, which may include assistive technology or adaptive equipment.

10. Providing mental health services and supports.

11. Planning and implementing activities related to summer learning and supplemental afterschool programs, including providing classroom instruction or online learning during the summer months and addressing the needs of low-income students, students with disabilities, English learners, migrant students, students experiencing homelessness and children in foster care.

The CARES Act funds are for the 2019-20 school year and will be available to LEAs for use until September 30, 2022.

While the Missouri Department of Elementary and Secondary Education has several non-public schools registered for participation in federal programs, there may be additional nonpublic schools that wish to receive an equitable share of services funded by the CARES Act. 
CPR classes were taught in the gym, where dummies of children, adults and infants with inflatable "airways" were used for practice purposes.







# Watch for MoDOT mowing crews

Spring rains and warm temperatures bring seasonal growth on Missouri roadways. The Missouri Department of Transportation urges motorists to use caution when encountering tractor mowers near the shoulder of interstates and other busy

"Our mowing focuses on visibility and safety," said MoDOT State Maintenance Director Natalie Roark. "Please watch out for our crews, slow down and don't drive distracted."

Major and minor routes are mowed in three cycles usually starting in mid-May and continuing in July and September. MoDOT mows about 400,000 acres of grass each year, which is equivalent to 300,000 football fields. Along with mowing, crews selectively use herbicides to stunt vegetation growth, control brush and stop the spread of noxious weeds. Encouraging wildflower growth and using herbicides carefully adds additional benefits in reducing the amount of time spent mowing.

On rural two-lane roads, crews may use a protective "follow" truck to alert motorists they are approaching slow-moving mowers. Drivers are advised to use the following tips to safely pass mowers:

Be alert for trucks and tractors with lights flashing and moving slowly, 2 to 5 mph.

Slow down and focus on the road ahead of you. Put your cellphone down and avoid other distractions.

Be prepared to stop or drive very slowly behind a "follow" truck, especially approaching a hill or curve on a two-lane road.

Obey the no passing zone stripes and only pass when you can see far enough past the "follow" truck to avoid meeting oncoming traffic.

Currently, Missouri has significant barriers impeding military spouse licensure. HB 1511 &1452 will permit military spouses to receive an equivalent license in Missouri providing that the requirements from their home state are substantially similar to, or more stringent than, Missouri's requirements.

By allowing military spouses to work in their licensed occupation, HB 1511 & 1452 will alleviate stress for military families relocating to Missouri. This legislation also supports Governor Parson's broader focus on workforce development.
