Re-entry plans announced for area schools

Exeter R-VI and Southwest R-V School Districts completed and posted their re-entry plans for the 2020-2021 school year online last week. In his letter to parents, Exeter Superintendent Dr. Ernest Raney stated, “We value the partnership we have with parents as we work to provide the best learning opportunities for our students.” Cooperation between the schools and community has been an essential element of all of the Barry County re-entry plans. The back-to-school plans for Exeter, Southwest, and the other area districts were composed by administrators with input from the commu-

nity compiled through recent parent/guardian surveys or meetings. Like the other Barry County districts, Exeter and Southwest are committed to providing the safest possible learning environments while ensuring that all students are provided with equitable and viable educational opportunities. In every school, students are being asked to use proper handwashing procedures, to follow physical distancing guidelines when possible, and to drink from refillable water bottles rather than traditional water fountains. Faculty and staff members will follow CDC protocols for health and well-

ness and will be required to wear masks when physical distancing is not possible. All schools will offer both in-class and virtual learning opportunities for every grade level in order to give parents and guardians a choice in how their students return to school. Two very important requests from the area schools are that parents and guardians keep their contact information up-to-date and that they check the school websites and social media pages for important new announcements. COVID-19 claims more residents

Acambaro Restaurant temporarily closes after employee tests positive

The Barry County Health Department is reporting the third and fourth COVID-19-associated deaths of Barry County residents.

One resident, a 71-year-old female with serious underlying health issues, was a resident of Lacoba Homes in Monett, according to health department administrator, Roger Brock.

Health Department and Emergency Management officials wish to offer their sincerest condolences to the family and friends on their losses.

“Older persons, especially those with underlying health issues, are at the highest risk of severe and fatal COVID-related infections,” Brock said. “In the State of Missouri, 37 percent of COVID-19 cases are in people older than 50 years, yet that same age group represents 97 percent of COVID-19-related deaths. This is the reason that younger persons, who may have few if any symptoms, must exercise extreme caution when visiting with older persons, who, if they contract COVID, are at the greatest risk of death.”

A COVID-19-positive case was identified at Monett restaurant.

The Barry County Health Department is announcing a person employed at Acambaro Mexican Restaurant in Monett has tested positive for COVID-19 as a result of community spread. The individual is in isolation and close contacts are being con-

tacted and, when appropriate, ordered to quarantine.

The owners of Acambaro Mexican Restaurant have decided to close the business to give staff time to monitor for symptoms and provide ample time for a deep cleaning of the facility. The voluntary decision was based on an abundance of caution and concern for customers and staff. The owners will announce the reopening date as soon as it is determined.

Upon reopening, all staff will be screened for symptoms of COVID-19 before each shift, face coverings will continue to be required for all employees, and all high touch surfaces will be cleaned often.

Roger Brock, Administrator of the Barry County Health Department, commended the owners of Acambaro for taking efforts to protect the health of employee, families, and customers.

“They decided closing was the safest option to protect their staff and our community. We appreciate their commitment to the health of our residents,” he said.

Brock reminded the public that COVID-19 is not food-borne and there is no risk of contracting COVID-19 from a meal. Customers do not need to self-quarantine unless symptoms develop. Anyone who develops symptoms should call their primary

care provider or the Barry County Health Department at 417-847-2114.

Symptoms of COVID-19 can appear 2 to 14 days after exposure and include fever or chills, cough, shortness of breath, fatigue, fever, muscle or body aches, headache, sore throat, congestion or runny nose, nausea or vomiting, diarrhea, or a new loss of taste or smell.

If you believe you have symptoms of COVID-19, stay home, call your medical provider, and wear a mask when near anyone who does not live in the same home.

Barry County Phase 2 Mitigation Rules began June 26 and remain in effect until August 31, 2020. Those rules include required source control masking of service providers, recommended physical distancing, cloth face-coverings, and enhanced hygiene practices. Administrator Brock and Emergency Management Director David Compton want to remind citizens of the need to wear face coverings anytime you are within six feet of people outside of your home.

“Remember, face-coverings are for the protection of those around you,” they said.

They also encourage individual businesses to adopt masking requirements for employees and customers. Service providers who cannot practice physical distancing of six feet or more are required to remain masked while providing any type of service.

The number of Barry County positive COVID-19 cases now stands at 256. Of those, 33 are in isolation; two are hospitalized; 219 have recovered; and four have died. One hundred, four are in quarantine.

The largest number of cases appear in the “Under 25” age bracket.

Shell Knob resident dies in head-on collision

Lori R. Cupp, 42, of Shell Knob, was killed in a head-on collision Saturday, August 8, when her southbound 2012 Nissan Sentra crossed the center line and struck a northbound 2014 Ford Edge driven by Tracy L. Periman, 51, of Aurora, Missouri.

The accident happened at 3:05 p.m. three miles north of Jenkins on Highway 39.

Cupp was not wearing a safety device. It is not known whether she was insured. She was pronounced dead on the scene by Barry County Coroner, Gary Swearingen. Her body was taken to Fohn Fu-

neral Home, and the Sentra was towed by Brice’s Towing.

Periman, who was wearing a safety device, was transported to Springfield by Mercy Lifeline with serious injuries. Her vehicle was towed by Double Eagle Towing.

The wreck was investigated by Trooper M. W. Coleman with Troop D, of the Missouri Highway Patrol. He was assisted by Sergeant C. S. Mason and Crash Team Sergeant S. R. Richardson with the Missouri Highway Patrol.

The accident marked Troop D’s 67th fatality for the year.

MDC invites kids to free fishing day at Roaring River State Park

Young anglers will have opportunities to fish for free at Kids' Fishing Day, Aug. 15, at Roaring River State Park. This event is co-sponsored by the Missouri Department of Conservation (MDC) and the Missouri Department of Natural Resources.

Kids' Fishing Day will be held from 7 a.m. to 8 p.m. At this event, an area of the park will be designated as a fishing area for youths age 15 and under. Children in that age range can pick up free trout tags at the Roaring River park store any time on Aug. 14 or all day on the day of the event. MDC staff and volunteers will be available to assist the young anglers. All anglers must bring their own equipment and bait. Parents are welcome to assist kids,

too, but only one pole may be used between the helper and the child. Adults are not allowed to fish by themselves.

DHSS launches new electronic COVID-19 case reporting system

The Department of Health and Senior Services (DHSS) partnered with the Office of Administration's Information Technology Services Division (OA ITSD) to develop and launch the new electronic COVID-19 case reporting system. The online reporting system allows providers and congregate facilities to report case information for individuals with COVID-19 quickly and easily.

The COVID-19 case reporting system replaces all forms of paper reporting and fulfills the requirement for residential congregate facilities to report COVID-19 case reports. COVID-19 case reports submitted via traditional paper reporting meth-

ods could contain inaccurate or incomplete information. The new system ensures that all necessary data is collected and disseminated to epidemiologists and facility management for case management and coordination of facility-wide testing.

This new reporting system is part of DHSS's efforts to ease the burden of COVID-19 case reporting on Missouri's providers and modernize its disease surveillance systems. By consolidating multiple methods of reporting, providers now can submit reports to DHSS through one channel. The COVID-19 case reporting system will integrate with other disease surveillance systems at

DHSS to ensure seamless data transfer and availability.

"We are determined to continue finding ways to advance processes and create more efficiencies throughout our public health response to this crisis," said Dr. Randall Williams, director of DHSS. "Digitizing this reporting system will help streamline a process between the state and those reporting cases to us in multiple ways."

The electronic COVID-19 case reporting system is available for any health care or congregate facility reporter in accordance with the state regulation on communicable disease and can be accessed from the main COVID-19 webpage.

Area coalition forming to serve families

Three area women who have a passion for helping children and families in need are working to bring local service providers together to form a central hub for the dispersal of information and resources. The group is called Southwest Missouri Coalition of Charities and Community Services (SWMO-CCCS). Although the name is long, the concept is simple.

"Our idea," said business owner, Rachel Luebbering, from Purdy, "is to create a resource guide for residents, business owners and not-for-profit groups in Barry, Stone and Lawrence Counties and beyond. With a compiled resource guide, any one organization can give referral information for others in the area. As it is, now, some of the groups are not even aware of the existence of some of the others. We're working to change that."

"In rural communities in Barry, Lawrence, and Stone Counties, many people live below the poverty level from one generation to the next," Luebbering said. "But we also have a lot of people and organizations willing and capable of helping. By the formation of a coalition, organizations can pool time and resources with each other on behalf of those they serve."

Luebbering has worked with various charities serving children for many years. A few months ago, she put her head together with those of Robyn Chrysler, of Kiddie City in Monett, and Katie Velazquez, of the Family Advocacy Center in Monett, with the idea of creating the central hub.

As an initial step, the trio of women planned a carefully orchestrated Zoom conference titled "A Community Conversation" on Thursday, July 30, to float the idea to interested attendees who were each allotted two-minute time slots to speak. A variety of service providers of all types were represented, including Drury University, Crowder College, OACAC Neighborhood Centers, Life 360, Clark Community Mental Health Center, the Family Advocacy Center, Tri-County Pregnancy Resource Center, Kiddie City, 4-H, Workforce Development Center, and His House, among many others.

In addition to organizations, political candidates were also on hand to share ideas for helping those with needs in our area.

Mike Moon, Senator-elect for Missouri's 29th District, said he was recently made aware of reductions in staffing for Children's Division, which adds to the workload of continuing employees, making it difficult for them to cover all bases.

In reference to families

receiving benefits from the state, he indicated that many times a pay raise will knock them out of bounds for those benefits, so making changes to the benefit structure might be in order.

All of the participants in the Zoom conference were united in their desire to help families - specifically, children - in need.

Danny Boyd, Sheriff-elect for Barry County, believes a youth program for young teens might stop problems before they begin.

"In my experience in law enforcement," he said, "when a kid commits a crime, the parents are the ones who usually pay restitution."

"Why not make the kids work to pay it off?" He questioned.

Boyd would like to see law enforcement personnel and churches team up for mentoring programs, perhaps at the YMCA.

Many of the representatives from the various organizations participating in the community conversation were unfamiliar with His House, in Shell Knob, which provides residential life services for certain individuals in need, typically a single parent with a child or children.

"We are not an addiction-recovery center," director, Trina Colwell, said. "We are more of a centralized program to help people get back on their feet if they've been through difficult times and have nowhere to turn."

A primary concern for Robyn Chrysler, owner and operator of Kiddie City, a day care in Monett, is the shortage of childcare in the area, as well as the shortage of foster parents.

"It's hard for parents to work, let alone get ahead, when they can't afford to pay a babysitter," she said.

According to Chrysler, although there is state compensation available for child care, it's typically not enough to meet the expenses of the providers. She would like to see local churches consider partnering with child care providers to increase availability of child care for working parents.

The initial Community Conversation was deemed a success by those in attendance.

"The next step," said Luebbering, "is the creation of a central website where the contact information of service providers can be easily located."

SCHOOLS from FRONT

Learn plan is posted on the District's Facebook page for easy access. When school begins on August 25th, students and parents can expect to see many adjustments in procedures and expectations. Faculty and staff will be required to wear masks or shields. Students who ride the bus will be required to wear face coverings and will have seating assignments. While masks are not required in class or during passing periods, students are strongly encouraged to wear them whenever physical distancing is not possible. Other changes implemented include an emphasis on hygiene procedures, a staggered bell schedule, assigned seats in class, additional lunch shifts, modifications in daily routines, and reduction of large group gatherings. If parents have questions about any of the guidelines, they are encouraged to call the school office.

In preparation for the August 13th start of school, Southwest Superintendent Tosha Tilford posted a letter to parents, guardians, and staff members on the Southwest R-V website, along with the school's re-entry plan. Students and parents may consider either face-to-face or virtual learning options.

At Southwest, all staff and students 5th grade and up are required to wear face shields or masks during transition periods and when physical distancing is not possible; all students must wear a mask on the bus. The policy is, "When you move, you mask." All students will have their temperatures taken as they board the bus, receive a face shield (which they are to keep all day), and sit in assigned seats. At the end of the day, bus riders will return the face shields for sanitizing. Other adjustments include assigned seats in the classroom, proper handwashing techniques, modified cafeteria seating and schedule, and procedure for pickup and return of Chromebooks. Additionally, all cell phones and smart watches must remain in students' lockers during class. Any questions on the guidelines should be directed to the school office.

A brief review of last week's information:

- Guidelines for Cassville Schools can be found on the district web page under the COVID-19 tab. An important note is that while face coverings for students are required on the buses, they are strongly recommended but not required in the classroom; students' families may make their own choices.
- A link to Wheaton's guidelines is provided on their Facebook page. Students in grades 7-12 are required to wear face coverings when social distancing is not possible; masks are strongly encouraged for students in grades K – 6.
- Purdy's re-entry plan can be found on their district's website under the red COVID-19 Information and Updates tab. The guidelines state that all staff and students must wear masks or face coverings while on the bus or at school.
- Shell Knob's complete Restart Plan can be found on the district's Facebook page along with updates from the Superintendent, Dr. Fransen.
- On July 30th, a link to the Monett R-I School District's re-entry plan was posted on Facebook. Monett requires that students in grades 3-12 and staff members wear face coverings. Masks are strongly encouraged for students in grades PreK – 2, and all students wear face coverings on the bus.

Parents or guardians should contact their child's school for answers to any questions.

Notice of Spire infrastructure surcharge adjustment application

Spire Missouri, Inc. (Spire) has filed an application with the Missouri Public Service Commission seeking to adjust the infrastructure system replacement surcharge (ISRS) on the bills of its Spire West natural gas customers. The surcharge first appeared on customer bills in April 2004.

According to its application, Spire seeks the adjustment to reflect the annual reconciliation of the difference between the revenues resulting from its ISRS and the appropriate pretax revenues as found by the Commission for the period October 8, 2018, through June 30, 2020, per Missouri statutes. The current ISRS for residential customers of Spire West is \$3.16 a month. Residential customers would pay an ISRS of \$3.36 a month under Spire's application.

Applications to intervene and participate in this case must be filed no later than August 21, 2020, with the Secretary of the Missouri Public Service Commission, P.O. Box 360, Jefferson City, Missouri 65102, or by using the Commission's Elec-

tronic Filing and Information System (EFIS) at www.psc.mo.gov.

Individual citizens wishing to comment should contact either the Office of the Public Counsel (Governor Office Building, 200 Madison Street, Suite 650, P.O. Box 2230, Jefferson City, Missouri 65102-2230, telephone (866) 922-2959, email opcservice@opc.mo.gov) or the Public Service Commission Staff (P.O. Box 360, Jefferson City, Missouri 65102, telephone 1-800-392-4211, email pscinfo@psc.mo.gov). The Office of the Public Counsel is a separate state agency that represents the general public in matters before the Commission.

Spire West provides natural gas service to approximately 517,500 customers in Andrew, Barry, Barton, Bates, Buchanan, Carroll, Cass, Cedar, Christian, Clay, Clinton, Cooper, Dade, DeKalb, Greene, Henry, Howard, Jackson, Jasper, Johnson, Lafayette, Lawrence, McDonald, Moniteau, Newton, Pettis, Platte, Ray, Saline, Stone and Vernon counties.

Residents reminded to complete census

Courtney Ryan is part of a communications team working with the U.S. Census Bureau to ensure remote areas such as Barry County are counted in the 2020 Census. She reminds people that responses to the census determine how hundreds of billions of dollars in federal funds will be allocated every year for the next 10 years. This money is then used for critical public services like emergency response, hospitals, healthcare, water, and waste disposal systems for rural communities.

The current self-response rate in Barry County is 46%. As part of the ongoing 2020 Census operations, the Census Bureau will start visiting the non-responding households to collect responses in person.

Households can still respond now by completing and mailing back the paper questionnaire they received, responding online at 2020census.gov, or by phone at 844-330-2020. Households that respond will not need to be visited in-person.

Catch a falling star

Take a blanket out under the stars after midnight and before dawn to see the annual Perseid Meteor Shower, which can be viewed on warm summer nights in the northern hemisphere.

Since my family immigrated here from Iowa when I was 12 years old, Barry County has bewitched me. Its near-mystical environment of hills, hollows, nooks, crannies and bubbling streams have enveloped me and provided a haven for my sometimes-reclusive nature.

It's been only recently that I discovered the fascinating history of Barry County and Cassville, prompted by my first visit to George Washington Carver National Monument last winter.

Since then, I've been caught up in learning about the people who trod this land before us. If it's not being done, I would love to see local history taught in Barry County school districts. We sit on a trove from a colorful (and, at

times, dark) past that many people, especially newcomers to the area, are unaware of. Sadly, when history is lost, it has a way of repeating itself.

Following is Part 1 of an overview of Cassville's history, with information drawn primarily from Senator Emory Melton's "The First 150 Years in Cassville," as well as from other sources, many found on the Barry County Museum website at barrycomuseum.org. As always, many thanks go to Jeremiah Buntin at the museum.

I suspect an attraction to the topography in Barry County prompted the original pioneers – mostly from Tennessee and Kentucky - to settle here, much as I have been attracted and my father before me. One early pioneer resident referred to south-

west Missouri as the "Land of Six Bulls," which makes no sense unless you know that "Bulls" was his pronunciation of "Boils," an alternate word for "Springs."

James and Josiah Keet (some of the earliest pioneers of Barry County) first found their way to the area in the early 1800s and established a trading post known as Keetsville, where a community soon sprang up. The location is now known as Washburn.

Keetsville was the nearest place to do business for settlers in the Cassville area, until they established a commercial center of their own in 1845.

Cassville's first small mercantile business, and later the first courthouse, was maintained for a time in the home of one of its first residents,

William Kerr. His house was located on the south side of 7th Street, west of Flat Creek, across from the LeCompte lumber building.

One of the early pioneers to Cassville was Jacob Hawk (1828 - 1922), whose family moved to Fayetteville, Arkansas, from Tennessee, then northward to Washburn, then to Cassville in 1845. As a young man, Hawk left Cassville to participate in the California Gold Rush, but returned in time to fight for the Union in the Civil War, after which he operated a stage line between Springfield and Fayetteville.

Another early resident, Littleberry Mason, owned a goodly amount of property on the east side of Flat Creek, also on the south side of 7th Street, southward to the junction of Highways 76, 248 and 112. The Mason house was purported to be a mansion by the standards of the day. However, the Masons' attempts to provide hospitality to both Union and Confederate troops during the Civil War proved to be the demise of their house, which was destroyed by fire in re-

taliation for their refusal to "take sides."

In 1845, 142 lots covering 50 acres were platted and purchased at auction by prospective residents and business owners in the new town of Cassville, named after U.S. Michigan Senator Lewis Cass, an 1812 War veteran and popular public figure at the time. The town was incorporated in 1847.

Cassville quickly flourished. Businesses and log cabin residences quickly sprang up around the original log and hewed-plank courthouse constructed in 1847, after the county seat of Barry County was relocated from Mount Pleasant (west of Pierce City) to McDowell (then known as McDonald) to Cassville, after redistricting of the county.

The log courthouse was replaced with a two-story brick structure in 1858; both buildings were situated in the center of the square, in the same location as the current courthouse.

All seemed to bode well for Cassville, with its idyllic location along Flat Creek and the main road between

Springfield and Fayetteville, Arkansas.

Cassville was served by a local mail route between Springfield and Fort Smith, Arkansas, called "The Underland Mail," which contracted with the federal government in 1855. A telegraph wire was also established along the same road, and the name "Old Wire Road" was given to it. The same route was adopted by the newly-formed Butterfield Overland Mail Service in 1858, when John Butterfield established an

ambitious 2,700-mile route to carry both passengers and mail between Tipton, Missouri, and the west coast.
 The road entered Barry County in the northeast corner, near Osa, continued southwesterly to McDowell, then ran alongside Flat Creek into Cassville. In a diary entry, a Union foot soldier declared that the road crossed Flat Creek 13 times between McDowell and Cassville, surely a challenge for both horses and men. From Cassville, the Old Wire Road continued southwest through Washburn, then on into Arkansas.

On the original Butterfield Coach line, stops were made for the changing of horses at Smith Station, at Wise Spring near Osa, in the northeast corner of the county. Another stop was made at Crouch Station, a few miles north of Cassville on the county road which continues north where Y Highway ends. Markers denoting Smith and Crouch Stations remain for those with eyes sharp enough to spot them.
 The stage coach's final stop in Barry County was at Harbin Station, a mile south of Washburn. No evidence remains of this final stop, al-

though the Old Wire Road remains. It runs past Rock Springs Baptist Church, down what is now Farm Road 1050 into Arkansas. It's a beautiful journey, but not for the faint-hearted.
 By April of 1861, Cassville was the largest town in Barry County, with some 300 residents. The only other notable towns at the time were Keetsville (Washburn), McDowald (McDowell) and Gadfly (Corsicana).
 The rumblings of war, however, were on the horizon, rumblings which didn't bode well for Cassville.

Common Sense Media says teens spend an average of nine hours a day online, compared to roughly six hours for those between the ages eight and 12 and 50 minutes for kids younger than eight.

Staying safe online should remain a priority for students who must spend more time on the internet and using digital education tools. These are some tips for maintaining cyber safety.

- Exercise caution when sharing information like your name, address, phone number, and other personal data online. Check with a trusted parent or teacher before sharing private data.
- Report any online activity that makes you feel uncomfortable, scared or confused, whether it is directed at you or a classmate.
- Think carefully before you post comments online. Data remains online indefinitely, and your words and actions today can greatly af-

fect your future.

- Respect others online by refraining from demeaning or bullying comments.
- Do not try to get around firewalls and blocked websites set up by school administrators. These limitations are there for your protection.
- Stick to school-sanctioned assignments and internet browsing when using school-issued devices. Administrators may have the right to monitor student

activity without students' knowledge and you can easily get yourself in trouble.

- It is easy to hide or fake one's identity on the internet, so never take someone you meet or speak with online at face value. Never meet up with someone you do not know or only met online.
- Talk to your parents or educators about extortion and ransomware that tries to trick you into providing payment in some shape or form

to prevent a perpetrator from releasing private information about you, advises the Readiness and Emergency for Schools Technical Assistance Center.

Various steps can be taken to promote cyber safety among students, parents and administrators.

USDA Accepting Applications to Help Cover Costs for Organic Certification

USDA's Farm Service Agency (FSA) announced that organic producers and handlers can apply for federal funds to assist with the cost of receiving and maintaining organic certification through the Organic Certification Cost Share Program (OCCSP). Applications for eligible certification expenses paid between Oct. 1, 2019, and Sept. 30, 2020, are due Oct. 31, 2020.

"For producers producing food with organic certification, this program helps cover a portion of those certification costs," FSA Administrator Richard Fordyce said. "Contact your local FSA county office to learn more about this program and other valuable USDA re-

sources, like farm loans and conservation assistance, that can help you succeed."

OCCSP provides cost-share assistance to producers and handlers of agricultural products for the costs of obtaining or maintaining organic certification under the USDA's National Organic Program. Eligible producers include any certified producers or handlers who have paid organic certification fees to a USDA-accredited certifying agent. Eligible expenses for cost-share reimbursement include application fees, inspection costs, fees related to equivalency agreement and arrangement requirements, travel expenses for inspectors, user fees, sales assessments and postage.

Changes in Reimbursement

Due to expected participation levels and the limited funds available, FSA revised the reimbursement amount available through fiscal year 2023. Certified producers and handlers are now eligible to receive reimbursement for up to 50 percent of the certified organic operation's eligible expenses, up to a maximum of \$500 per scope.

This change will allow a larger number of certified organic operations to receive assistance. If Congress authorizes additional funding, FSA may provide additional assistance to certified operations that have applied for OCCSP, not to exceed 75 percent of their eligible costs, up to \$750 per scope.

The changes to the payment calculation and maximum payment amount are applicable to all certified organic operations, regardless of whether they apply through an FSA county office or a participating state agency. State agencies that are interested in overseeing reimbursements to producers and handlers in their states must establish new agreements with FSA for fiscal 2020.

Opportunities for State Agencies

Today's announcement also includes the opportunity for state agencies to apply for grant agreements to administer the OCCSP program in fiscal 2020. State agencies that establish agreements may be able to extend their

agreements and receive additional funds to administer the program in future years. FSA has not yet determined whether an additional application period will be announced for state agencies that choose not to participate in fiscal 2020. States that would like to administer OCCSP for multiple years are encouraged to establish an agreement for fiscal 2020. FSA will accept applications from state agencies from Aug. 10, 2020 through Sept. 9, 2020.

State Agencies must submit the Application for Federal Assistance (Standard Form 424 and 424B) electronically via Grants.gov, the Federal grants website, at <http://www.grants.gov>.

More Information

To learn more about organic certification cost share, please visit the OCCSP webpage, view the notice of funds availability on the Federal Register, or contact the FSA county office at your local USDA Service Center. All USDA Service Centers are open for business, including some that are open to visitors to conduct business in person by appointment only.

All Service Center visitors wishing to conduct business with FSA, Natural Resources Conservation Service or any other Service Center agency should call ahead and schedule an appointment. Service Centers that are open for appointments will pre-screen visitors based on health concerns or recent travel, and visitors must adhere to social distancing guidelines. Visitors may also be required to wear a face covering during their appointment.
