Life without parole sentence handed out in Golden stabbing death case

The man convicted of stabbing a man from Golden to death in December 2017 was sentenced to life in prison without the possibility of parole plus an additional 10 years by a Barry County Judge. Matthew Aaron Jackson, 42, of Holiday Island, Ark., was sentenced by Judge Jack Goodman on August 19 after being found guilty of

murder in the first degree and armed criminal action by a jury on March 28 of this year.

Jackson was arrested shortly after the victim, Steven Gregory Chupp, of Golden, was transported to the hospital for several stab wounds. Chupp died en route to the hospital on December 4, 2017.

According to the affidavits probable cause filed by

the Barry County Sheriff's Department in 2017, Jackson told officers he stabbed Chupp several times with a knife on Monday, December 4.

It was released that the two men had an argument, but the nature of that argument was unknown at that time.

Jackson first went to trial on the case in November 2018. However, the initial jury trial was declared a mistrial after accidental contact between a Barry County Sheriff's Department officer and the jury pool. The mistrial was declared on October 29, 2018.

The second trial began on March 26, 2019. The three-day trial resulted in the jury returning two guilty verdicts on the charges Jackson faced: first degree murder and armed criminal action.

Initially, Jackson's sentencing was scheduled for June 17, but it was postponed until this month.

Jackson was transported out of the Barry County Jail on Tuesday, August 27, at

5:27 a.m. Jackson will serve an incarceration sentence of life without parole with the Department of Corrections

plus an additional ten years for the armed criminal action charge.

Shell Knob librarian retires and leaves behind legacy as an innovator

No matter how much things can feel like they stay the same in a small town, eventually change comes knocking. For the last 42 years, students of Shell Knob could count on the consistency of one figure within the school, librarian Sandy Cupps. That all changed this year when Cupps announced her official retirement from her

duties.

Cupps explained that this move was made to spend more time with her ever growing family.

"I turned 68 years old last week," said Cupps. "I have my first grandchild, he's seven months old. Plus, my mother just turned 91 and I need to spend more time with her."

Cupps had previously retired last year, but came

back to the school part time to assist in the library where she was needed. This retirement, according to Cupps, is the real thing, with her officially stepping away from all duties at Shell Knob School.

She, like many in Shell Knob, started her time in the lake community as a tourist. She originally hailed from the suburbs of Chicago, Ill., where she

lived with her parents for a number of years. There, she attended college, receiving her bachelor's degree in Library Sciences from Illinois State University.

While originally only having a minor in library sciences, Cupps opted to change majors after speaking with her mother, who at the time worked for the library coordinator of an Illinois school district.

In Illinois, Cupps served the Oak Lawn Public Library for a year before moving to the Champaign Public Library, where she worked for three and a half years. Cupps explained that while she loved being a librarian, her lack of a master's degree precluded her from further advancement or opportunity in the public library system.

Cupps and her family started vacationing in Shell Knob on Table Rock Lake in 1971. While there, she regularly stayed at the Rod N' Reel Resort and became friendly with the owners of the Shell Knob Cafe.

Loving the area so much, Cupps' parents opted to build a vacation home in Shell Knob. It was here Cupps came in 1977 to va-

cation over the summer. After relating her dissatisfaction with her position in Illinois, friends in the area told her the local school was looking for a librarian.

Before her vacation was over, Cupps was hired by Shell Knob Public School as their librarian. Her parents agreed to let her live in their vacation home so long as she cleaned and maintained

it. She then returned home to Illinois with two weeks to pack her things and move her life to Missouri.

That fall, Cupps began what would be a long and storied career as one of the longest serving employees of the district.

While not educating students on the importance of reading and proper research, Cupps found time

Exeter increases water, sewer rates, cracks down on delinquent bills

Exeter residents will soon see a slight increase in their water and sewer bills after the city council moved to implement a small increase at their regular meeting on Tuesday, August 14.

There were also several key pieces of legislation that will affect the lives of residents discussed and passed. The Exeter board of aldermen made a motion to raise the water and sewer rates for customers con-

connected to city services, both inside and outside of the city limits to help offset costs of the operation of the city's utility system.

The base rates for water will remain the same at \$17.25 for customers inside the city limits, \$27.25 for customers outside of the city limits with meters located within city limits, and \$44.50 for customers with meters outside of city limits. These are the rates for the first thousand gallons of water used by a household.

The rate change affects the prices of every additional thousand gallons of water used. Whereas the rate was previously set at \$3.30 per additional thousand gallons, the council voted to increase the charge to \$3.80 per thousand gallons.

The change also affects the city's sewer rates. The base rates for all customers hooked into Exeter sewer services will remain at \$16 for the first thousand gallons of sewer usage, while the rate for an additional thousand gallons will rise from \$5 to \$5.50.

According to members of the board, this rate increase was done in order to generate more revenue to

Additionally, the city has elected to make a move to collect delinquent water bills in the city. According to Marissa Robbins, Exeter court clerk and treasurer, the previous application that the city used to keep track of water and sewage services only allowed for one name to be included on the bill. Robbins explained this created an opening for several married or cohabiting households to move residences and get water turned on under the name of the other person in the household, while the previous bill under the other resident's name went unpaid. Robbins said it was decided a notice would be

to settle down and start a family. She married Shell Knob native Johnny Cupps, with whom she had twin sons, Matt and Scott, and one daughter, Julie. Seven months ago, she welcomed her first grandchild to the family.

During her time within the district, Cupps said that her favorite thing was the challenge of working with multiple age groups, as the library served grades kindergarten through eighth.

“I liked that I got to see all the kids,” said Cupps. “I wasn’t just with one group all day Long. There was a variety. I got to read to little kids and teach research skills to the older ones. I got to see everyone there mature over time.”

The school librarian has a lengthy list of accomplishments within the district. Cupps organized several career awareness days throughout the years, drawing in not only Shell Knob businesses, but businesses from the surrounding areas to come in and discuss the realities of their professions with students.

From her time in college, Cupps knew that many innovations were coming for her profession, but was not prepared for the meteoric impact that it would have on her career.

“When I was in school for library science, they used to make us read these little vignettes and one of them said ‘someday, from your home you’ll be able to use your computer to get into your public library and see their collection’ and we all didn’t think that would be right,” said Cupps.

Over the span of her career, Cupps was a constant advocate of technology within the school. She was present for the installation and taught the operation of the school’s first computers, Texas Instruments model

TI-99s, to students.

“I enjoyed going to the different technology meetings and stuff,” she explained. “I became the librarian slash technology person, which nowadays, all librarians are the technology person.”

Cupps explained that her interest in technology drove her forward and helped create many new resources for learning within the district.

“I got the first satellite dishes for the school,” said Cupps. “I went to all of the technology meetings back then and found out that we could get a grant for satellite dishes and TVs in every room.”

Later in her career, she chaired the committee that wrote and received a grant to give the school its first fully functional computer lab, after which Cupps familiarized herself enough with the machines to teach computer classes to students.

Cupps also stated that she introduced the computer card book catalogue and check-out system to the school, as well as being an early advocate for allowing

students to use online research for their projects.

Cupps also pushed the school to purchase their first mobile television and VCR setup, a move that saw some pushback from school officials at the time.

“I told the principal at the time that we needed a TV, VCR and a video camera and he told me that we didn’t need that in the school,” explained Cupps. “So, I talked him into it, and we got. Then, when someone from the state came to give a presentation and needed a VCR to show a tape, then the principal got excited about the VCR.”

In her eyes, one of her biggest career accomplishments came later in her career when she wrote and received a \$50,000 literacy grant to improve the school’s library. The check for this grant was given to Cupps in person by Missouri Senator Roy Blunt at a school assembly.

Additionally, she explained that she hosted an incalculable amount of book fairs and kept score for a cornucopia of volleyball and basketball games.

Cupps explained that while her drive and determination definitely made an impact on her position, none of it would have been possible without the constant support of both the school and the community.

“The school, the administration, everybody has always been supportive of the library program and I appreciate that. In going to different meetings I would hear librarians talk about how they didn’t get funding or didn’t think the schools supported them and this and that. So, it was really nice that I always had full support of things I wanted to do in the library, and I wanted to thank everyone for that. I wouldn’t have stayed for 42 years if I didn’t love what I did.”

Cupps isn’t finished with her work at Shell Knob yet, as she plans to return in the future as a substitute for the district. She also works from time to time at the

Thrifty Closet, a thrift store in Shell Knob.

Cupps is also debating the idea of joining the Mentor Program at Shell Knob, where she would come in once a week and help a struggling Shell Knob student to better manage stress and apply themselves in school.

Between all of this, Cupps stated that her ultimate goal in her retirement

is to spend more time with her mother and constantly expanding family.

While many can claim to have an impact on their career field, few people can boast the kind of determination, openness to new technology, drive toward improvement, knowledge and timing of Sandy Cupps.

change, it was decided that the ordinance will now be enforced. Finally, the council officially passed a previously discussed amendment to an ordinance requiring the city to collect a fee from citizens moving trailer homes into city limits and inform neighbors of the move. Citizens are no longer responsible for the \$15 permit to move a trailer home inside city limits nor is the council required to inform the neighboring lots of the move.

Finally, the council also moved to begin accepting sealed bids for the former city hall building. The bid process will last 45 days, and the city reserves the right to refuse any and all bids submitted. 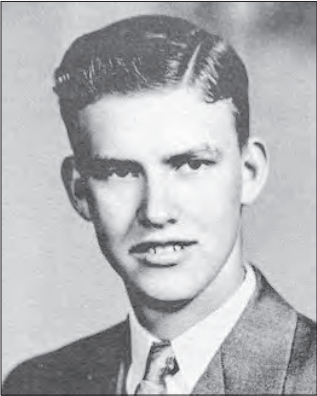

Monett wrestling coaches awarded national honors for championship season

Monett head wrestling coach Daryl Bradley is having one of the best starts to a school year that a coach could ask for. After coming off of a state championship-winning season, Bradley is beginning his 20th year as wrestling coach amidst the news that both he and assistant coach Ben Hohensee were named by the National Wrestling Coaches Association (NWCA) as Head Coach of the Year and Assistant Coach of the Year.

Bradley began life as a native of central Oklahoma before attending school at Labette Community College in Kansas, where he attained an associate of arts in history. After meeting his wife, a Kansas native, Bradley transferred to Huron University in South Dakota, where he attained his bachelor's degree in health and physical education.

He put in applications to every place that he could think of, eventually settling on a modest Missouri town on the border of Barry and Lawrence Counties.

“I was just a starving kid out of college when I came here to Monett,” explained Bradley. “I didn’t know about the history, I just lucked out. The school gave me an opportunity and I’ve been here ever since.”

He began his long career with Monett in the fall of

1999.

Bradley explained he was familiar with the area due to its proximity to Roaring River State Park but had no idea of the storied history Monett’s wrestling program had at the time.

“My friends and I used to come down to trout fish, so I was familiar with the area, but had no idea of the history of the program and how good it was here,” he continued. “They’ve had wrestling since the 60’s here. They had some success and even had some state champs before.”

Bradley didn’t plan on becoming a wrestling coach, but acknowledged he had the background to put forth the effort.

Bradley was a two time state champion wrestler in high school and qualified on the national level in both Kansas and South Dakota.

“I had some coaching experience in college and some success on that mat in high school and they needed the experience, so they just trusted this young kid to lead the program,” stated Bradley. “Before I got here, they were second or third most years and had three or four trophies. So, I stepped into a good foundation, we just needed to find ourselves again.”

Under Bradley’s leadership, the wrestling program at Monett began to flourish mightily, culminating in

back-to-back state championships after multiple seasons of award-winning performances out of his wrestlers.

“We’ve been top ten in the state for 14 of my 20 years here,” Bradley said. “We were state runner-ups in 2004 and 2006. We finally got over that hump in ‘08 and won a state title and again in ‘09.”

After this period of success, the program saw a dip in the number of accolades received. This remained the case until the team took fourth in state in 2017, an event that sparked a slow build leading up to Monett once again seizing the state championship during the 2019 MSHSAA State Wrestling Finals.

Bradley attributes his success to a strong support system, both at home and in the ring.

“I attribute a lot to my support system at home,” said Bradley. “My family, my friends and my close relationship to the people who do great things here are part of it. Also, the family members who haul their kids around all season and keep them ready to compete.”

Monett’s head wrestling coach is a firm believer in the program’s capacity for success, so much so that he’s even brought some of his family members through the program.

“I’ve been fortunate

enough to have a couple of my kids go through the program. I’ve got a senior right now who’s my second son to come through,” said Bradley. “Having a good support system and a supportive administration makes it all work. It makes it all fun for everyone.”

Bradley also knows that the program doesn’t live and die under his direction alone, acknowledging the work of the coaching staff on all levels of Monett’s wrestling program. He gives special credit to the work done by the coaches on the youth level.

Another important piece of the puzzle, according to Bradley, is the tenacity of his athletes.

“We get good kids right away; we just polish them up a little bit, give them a shave and make sure that they’re good to go,” continued Bradley. “We couldn’t have that success without them. I’ve got good kids, a good program and some excellent assistant coaches that make it all work.”

The final component to the Monett wrestling program’s continued success, according to Bradley, is his excellent staff of assistant coaches. One of these assistant coaches, Ben Hohensee, was named Assistant Coach of the Year by the NWCA.

“He’s a huge part of our success,” stated Bradley. “I coached him in high school and I coached most of my

assistants in high school. It makes it special because he knows what to do and to expect. I love all of the ideas that he and my other assistants bring to the table. I love his enthusiasm.

“For him to get recognized for all of the work that he puts in, the love he has for the program, is really neat. I’m proud of him.”

Prospects for this year’s crop of wrestlers are looking positive, with multiple state finishers returning for the 2019-2020 season.

“We had seven state places last year. Out of those seven, five were finalists and four state champs, so every-

one is returning this year,” he said.

Bradley knows the kind of pressure the team will be under.

“I’m sure we’ll have a bullseye on our backs again,” he explained. “They’ll expect us to do nothing, but we’re gonna keep everyone healthy through fall sports and continue to work. I don’t think we’ll take a step back. I expect us to go back-to-back this year, which is exciting.”

Monett’s 2019-2020 wrestling season will begin on December 5, when they will travel to wrestle against Branson High School.

During July and August, matching funds grant checks for rural fire departments were distributed by the Missouri Department of Conservation forestry division staff. One hundred sixty-eight fire departments received checks for up to \$4,000 each to help with the purchase of personal protective gear, communications equipment and wildfire suppression equipment to help increase the fire departments' capacity to suppress wildfires safely and efficiently.

The total matching funds awarded to Missouri fire departments through the matching funds grant program this year was \$386,639.14. Fire departments are required to match 50 percent of the funds which are provided by the Missouri Department of Conservation and the US Forest Service volunteer fire assistance program. Throughout the last 30 years, over \$8 million has been distributed to rural fire departments to help them increase the safety of their firefighters and provide them with better firefighting equipment.

MDC has new rules for deer carcasses in ongoing fight against CWD

Starting in 2020, the Missouri Department of Conservation (MDC) has added additional regulations to the Wildlife Code of Missouri as part of its ongoing efforts to slow the spread of the deadly deer disease called Chronic Wasting Disease (CWD). The new regulations change the requirements for transporting deer carcasses into Missouri and throughout the state and also add carcass-disposal requirements for meat processors and taxidermists.

The Missouri Conservation Commission initially approved the changes at its May meeting and gave final approval at its Aug. 23 meeting in Jefferson City. The changes will become effective Feb. 29, 2020.

CWD is a deadly disease in white-tailed deer and other members of the deer family, called cervids. The disease has no vaccine or cure and eventually kills all deer it infects. The infectious prions that cause CWD are most concentrated in the spines and heads of deer. Moving potentially infected deer carcasses out of the immediate areas where they were harvested and improperly disposing of them can spread the disease. MDC has established a CWD Management Zone consisting of counties in or near where CWD has been found. For more information on CWD, go online to www.mdc.mo.gov/cwd.

The new regulations, starting in 2020, will:

- Restrict transportation of whole cervid carcasses into the state;
- Allow for the importation of cervid heads with attached capes into Missouri if they are taken to a licensed taxidermist;
- Within the MDC CWD Management Zone, limit the transportation of whole cervid carcasses out of the

- county of harvest, except for whole carcasses being transported to a permitted taxidermist or meat processor within 48 hours;
- Within the MDC CWD Management Zone, allow the transportation of “low-risk” carcass parts out of the county of harvest, which includes meat that is cut and wrapped or boned out, quarters without the spinal column attached, antlers, and finished taxidermy products;
- Require meat processors and taxidermists to discard cervid carcass remains in a properly permitted landfill or waste transfer station; and
- Require that meat processors and taxidermists keep records of cervid carcass disposal.

MDC will provide the full regulations in the 2020 Wildlife Code of Missouri and in its 2020 “Fall Deer and Turkey Hunting Regula-

tions & Information” booklet, available where permits are sold starting in early July 2020.

“Most states with CWD have similar restrictions on carcass movement and disposal,” said MDC Resource Science Division Chief and deer biologist Jason Sumners. “CWD remains a rare disease in our state and we want to keep it that way!”

According to MDC, most deer hunters would not be affected by the proposed regulations and most meat processors and taxidermists are already properly disposing of deer carcasses.

“Our deer-hunter surveys and other research shows that more than 85% of deer hunters would NOT be affected by the new regulations because they already dispose of carcasses on or near the property where the deer was harvested, or already take their harvested deer to licensed meat processors and taxidermists,” Sumners explained.

SBA Economic Injury Disaster Loans available for small businesses

"SBA eligibility covers both the economic impacts on businesses dependent on farmers and ranchers that have suffered agricultural production losses caused by the disaster and businesses directly impacted by the disaster," Garfield said.

Small nonfarm businesses, small agricultural cooperatives, small businesses engaged in aquaculture and most private nonprofit organizations of any size may qualify for Economic Injury Disaster Loans of up to \$2 million to help meet financial obligations and operating expenses which could have been met had the disaster not occurred.

"Eligibility for these loans is based on the financial impact of the disaster only and not on any actual property damage. These loans have an interest rate of 4 percent for businesses and 2.75 percent for private nonprofit organizations, a maximum term of 30 years and are available to small businesses and most private nonprofits without the financial ability to offset the adverse impact without hardship," Garfield said.

By law, SBA makes Economic Injury Disaster Loans available when the U.S. Secretary of Agriculture designates an agricultural disaster. The Secretary declared this disaster on Aug. 7, 2019.

Businesses primarily engaged in farming or ranching are not eligible for SBA disaster assistance. Agricultural enterprises should contact the Farm Services Agency about the U.S. Department of Agriculture as-

sistance made available by the Secretary's declaration.

Applicants may apply online, receive additional disaster assistance information and download applications at <https://disasterloan.sba.gov/ela>. Applicants may also call SBA's Customer Service Center at (800) 659-2955 or email disastercustomerservice@sba.gov for more information on SBA disaster assistance. Individuals who are deaf or hard-of-hearing may call (800) 877-8339. Completed applications should be mailed to U.S. Small Business Administration, Processing and Disbursement Center, 14925 Kingsport Road, Fort Worth, TX 76155.

The deadline to apply for economic injury is April 7, 2020.

Newest Habitat for Humanity house nearing completion

In November 2018, the South Barry County chapter of Habitat for Humanity broke ground on its seventh house. Construction on the property, located on the corner of 8th Street and Oak Hill Drive in Cassville, moved along steadily with completion expected in October.

“We have the interior walls up, the roof is up, electrical is in and the bottom end of the plumbing is going in as we speak,” said David Hermann, president of the South Barry County chapter of Habitat. “We have the tub and the enclosure in, but we don’t have sinks in or anything in the kitchen yet. We don’t have any plumbing in through the house yet.”

Hermann said the construction is scheduled to resume once the builders acquire spray insulation, which will be used throughout the house to make it more energy efficient. The construction team will also soon begin the installation of a heating and air system.

“The walls are up. You can see where the rooms are going to be located and everything like that,” said Hermann. “Once we start to get the drywall in and start painting, that’s when I will go to Lowe’s and start looking at cabinets for the kitchen.”

According to Hermann, construction is tentatively set to be completed sometime in October.

“We’re getting really close,” explained Hermann. “We’re really excited about where we’re at and how things look.”

Once the drywall has been added to the interior walls of the house, Hermann plans on taking the home’s owner, Amanda Karaklajic, on a tour of the home to lay out her color preferences room by room.

At this point, Hermann plans on making a volunteer event out of the interior painting of the home. According to him, he has sought female volunteers from local businesses Freedom Bank, 1st State Bank and Barry Electric for what he calls a “Women’s Construction Day.”

On Women’s Construction Day, Hermann plans to have these female volunteers take on all of the interior painting in the home. For their efforts, participants will receive a commemorative t-shirt. No official date has been set for this event but will be made public once the drywall has been installed in the home.

Karaklajic, currently a resident of Boulder City, expressed immense joy at the prospect of the house nearing completion.

“The construction has been awesome. Those men have done so much. I never in my lifetime thought it would be happening to me,” said Karaklajic. “Every time I walk into that house, they’ve done more. Something is different and new.”

Hermann has also noticed Karaklajic’s joy while giving her tours of their construction.

“Every time she shows up, she bursts into tears,” said Hermann. “It’s like a dream come true for her I think. I’m really glad that we could do this for them because they really are so deserving. Having her see the progress and be part of it was instrumental.”

Karaklajic and her fiancé, Justin Weston, are both in dire need of housing of their own. Both currently live with Weston’s mother in Boulder City after no longer being able to stay in their previous home.

“It’s me and my fiancé, we’re both disabled. We heard about getting a home through Habitat, and we filled out an application,” said Karaklajic. “My family lives in Arkansas. We live with his mom right now. The house we were living in was literally falling apart in front of us.”

Karaklajic toured the home several times at various points of construction.

“The house is becoming so beautiful. They have done so much for us. I love it, it’s so beautiful,” said Karaklajic. “It’s amazing. I’m feeling a little overwhelmed by it all.”

Recently, the family was hit with yet another tragedy that made moving into their new home even more crucial than before.

“We’re ready to just move in and relax for a little bit,” said Karaklajic. “We had a flood out here a couple of weeks ago, and we lost a bunch of stuff. Everyone from Cassville, the churches, David [Hermann] and Denney [Ball, head builder on the home] have all been amazing.”

Karaklajic continued, “I want to thank everyone who’s been working on it. My heart, my soul and my prayers all go out to them.”
