## Cassville FFA charter member presented with jacket 77 years later

Over seven decades later, one of the original charter members of the Cassville Future Farmers of America got his very first FFA jacket. Four members of the Cassville FFA presented the jacket to Doyle Nickle, an original charter member of the FFA at the school when it began in January 1938.

On January 25, 1938, Doyle Nickle and 27 other Cassville High School agriculture students signed a charter to establish an FFA chapter at the school. By establishing the chapter at the school, the group has had the chance to grow over the years and the few students who wanted the club all of those years ago paved the way for kids today to have the opportunity to learn agriculture techniques and skills that will follow them throughout their lives.

In 77 years, the school's membership went from 28 members to 150.

When Nickle was pre-

sented with the jacket, the surprise obviously meant a lot to the man. Cassville FFA chapter president Parker Dunker gave a speech before officer Mattie Stephenson helped Nickle into his jacket. Dunker said, "The FFA has meant much to me in my four years of being a member. It has taught me much about agriculture, given me leadership qualities, opportunities to travel across our state and country, along with teaching me how to better advocate for agriculture."

Nickle was all smiles when he was given his jacket. Dunker continued, "Without your contribution to our community, our state and our nation, we would be unable to have some of the opportunities we do today."

When asked what it felt like to have his first official jacket, Nickle laughed and replied simply, "Unusual." Nickle was also presented with a football shirt from the school last year for his

contributions.

Even though Nickle was a member of the first FFA group, he did not pursue agriculture and served his country instead. He stated, "I didn't take up farming, I went into service. So, that took care of that." Nickle is a World War II, Korean War and Vietnam conflict veteran with the United States Army.

The plan to present Nickle with a jacket was a

collaborative effort between his son Bruce, Bruce's wife, Debra, and Debra's son Jordan Ellis, one of the FFA advisers at Cassville.

Debra said that the plan was originally to get Doyle an official jacket for Christmas since he'd never had one, but when Ellis started researching, he found that Nickle was a charter member and thought it would be a good opportunity for the students to meet a WWII

veteran and have a connection with that part of history for their chapter. The plan came together from there.

Nickle was raised in Cassville and graduated from Cassville High School in 1940 before enlisting. He and his wife, Trudy, have been married over 60 years.

Donning his new jacket, Nickle said, "It fits just fine."

## Aurora man arrested for assault over \$20

An Aurora man was arrested this week after an argument over \$20, according to an affidavit of probable cause by the Barry County Sheriff's Department. # Cassville Schools consider monument to replace sidewalks

Alumni members from Cassville High School (CHS) classes of 1922-1972 will be honored in a newly designed monument outside of the JC Duncan Gymnasium.

Traditionally, CHS has honored alumni members by stamping the names of every graduating student on the sidewalk. Senior sidewalks for the classes of 1922-1972 are

located outside of the JC Duncan Gymnasium; however, after years of weathering and foot traffic, many names are no longer legible due to deteriorating concrete.

In order to comply with the guidelines established within the American with Disabilities Act (ADA), Missouri Department of Transportation (MoDOT) will complete a side-

walk renovation project that will span the length from 5th Street to 17th Street. As a result of this renovation and the deteriorating sidewalk conditions, the senior sidewalks for the classes of 1922-1972 will be removed.

“Our senior sidewalks are important to us. We are committed to remembering our heritage and take great pride in preserving our history at Cassville Schools,” said Richard Asbill, Cassville R-IV Superintendent.

The school district has established a committee with CHS alumni, school board members and school staff to determine the details regarding the new monument that will replace the senior sidewalks for the classes of 1922-

1972.

“Our committee began meeting at the beginning of the year and we all agreed, without a doubt, we wanted to continue to honor our graduates,” stated Jill LeCompte, Assistant Superintendent. “While we hate to see the sidewalks removed, we also think our new monument will be a great addition to our school. The monument will be easy to read and will not deteriorate like many of our senior sidewalks have.”

The Senior Sidewalk Committee is currently evaluating several options for the monument.

“While we must be mindful of the expense associated with this project, we also want to create a nice area for alumni and community members to

enjoy,” stated Dusty Reid, Director of Facilities and Operations. “The sidewalks will be removed in the summer; however, we are still in the design phase for the monument. We don’t want to rush our decision and not be completely happy with the end result. The committee continues to evaluate several options and we plan to meet at the start of the New Year to finalize our plans.”

While the monument completion date has not been determined, MoDOT will complete sidewalk removal and renovations in the sum-

mer, before the start of the 2015-2016 school year.

Prior to the removal, the district plans to have the sidewalks photographed in order to document this piece of history. Photos will be displayed on campus.

## Preliminary November state deer harvest totals in

Preliminary data from the Missouri Department of Conservation (MDC) shows that deer hunters in Missouri harvested 189,938 deer during the November portion of fall firearms deer season, Nov. 14 through 24. Of the 189,938 deer harvested, 92,020 were antlered bucks, 21,256 were button bucks, and 76,662 were does. Top harvest counties were Texas with 4,544 deer checked, Howell with 4,046, and Franklin with 3,707.

Last year, hunters checked 166,383 deer during the 2014 November portion of firearms deer season with 78,556 being antlered bucks, 19,300 being button bucks, and

68,527 being does.

Barry County's numbers for the season were 837 antlered bucks, 159 button bucks and 556 does for a total of 1,552. The numbers were an increase from 2014's totals of 569 antlered bucks, 138 button bucks and 568 does, with the overall total 1,365.

"Good weather and plenty of deer activity likely are the reasons why there was an increase in deer harvest during the November portion of the firearms deer season this year," MDC Deer Biologist Jason Sumners said.

MDC reported five firearms-related hunting incidents during the fall firearms November portion.

The five incidents involved self-inflicted firearm wounds and occurred in Butler (2), Franklin, Newton, and Howard counties.

Deer hunting in Missouri continues with archery deer hunting from Nov. 25 through Jan. 15, firearms antlerless portion Nov. 25 through Dec. 6, firearms alternative methods portion Dec. 19-29, and firearms late youth portion Jan. 2-3. **HERMAN (SHERM) LEE STRINGER**

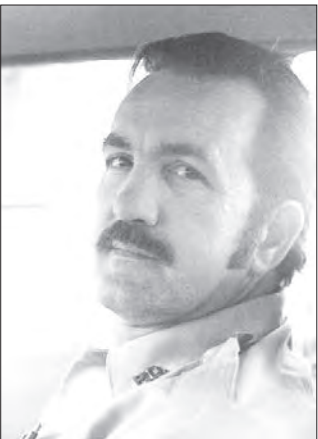

## BARRY COUNTY HEALTH DEPARTMENT CONTINUES WIC CONTRACT

The Barry County Health Department has continued its contract with the Missouri Department of Health and Senior Services to provide the WIC (Women, Infants and Children) Program for fiscal year October 1, 2015 thru September 30, 2016. The WIC Program serves pregnant women, breastfeeding women up to one year, non breastfeeding women for 6 month, as well as infants and children up to the age of 5. The contract is for \$236,324.00 which allow the department to serve an annual caseload of 17,244 participants. The contract includes \$30,530.00 which will be used exclusively for breastfeeding support. It will allow us to have a breastfeeding peer counselor two days a week in the Monett and Cassville offices to provide education and support. The WIC program also provides a food package to all participants monthly as well as offering appropriate referrals and nutrition education to all. To find out if you qualify for the WIC program you may contact the Barry County Health Department at 417-847-2114 or our satellite office in Monett, Monday thru Wednesday at 417-354-8402. The WIC program also conducts clinics in Seligman and Shell Knob area once a month. This institution is an Equal Opportunity Provider.

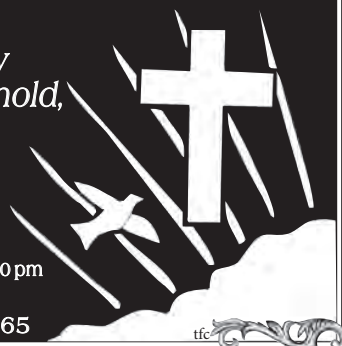

Kornerstone Teen Parent the Start program for their program hosted a Read from teen parents, Shell Knob pre-

school parents and Parents as Teachers program parents on November 12 at the Shell Knob School from 6 p.m. to 8 p.m. This program was sponsored by the Missouri Humanities Council and funded through private and corporate donations and the National Endowment for the Humanities. Rural districts in Missouri face special challenges as they recruit public school teachers. The local school workforce is well established and will experience significant retirement turnover trend as those teachers exit. Younger residents may be thinking about moving to larger cities for greater career and social opportunities if the local school district does not promote strong community engagement. Cassville R-IV, a rural district in southwest Missouri, has developed a homegrown effort to persuade its graduates to come back to the area to teach.

The effort begins in current classrooms. Teachers tell their students about the benefits of becoming educators in small districts, their own reasons for becoming teachers, and the opportunities that exist in the students' home town.

Several high school students are given the opportunity to shadow teachers and gain field experience. Some

Cassville teachers are also adjunct faculty members at Crowder Community College, where they encourage pre-education students to complete their education degrees at Missouri State University or Missouri Southern State University. The three- to five-year process includes substitute teaching, student-teaching placements and job interviews for teacher candidates.

"We have turned around the question of 'Why would I become a Cassville teacher?' to 'Why wouldn't you become a Cassville teacher?'" said Superintendent Richard Asbill. "One of the keys is having teachers who promote education as a career. Teaching is an honorable and important part of our society and future, and we need to build and grow those leaders now."

Superintendent Asbill says the district works with the teaching staff to establish competitive and higher salaries than many

surrounding districts, and the benefits are comparable with larger districts.

As a result of the district's efforts, 25 percent of Cassville teachers are district alumni. About half have 11 years or more experience, ranking Cassville among the top districts in southwest Missouri in teacher experience.

"Cassville is a great example to other districts that face challenges in recruiting fully qualified teachers," said Paul Katnik, assistant commissioner in the Office of Educator Quality. "Their approach is a complement to Missouri's plan to provide every child in the state with equitable access to the best teachers available."

Preparing, developing and supporting effective educators is one of the primary goals of Missouri's Top 10 by 20 initiative, an effort to rank among the top 10 states in education performance by 2020.

Southwest survives Diamond rally for 50-49 win

The Southwest Trojans led by 13 points in the final quarter, then survived a furious Diamond rally to claim a 50-49 Tipoff victory at Washburn on Tuesday, November 24. Southwest's Robbie Randall and Jacob Durossette scored 11 points each to lead a balanced attack.

The Trojans led at every quarter break with team speed and finesse overcoming Diamond's size advantage. An early parade to the free throw line helped Southwest claim a 13-4 lead midway through the opening period. The Trojans held that lead into the half, but big center Robbie Randall picked up his third personal foul with just seconds remaining.

The Southwest offense revolved around Randall. When the Trojans opened the third quarter with him planted on the pine, Rusty Roe had to wonder where his scoring would come from. Life lesson: when life hands you lemons, don't make lemonade. Find a good lawyer.

Senior forward Orion Lawyer scored with a trio of seemingly impossible interior shots against the bigger Diamond defense, and finished a three-point play from the line to push the Trojans to a 33-30 lead. Landon Wright and Randall followed with close range buckets, and point guard Devon Resz buried a long trey for a 40-30 lead at the 1:20 mark.

Resz finished the quarter strong, canning a running jumper against the Diamond

press, and then throwing in a money ball from the left sideline as the clock wound down. Southwest led by 45-35 at the final break.

A Randall basket in the paint and a Durossette trey pushed the lead to 50-37 with 5:37 left in the game. But Southwest would not score again in the contest. The Trojans had trouble executing their delay game and the Wildcats stormed back into the game. Shepherd sank a pair of free throws with 90 seconds left, and then followed his own miss to cut the lead to 50-49 with 28 seconds remaining.

The Trojans missed three free throws in the waning seconds, but Diamond could not convert. Southwest's Clay snared an offensive board as the clock ran out to preserve the one-point victory.

Ozark Turkey Scramble provides Thanksgiving Day race experience

After years of fighting the crush of humanity at the annual Springfield Turkey Trot, Josie and I switched our holiday racing schedule. Out with the trot, in with the scramble. The third annual Turkey Scramble in Ozark offered a chance for a run on the Findley River trail, and the options of either the 5K or 10K distances. The expected field of 250 runners was also a bonus.

Race director Chris Esick is not Ned Reynolds, but he is a veteran runner and coach and understands how to host a race.

The Turkey Scramble has a few door prizes and a costume contest, but the emphasis is on the race and especially the course. Runner safety is a high priority. The course is confined to sidewalks, parking lots, and trail surfaces. One mile of the 5K

loop sends runners onto the wooded trail just south of the Ozark Community Center. It is a challenging but interesting course.

Race management services including the chip timing system were provided by Ozark Racing Systems of Springfield.

In just its third year, the Turkey Scramble is still going through new race growth stages. Race shirt overages are recycled into the next year's event. Age groups are stretched into 10-year increments instead of the standard 5. To make up for fewer age-group awards, every runner receives a finisher's medal.

The race itself was a classic. Logan Bohannon, a hometown high school runner, won the 5K event in 17:05. Sharla Mathes, twin sister of Shannon Parsley, the former Exeter coach, won the women's 5K, running 22:47.

Josie Stubblefield, of Cassville, placed 2nd in the women's 50-59 division with her 27:00 effort.

In the 10K event, Springfield's Stephen Garcia owned the field, blazing to a 38:22 victory. Chelsea Jensinkwitt was the women's champion, running 44:06.

Courtney Beagle, of Cassville, won the women's 20-29 age group in 53:14. Beagle, who is more of a speed merchant and holds a Missouri state road race record at 2 miles, turned in a strong performance at the longer distance.

I had a good day, placing 5th overall and 2nd in the men's 50-59 group in 43:25. Troy Schleim of Monett, 8 years my junior, won the division in 43:11.

The weather cooperated for the event, with the feared torrential rain nowhere in sight. Unseasonably warm

temperatures contributed to the fast performances.

More and more communities are adopting Thanksgiving Day races as runners balk at driving great distances when they could spend that road time with family instead. The Turkey Scramble offers a nice alternative. For us diehard runners, it's just one more thing to be thankful for.

The WIC program also provides a food package to all participants monthly as well as offering appropriate referrals and nutrition education to all. ## Percolation Test training provided by Extension Center

Percolation Test Certification Training will be Friday and Saturday, December 11 and 12, at Johnson County Extension Center, in Warrensburg. This course is for individuals who want to obtain certification to conduct soil percolation tests for determining soil absorption qualities of sites being considered for installation of an on-site sewage system. Instructors for the two-day event will be David Lindell, retired University Extension Agronomy Specialist and John Tharp, retired University Extension Water Quality/Community Development Specialist.

The cost of the two-day course is \$160 per person. Each participant who completes the course will also need to provide a payment of \$90 to the Missouri Department of Health and Senior Services. This is in addition to the \$160 course fee to Johnson County Extension. Registration will be a minimum of 10 and a maximum of 25 participants per class and will be on a first-come, first-serve basis. Registration is due by Tuesday, December 1. We must receive the \$160 payment by registration deadline.

At the end of the training course, an exam will be given by the instructors and mailed

for grading by the Missouri Department of Health and Senior Services. DHSS certification cards will be mailed to those successfully completing the exam.

The training site is upstairs at the Johnson County Extension Office, 135 W. Market Street, Warrensburg, MO 64093. For more information, please phone (660) 747-3193.
