## Butterfield bust nets alleged dealers

Based on Statements of Probable Cause filed by Michael J. Larery with the Ozark Drug Enforcement Team (ODET), warrants were issued for the arrest of Christopher Lee Youngblood (37) and Terrie L. Dunbar Tunis (48), of Butterfield, for the alleged possession and intended distribution of fentanyl, and methamphetamine, and possession of marijuana.

On October 6, members of the Ozarks Drug Enforcement Team, with the assistance of Barry County deputies, served a search warrant at a property on West 5th in Butterfield, where, according to the probable cause statements, Dunbar Tunis and Youngblood were arrested in a small outbuilding that had been converted into living

quarters

According to a press release from ODET, detectives seized approximately 400 capsules of suspected fentanyl, 15 grams of suspected methamphetamine and 570 grams of marijuana at the residence.

According to Probable Cause statements, Young-blood denied living at the residence, and denied knowledge of the presence of illegal drugs. However, a search revealed a wallet with his name in it, as well as the alleged presence of what appeared to be - and tested positive for - illegal substances.

In a subsequent interview, according to the probable cause statements, Dunbar Tunis allegedly admitted to detectives that she had acquired the fentanyl in the St. Louis area, then transported it back to Barry County, where she supplied it to Youngblood in September for him to resell. Dunbar allegedly also sold it herself to numerous people for profit.

According to warrants filed in Barry County Circuit Court, both Youngblood and Dunbar Tunis are prior drug offenders. They are charged with Delivery of a Controlled Substance and Possession of

a Controlled Substance.

Dunbar Tunis is currently being held in the Barry County Jail on a \$150,000 cash-only bond.

Youngblood is held on a \$75,000 bond.

Bond hearings are scheduled for each of them in Barry County Circuit Court on October 14.

Commander Chad Allison, with the Ozark Drug Enforcement Team, says there has been an increase in overdose cases in the area.

"We are hoping (these arrests) will slow down the trend," he said.

## The Show: a beloved tradition returns to the Cassville stage

An annual tradition since 1993, *The Show* will return to Cassville October 21, 23 and 24, at 7:30 p.m., 7:30 p.m. and 2 p.m. on respective dates. It will be performed in the Cassville R-IV FEMA & Event Center next to the football field.

For nearly thirty years,

Greg Beck has entertained Cassville by assembling the greatest local musical talent for an annual concert every October. Due to COVID-19 precautions, *The Show* was cancelled in 2020. However, according to Beck, this only strengthened his confidence about this year's perfor-

"With two years of practice behind the band, we're ready to perform," he said.

The 35 vocalists featured in this year's *Show* will be performing under the umbrella of the theme, "American Classics: Past, Present and Future." Over thirty different artists will be covering hits from the 1950s up

through present day.

Beck had worked as a touring drummer for much of his life, but put it aside in favor of settling into the Cassville area. In 1991, though, after he and his wife Brenda finished building their home, Greg started to miss performing. So, with pencil and paper in hand, he and Brenda began recalling and writing the names of local musicians he'd performed with in the past, with the idea of forming a new band.

"The formation of a band evolved into the idea of attempting to put together some kind of concert," Brenda Beck said.

"Coincidentally, at about the same time, the Cassville Chamber had also been seeking to start some kind of annual concert," she continued.

According to Beck, from

the late 1950s into the early 1960s, Cassville had held the yearly *Jamboree*, a big country music show and cherished community event.

"The Chamber wanted to see something similar reinstated, so members approached Greg in 1992 and offered to sponsor the first concert."

In 1993, after a year of practice, *The Show* made its debut in the Cassville Middle School gym, sponsored by both the Chamber and the City of Cassville. Since then, the only year without a *Show* was 2020, when it was cancelled three days before the first performance was to take place.

"Greg Beck's primary goal was to incorporate and spotlight as much local talent as possible," said Jim Craig, trumpeter for the band.

"They'd follow rumors of good musicians and contact them."

"Singers are never turned

down; there are no try-outs," said Brenda Beck, who coruns *The Show*.

"We want to involve as many school age people as

many school-age people as possible from all over the county," she continued. "This year's performance will feature 11 local middle and high school vocalists."

According to Beck, if a

student performs exceptionally well in choir or a related activity, the teacher of that class will direct the Becks to that student, who will be offered a place in *The Show*.

Tickets for the October 2021 performance of *The Show* can be purchased in advance at the Cassville Cham-

## **Purdy City Council, Police Reports**

Mayor Brian Bowers signed an agreement to move Purdy into the second phase of repairing the city's sewer lines. Purdy has now entered year-two of a ten-year plan to repair and replace the city's sewer and water systems. Maintenance is planned to first be applied to areas in danger of leaking, followed by the city's less dilapidated pipes, eventually covering the entire city limits.

With great effort, Purdy's water efficiency has risen to 73 percent. According to Purdy Public Works Supervisor Lonnie Lowery, this speaks to incredible progress following the nearly undetectable million-gallon-a-month water leak that had plagued Purdy in recent months. Due to this leak, in August and September, the water efficiency percentage had plummeted as low as approximately 62 percent. However, Lowery expects that, by November,

to see a continuing trend of increased efficiency. "The goal is around 80 percent efficiency," said Lowery.


Both vehicles were insured and both drivers were wearing safety devices.



## Local authors release new book, signing Oct. 15

Local author Tom Koob has just released a new book. Co-authored with Curtis Copeland, Ozarks Hillbilly Stereotype and Reality researches the origins, development and usage of the "hillbilly" stereotype and image.

Koob says, "Curtis and I had a conversation about the inaccurate portrayals that are sometimes applied to Ozarkers. We wanted to present an alternate view based on personal stories of strong, successful characters from the past and present. Our discussion led to this book."

Koob and Copeland will have a book signing at the Barry County Museum on Friday, October 15, from 10 a.m. to noon, and at the Shell Knob Library, from 1 to 3 p.m. on the same day.

Ozarks Hillbilly traces the images of the mountain folk that some of the first chroniclers of the region wrote about. Outlanders like Henry Rowe Schoolcraft and George Featherstonhaugh toured the Ozarks in the early 1800s. They documented their travels and described



the people they encountered. Unfortunately, these accounts were often critical and judged the early settlers by an elite bias. Throughout much of the nineteenth century, Ozarks folk and mountain people in general were portrayed in a comic sense. Particularly, the Southwestern humorists penned stories that sometimes admitted the rugged skills and generosity of the Ozark folk, but more often made fun of them.

The advent of the twentieth century brought conflicting views of rural dwellers. There was a new, admiring respect in the Country Life Movement and in romanticized novels like Harold Bell Wright's Shepherd of the Hills. But at the same time, the mass media of newspapers, films, music, and live entertainment often presented inaccurate portraits. Some

of these portrayals were just silly, while others were outright insulting.

Ozarks Hillbilly presents all the various images that have lampooned Ozark people for the last two hundred years. Koob and Copeland present true life stories throughout the book that contradict these images. Bios of true Ozarkers, past and present, offer a much more praiseworthy depiction of what it took to live a good life in these rugged hills and hol-

Well researched, Koob and Copeland's book cites the writing of several Ozark historians. The book also includes many photographs and images that bring the book to life. Classic photos from the Vance Randolph Collection and the Townsend Godsey Collection reveal the strength and character of the Ozarks people.

Ozarks Hillbilly presents a refreshing analysis of the often maligned, misunderstood mountain folk of this region. With a balanced assessment, the book reveals how the term "hillbilly" has taken on dual meanings, based on the context of its use. The writers do a thorough job of presenting this dichotomous view and offer a more positive interpreta-

To make their book available and hear opinions about their subject matter, Koob and Copeland will have a book signing at the Barry County Museum on Friday, October 15 from 10 am. - 12 p.m., and at the Shell Knob Library from 1- 3 p.m. on October 15.





## Seneca pins 27-0 shutout on Cassville

The Seneca Indians roared to a 19-0 lead in a near-perfect first half, then cruised to a 27-0 victory over the Cassville Wildcats on the new turf at Tom Hodge Stadium. The Wildcats suffered their second shutout loss of the season, the first time that has happened since the 2014 campaign.

Coming into Friday night, the 2-4 Wildcats and the 3-3 Indians had two common opponents: Marshfield and Rogersville. Cassville went 0-2 against the Blue Jays and the Wildcats. Seneca beat

First year coach Cody Hilburn, a former Seneca player, saw his team dominate Cassville in that first half. Although the Wildcats held a slight size advantage in the line, the Indians appeared quicker and more aggressive. With senior quarterback Ethan Fritchey operating out of the Wildcat set most of the night, Seneca gashed the line again and again with traps and jet sweeps.

With a fired up home crowd serenading the players with the tomahawk chop chant, the Indians set the

tone for this game on their very first possession. Eighty yards. Fifteen plays. Seven minutes off the clock. Fritchey ran off right tackle into the end zone from five yards out to finish the drive and give Seneca a 6-0 lead. It was all the points the Indians would need.

Jackson Graham racked up 153 yards on 15 carries to lead the Indians. His 56-yard sprint down the Seneca sideline on a one-play drive gave the Indians a 12-0 lead with 3:25 left in the first quarter.

It was a tough first half for Cassville. The Wildcats never crossed midfield, with their own 38-yard line their best field position for two quarters. Even Custer and the Seventh Cavalry managed to get into Indian Territory.

Cassville sputtered to just two first downs in the first half, one of them by penalty. That flag gave the Wildcats a new set of downs at their own 32-yard line late in the second quarter. But Dane Napier intercepted a Cutter Hicks pass and returned it to the Cassville 25-yard line. Two plays later, Fritchey tossed a rainbow to Conner Ackerson in the back of the end zone to put Seneca ahead at halftime, 19-0.

The Cassville defense played a much stronger second half, holding Seneca on downs twice and forcing a punt. But Jackson Marrs escaped for a 33-yard touchdown run on the first play of the fourth quarter to give Seneca a 27-0 lead.

The Cassville offense simply looked out of sync in this game, a stark contrast to the efficient machine that raced up and down the field against Monett. Even though Cassville's defense blunted the Seneca attack for most of the second half, the Wildcats were unable to sustain drives and managed just one first down in that half.

After the Wildcats were forced to punt with 7:54 remaining in the game, the Seneca JV offense came on and ran out the clock with a 13-play drive that reached the Cassville 13-yard line. After completing two fourth

down passes to keep the drive alive, sophomore quarterback Gavyn Hoover took a knee as the final seconds ticked off.

The stats disparity was brutal. Seneca rushed for 323 yards and threw for 106 more in a 429-yard performance. Cassville was held to just 98 yards of total offense. Jake Anthonysz gained just 57 yards on 16 attempts. Hicks completed one of his sixteen throws and was intercepted once.

Seneca improved to 4-3 with the victory, while Cassville slipped to 2-5. The Wildcats return home to host the one-win East Newton Patriots on Friday night. Kickoff is set for 7 PM.

## Cassville man flees scene of crash







venture by his cousin, Chelsea Hinds.

Swearingen's aunt and Hinds's mother, Teresa Addison, died from complications of COVID-19 in August. As a way of remembering Addison's gift of making people feel loved and cared for, Swearingen and Hinds named the foundation in her honor.

"My Mom was one in a million," said Hinds. "She loved big-time and you could feel that (love) whenever she was in the room. She always put others before herself and would give you the shirt off her back."

Fundraising efforts for the T. Addison Foundation are just getting underway, but a busy October is planned, Swearingen says.
