

America’s Muralist commemorates late Cassville attorney, Emory Melton

The double-themed mural, shown above, was recently completed by Raine Clotfelter, “America’s Muralist,” on two walls of The Barry County Advertiser’s offices in Cassville.

Raine Clotfelter, “America’s Muralist,” is busy preserving the history of small towns across America. His latest work is in Cassville, painted in Benjamin Moore acrylic on two exterior walls of The Barry County Advertiser and Litho Printer offices at 201 9th Street. Muralized on one wall is a bucolic scene

at Roaring River State Park; the other wall depicts the Barry County courthouse with beloved attorney and past state senator, Emory Melton, emerging in sharp relief from the background. The idea for the exterior murals was the culmination of the ongoing remodeling of the interior office spaces,

which included moving the front entrance from the lower level on West Street, to the upper level which faces 9th Street, directly north of the

post office.

An almost \$2 million renovation project - over two years in the works, - was officially deemed complete at a special ribbon-cutting ceremony at Roaring River State Park Friday, March 26.

The event was attended by Missouri Department of Conservation (MDC) and Missouri State Parks officials, Missouri State Senator

McBroom named CEO of Barry Electric

The Barry Electric Co-operative Board of Directors announced today, the promotion of Jennifer McBroom to CEO/General Manager of the Co-op. Ms. McBroom is only the 5th manager in the 75-year history of Barry Electric Co-operative and was chosen after a nationwide search that yielded over 50 applications. From that applicant pool, the board winnowed the choices down to a few to interview in person or via video conference.

Dr. David Cupps, president of board said, “Ms. McBroom was chosen because of her record of leadership as interim CEO, in addition the board is convinced that she shares their vision for Barry Electric going into the future.” Ms. McBroom served as Barry Electric’s CFO for the last 5 years

Purdy Americorp reading program unique in SW Missouri

The Americorp reading program, which offers one-on-one coaching to elementary students struggling to master reading skills, has proven to be a boon to both teachers and students in the Purdy R-II School District since its inception in 1999.

Often called the “Stateside Peace Corps,” Americorp is a federal program which provides a monthly living stipend to volunteers in a variety of fields. In the Purdy School District, that field happens to be helping children in grades Kindergarten through Fifth become better readers.

Purdy is one of the only school districts in southwest Missouri who host Americorps volunteers.

Raynel Schallert, of Purdy, the original director for the program, said it began with then elementary principal,

Patty Laney, who passed away unexpectedly in 2013.

“Patty was passionate about teaching children to read,” said Schallert.

After obtaining a green light from the school board, a grant request for Americorp was written and later approved.

“Initially, we began with five volunteers,” Schallert said.

That number has since changed. Current director, Renae Neill, who has been in the position for 15 years, says the district currently has ten part-time volunteers who draw a monthly stipend designed to help defray their living expenses. Additionally, volunteers receive an annual education award of about \$3,100 per each term of their annual contract, which can be renewed up to four times.

Current Purdy Elementary teacher, Julie Dalton, began her career with the Purdy district as an Americorp volunteer, where, she says, the program changed the course of not only her life, but the lives of the students who received the one-on-one attention.

“We had one student in particular who was struggling with her reading skills when I was a coach,” Dalton said. “That young lady is now an A+ student in high school and has become an Americorp coach herself.

“This program makes a difference,” she continued.

After serving as an Americorp volunteer, Dalton used her education award toward obtaining a Master’s Degree in Education.

Education awards can be used in multiple ways. They can be used to further a volunteer’s education, pay off student debt, or, if the volunteer is over age 55, it can be given to another individual to be used for *their* education.

There are currently five openings in the Purdy School District for Americorps volunteers for the 2021-2022 school year.

Applications will be accepted through April 5.

Cox Monett launches veteran program

Veterans Honor Program recognizes those who have served honoring military veterans for their service is a part of CoxHealth’s culture, and the health system is expanding the recognition it provides with a new Veterans Honor Program.

The program launched systemwide in recent days, standardizing the ways patients who have served in the United States Armed Forces are recognized.

“This opportunity to create a unique program for our veterans in the populations we serve is a huge win for our communities and for CoxHealth,” says Kerry Miller, volunteer services coordinator and member of the Veterans Honor Program Committee. “Through a team effort, this program is now a reality.”

CoxHealth has had veterans’ recognition in place at campuses like Cox Branson and Cox Barton County and through its Palliative Care Departments. The Veterans Honor Program builds on those efforts and provides standardized recognition across the system.

Patients who are veterans

or active duty military members will be identified during the registration process at CoxHealth hospitals.

If they choose, veterans will receive:

- A thank you card, signed by a key hospital leader at the campus where they are a patient.
- An American flag door magnet.
- A special food tray liner at breakfast.

The CoxHealth Foundation is working to secure sponsors to assist with the costs of expanding the program systemwide. The Veterans Honor Program Committee is currently working on the next phase of the program: a Final Salute for veterans who pass away at CoxHealth hospitals.

In the Final Salute, staff members will line the hall as the patient is moved from the unit, similar to the Path of Honor ceremony provided for organ donors. Veterans will be draped with a ceremonial American flag for the salute.

Last week, representatives from Congressman Billy Long’s office delivered four 5’x8’ American flags for the

Final Salute. In total, CoxHealth has five ceremonial flags at south, three at Branson and one each in Monett and Barton County for the salutes.

The committee plans to begin Final Salutes in the coming months. The committee includes members from Si3, the Office of Patient Experience, CoxHealth Foundation, Nursing Administration, Centralized Transport, Food Services and more. Staff and leaders from all campuses, including Branson, Monett and Barton County, came together to make the program possible.

For the entire group, the program’s launch is a point of pride. “Prior to COVID-19, (President and CEO) Steve Edwards reached out to us to create a systemwide program that would honor each veteran, with the Final Salute being the ultimate honor,” Miller says. “As a military veteran myself, I am grateful CoxHealth is leading the way to honor those who have served. It is truly an honor to be part of the Veteran Honor Program here at CoxHealth.”

Governor Parson Signs Executive Order Extending State of Emergency

Today, Governor Mike Parson signed Executive Order 21-07 extending the state of emergency in Missouri through August 31, 2021, to help accelerate COVID-19 recovery.

“For over a year now, we have worked nonstop to take a balanced approach, fight COVID-19, and keep Missourians as safe as possible,” Governor Parson said. “We have made incredible progress in a short amount of time, and we must continue doing all that we can to support Missouri citizens, business, and communities throughout the recovery process.”

The state of emergency extension will allow the state continued flexibility in providing resources and easing regulatory burdens to further assist Missouri’s COVID-19 recovery efforts. This also allows for continued utilization of the Missouri National Guard and federal funding for COVID-19 response efforts.

Governor Parson initially declared a state of emergency on March 13, 2020, with the signing of Executive Order 20-02. Since that time, nearly 600 state statutes and regulations have been waived or suspended to increase efficiency and effectiveness in responding to COVID-19.

Executive Order 21-07 keeps many of the previous measures in place, including those related to telemedicine, motor carrier limitations, the sale of unprepared foods by restaurants, and remote notary access for certain legal documents such as estate planning.

Over 200 waivers are currently in the rescission process as the state continues to recover and the need for certain waivers diminishes. However, the Governor’s Office will continue to work with state agencies to identify regulations that can be permanently eliminated or streamlined moving forward.

Because painting murals as a way of preserving history is Clotfelter’s passion, Tricia encouraged him to follow that dream after his retirement.

“So far, I’ve painted about 170 pieces. About 60 percent of them are murals,” Clotfelter said.

Clotfelter said he’s currently booked through November of this year. Nearby Aurora is next on his list, where a mural will be painted on a dentist’s office with the assistance of high school art students.

A formal mural dedication ceremony to honor Emory Melton is being planned for later in the spring at The Barry County Advertiser.

Clotfelter said a total of 14 working days were put into the creation of the mural, which had to be carefully planned around the weather. The design was sketched in mostly by hand, except for the more detailed portrait of Emory Melton and the state seal behind him. For those, a projected image was cast on the building and used as a guide for sketching.

A Cassville High School art student and employee of The Barry County Advertiser, Adrienne Quiros-Zucca, was given the opportunity by Clotfelter to paint the face of Emory Melton into the mural, an invitation she promptly accepted.

Clotfelter used about eight gallons of paint in mostly primary colors for the mural.

“I mix a lot of the colors myself,” he said, “starting with the primaries.”

Clotfelter, who lives in Branson with his wife Tricia, had no formal art training before joining the U.S. Navy and emerging with a career in graphic design and art.

where she gained invaluable knowledge of the Barry Electric business model.

“The selection process was unhurried and deliberate. The board was able take time in making this choice thanks, in no small part, to Bill Shiveley.” Mr. Shiveley served as a part-time consultant to the board during the interim between managers. McBroom joined Barry Electric Cooperative in 2016 as the Chief Financial Officer. Prior to joining the cooperative, she spent 18 years in the banking industry – spending most of her career serving in community banks as the credit officer for commercial loan portfolios. “I am fortunate to have been able to bring my financial background to the electric cooperative industry, and it has been a privilege to serve as the CFO of Barry Electric

for the past 5 years. Being named CEO and General Manager of such a great organization is an honor and I am look forward to leading our employees as we continue to provide safe, reliable, and affordable electric and fiber services to our membership,” McBroom said. Ms. McBroom expressed sincere appreciation of the board and Mr. Shiveley for their continued support.

McBroom received her Bachelor of Business Administration and Finance from Austin Peay State University in Clarksville, Tennessee where she graduated with honors. She and her husband of 20 years, Tony, have resided in Barry County for the last seven years, with their two children, Estin (17) and Aiden (13).

Dear Editor,

Allowing Weapons on Public Transit Raises Concerns

OATS Transit is closely watching proposed state legislation that, if passed, would allow concealed-carry permit holders to lawfully bring firearms on public transportation. It raises serious concerns not only for the safety on our buses but also our funding as a private, non-profit transportation provider.

According to the Missouri Public Transit Association, there is no evidence that allowing concealed-carry permit holders to have firearms on transit improves safety and security. The close-quarter transit environment is absolutely unique. There is an unacceptable risk that someone could be harmed if a gun is fired or discharged accidentally on transit vehicles. I cannot recall an issue on one of our buses that would have been resolved with a firearm.

Beyond the safety issue, this also poses a major fiscal concern. Because OATS Transit receives federal funding through MoDOT for general public service, we would have to adhere to this new law. Yet, the majority of our users are individuals with physical, intellectual & developmental disabilities, and senior citizens. Most of these individuals ride under funding grants that expressly prohibit firearms on our buses including the state's own regulations for transportation

service for these individuals.

We use many of these private contracts to match federal, general public funds. If this legislation passes and we are required to allow firearms on our vehicles, this would jeopardize our private contracts. If we lose them, the local match required for the federal funds would be reduced thereby decreasing our entire operating budget.

This is a complicated issue that could have unintended consequences and I urge legislators to think this through more carefully.

In August, the people of Missouri voted for Medicaid expansion. Last week, Republican legislators initiated an attempt to overthrow the expansion citizens had voted for.

Governor Parsons allocated the necessary funds to make the expansion happen in his state budget proposal. The money was set aside; the House Budget Committee Chairman took it out. No funding equals no expansion.

The reasoning for stopping the funding for expansion was the conservative prediction that Missouri's share of the cost could increase over time and cause financial disaster for the state.

The state reps in the budget committee who blocked the funding for expansion say that a single, able-bodied person can work full-time at a minimum wage job and cover all their own expenses including health care. They shouldn't need state assistance. Instead, the money intended for expansion should be reallocated to help the most vulnerable, the elderly. They claim Missouri's Medicaid program - Mo HealthNet - can barely cover who it covers now: the disabled, the elderly, children, and pregnant women. Previously in the public debate over expansion, one Republican official even declared that now - during a pandemic - is not the time to expand Medicaid.

The conservative prediction that expansion will cause financial disaster for the state has been countered with evidence showing that just

the opposite will result from expansion. Financial studies and statistics from states already taking advantage of Medicaid expansion indicate the influx of federal funding and a careful plan will bolster struggling rural hospitals in Missouri, reduce medical debt and bankruptcies, provide more healthcare jobs, reduce disease related deaths, reduce avoidable emergency medical treatment, reduce job insecurity for folks with untreated health issues, and even create a budget savings - making more funds available for other priorities such as education and infrastructure.

Almost every healthcare organization in Missouri is in support of Medicaid expansion. A spokesperson for Cox regional hospitals in SW Missouri expressed confidence that expansion will happen because the people voted for it and it is part of our constitution.

"... we know that expanding Medicaid will bring federal tax dollars back to our state that will be more than sufficient to pay for the program. Most importantly, this program will save lives," Cox representatives said in a recent statement.

Last week, I wrote about the hearings for House Bills 557 & 560 where individuals gave testimony of abuse they endured in unregulated reform schools in Missouri. Physical, emotional, and mental pain will be with them for the rest of their lives. What are their options in Missouri without Medicaid expansion? The process of obtaining disability status is notoriously difficult, arduous and lengthy - taking as long as years. Maybe the stigma of a disability label isn't what they need.

People with mental/emotional health issues are often left at the fringes of society and sometimes - inappropriately - end up in jail. Maybe what they need is to be able

to work part-time for one of the many employers who do not offer health insurance, or the ability to work odd jobs, or run a small home business. That way they can still have the dignity of contributing to society, paying for their own needs, AND getting the mental and physical health care they so desperately need through enrollment in Medicaid without the stigma of a disability. As it is, so many struggle daily knowing help is there but is out of reach because they do not have the funds to pay for it.

Missouri's constitution demands a balanced budget, but the hundreds of thousands of Missourians living between 20 percent and 133 percent of the federal poverty level do not have the luxury of a balanced budget. They live paycheck to paycheck and every unexpected expense like an emergency room bill - for something like a busted eardrum - adds to their growing debt. That E.R. visit could have been avoided if they had coverage for a doctor visit to stop the infection before it became an emergency.

The least we can do is take care of *all* of Missouri's most vulnerable by expanding Medicaid. And maybe we can do more. Maybe we can show respect and compassion for those who struggle every day with mental/emotional health issues and those who never have enough to balance their own budget.

The Chairman of the house budget committee was given kudos for blocking the expansion funding. He was praised by fellow conservatives for his commitment to fiscal responsibility and a balanced budget.

Low-income Missourians probably will not be celebrating Missouri's balanced budget if Medicaid expansion is not included. They will be

Dear Editor,
Well, it has become obvious that the city of Cassville has decided to have another "crash course" in flood insurance. But after reading the article in last week's Advertiser, I am amazed that Walensky even considered this plan as

being worthy of discussion. But I greatly fear that based on their previous record, no one on the city council will be willing to put a stop to this.
According to the article, all houses now in the floodway would be eligible for this over priced insurance policy, but once their dwelling needed any serious repairs, it would have to be elevated out of the floodway. As per the article, "existing structures in the floodway will be grandfathered in to receive coverage. However, if there is a need to rebuild damaged structures in the floodway, they would have to be built according to FEMA specifications, whether the damage is caused by flood, tornado, fire or any other force."
So let's take a closer look at this. If Cassville gets hit by a serious hailstorm, and this

storm leaves behind damaged roofs and broken windows, the owner must make the house compliant with FEMA standards before they can address these repairs? If a water line ruptures in a house, and does significant damage, can it be repaired without making it compliant with FEMA regulations? If the neighbor is burning leaves and the fire gets out of hand and melts the vinyl siding on your house, can you put new siding on that house without making it FEMA compliant? What I'm asking is, at what point does repairing significant damage become "reguilding"?
The real irony here is the fact that the worst flooding Cassville has experienced in the last 20 years was compounded by the city failing to keep the brush cleaned out of the drainage ditches that run east from Fair Street to Flat Creek. This made the water levels much higher between Main and the creek.
Right after this occurred, I found evidence that proved that the city owned

this drainage ditch. I took this proof to the city council and told them that since the ditch belonged to the city, they needed to clean it out in order to speed up the flow of flood water going into Flat Creek. Everyone there, including Walensky, sat there silently and never spoke a word. Every time I ran into Walensky after that, I confronted him about this, and his response was always something like "you can't prove it belongs to the city", or "you can't prove it's our responsibility". Eventually, after waiting two years, I hired an attorney and instructed him to file suit against the city. The following week the city cleaned the brush out of the drainage ditch.
If we, as citizens, don't stop the irresponsibility that is so commonly reflected by our city government, we will eventually lose control of everything we have, just to accommodate the funding of the "Walensky Toy Chest".

Barry County Back Roads

The way of tears, death . . . and a gypsy

I once heard a preacher say from the pulpit that it's a sin to leave the place where one has been planted. It gave me pause for consideration. Was he suggesting a person would be hell-bound if they left the place of their birth? I wondered. If so, I'd been doomed long ago by my parents' decision to leave the urban clutter of Des Moines for the bewitching serenity of southwest Missouri when I was 12 years old. It was a place my brother and I quickly adapted to.

Among rugged hills, beside pristine (more or less) waters, and in the schools and churches we attended, we learned the ways of the Ozark natives who adopted

us, molded us into their likeness and called us friends. Beautiful people, they are. Numbered among them, now, are our children and grandchildren. If this was sinning, we were in deep.

Over the last couple of years, I've actually considered following in the roving gypsy footsteps of my parents, packing my bags and setting out for parts unknown, at least unknown to many of *you*. Not too far, really, just to southeast Iowa to dig into the history of my Swedish and Irish immigrant ancestors.

But just when I think I'm ready to take the bold step, I discover how firmly my roots are now grounded in the rocky southwest Missouri hills.

In January of 2020, with courage bolstered to venture forth - as soon as the spring thaw arrived, that is - I decided that I'd better learn as much about Barry County's history as I possibly could before I left it. When I did, I opened a veritable treasure trove. The first thing I learned is that I knew virtually *nothing* of Barry County's history - in spite of the fact that I'd

lived in it for almost 48 years.

Why didn't I learn about local history in local schools? I wondered. I learned plenty of national history, and even some world history, but right here where I've lived, what history I'd learned was mostly from Murray Bishoff, semi-retired reporter for The Monett Times.

My second discovery was the colorful nature of Barry County's Civil War history, with McDowell, Cassville and Washburn the focal points because of their positions along the road traveled by troops between Spring-

field and Fayetteville, Arkansas.

Commonly known during the war as the Old Wire Road because it was used for sending telegraphs, the route was also the one used when our government drove Native American people westward from their homelands to reservations in Oklahoma, known then as "Indian Territory."

The road was also used by the Butterfield Stage Line for a few years prior to the Civil War. Three of its original stops were made in Barry County at Smith, Crouch and

Harbin Stations. For intrepid back road explorers, markers are in place at the former two, although the exact location of the third one has been lost to time. After the war, the Butterfield Stage Line was reopened and additional stops were added.

Beginning over a year ago, my goal has been to retrace the entire Old Wire Road's route through Barry County. I believe I've been successful.

Saturday marked the culmination of my efforts, with the discovery of the last bit of road which leaves Barry County to the south and continues into Pea Ridge National Military Park in Arkansas.

Does this mean I'm free to leave Barry County now? Maybe so. But do I really want to leave it now? Maybe not.

Whether started from seed or transferred as a seedling, how *does* one leave the place where one has been planted? I wouldn't call it a sin, exactly, but I'd certainly call it *painful*, and, sometimes, self-inflicted pain is a greater sin than *moving* would be, if one labels such things.

After Saturday's exhilarating (yet mind-clearing) adventure chasing off down Ozark gravel roads with my daughter and granddaughter in tow, I feel kind of sorry for those who don't live in southwest Missouri. Even though the temptation to pack my bags and run comes over me occasionally (normal for anyone with gypsy blood, I suspect), I'm thrilled to live in an area where there's so much interesting terrain and history waiting to be discovered.

Yes, it's dark history - and some might say best left buried - but, without education, no forewarning of its repetition will be recognized, a repetition that the writer of Ecclesiastes deems a certainty of the human condition.

I suspect there's no history as enthralling as Ozarks history in southeast Iowa.

Or maybe there *is* and I'm just not brave enough to look for it.

Then, one must question whether my *fear* is the greatest sin of all.

To clarify, since my interest in Barry County history has been sparked, the Barry County Museum and its employees have provided me with a wealth of information. They represent yet one more educational treasure trove we have at our disposal in Barry County. I'm extremely grateful for all the help they have given me.

With 38 years of experience under his belt as a John Deere parts and products salesman, Bruce Doss, of Sarcoxie, continues supplying parts for all makes and models of agricultural equipment, but now from a different location.

After Larson Farm & Lawn closed its doors in Freistatt a couple of years ago, Doss knew a vacuum had been left behind for the many farmers and ranchers in the area who depended on the store as a source for the products they needed to keep their farm equipment running efficiently.

“My son-in-law, Kevin

McBlair, had a vacant shop building sitting on his property - one he'd used temporarily for his machining business before he relocated it to Monett - so he and I put our heads together to think about what we could use the empty building for,” Doss said.

“With my background in parts sales for ag equipment, the answer seemed obvious,” Doss said, “so we stocked the building with a variety of parts for haying, tillage, tractors, baling equipment and lawn mowers. We opened for business in May, 2019. I serve as the full-time manager for the store.”

Because of its rural location - although not far off

the beaten path - Doss said he's depended a lot on word of mouth (so far) to get the news of his store out to area farmers.

“With lawn-mowing and haying season coming on, though,” Doss said, “it's important for people to know we are here.”

“Until we opened this store, a lot of farmers and ranchers were driving 60 or 70 miles for parts for their equipment,” he continued. “We're trying to save people from having to make that drive.”

Doss added that, although the store keeps regular business hours, he's available by telephone evenings and weekends to help a farmer with downed equipment in any way he can.

“It's their livelihood,” he said. “We're in business to help *their* business - to keep them running without downtime.”

Doss said one of his favorite things to do is to track down hard-to-find parts for agriculture equipment.

“I can't guarantee that we'll be able to find the part someone's looking for,” he said, “but we'll certainly investigate and *try* to find it.”

Doss said KM Tractor Works is an A&I Products

dealer, and a Sunbelt parts dealer for lawn and garden equipment. They also carry hydraulic hoses, roller chain, oils and lubes, replacement bale spikes, baler belts, lawn and garden belts, Sunbelt lawn mower blades, and a well-stocked supply of nuts, bolts, and other parts too numerous to mention.

“We also have Sitrex hay rake parts, Martin-Till row units and parts for field sprayers,” Doss said.

“If we don't have it in stock, we can order it for you,” he added.

Doss said that, although KM Tractor Works can order most parts, they do not service equipment.

Wild horses, burros to be offered for adoption or sale

BY APPOINTMENT ONLY

Wild horses and burros from public rangelands in Western states will be available for adoption or sale at an event managed by the Bureau of Land Management (BLM), on April 16-17, 2021, at the Civil War Arena, 11838 Civil War Road, Carthage, Missouri.

This free event is **by appointment only**, from 8 a.m. - 5 p.m. CST on Friday, April 16, in one-hour increments (five appointments per hour) and from 8 a.m. - 1 p.m. CST on Saturday, April 17, in one-hour increments (five appointments per hour).

For appointments, please email BLM_ES_NSDO_WHB@blm.gov with your top three preferred time slots prior to the event. Come and adopt or learn more about the program.

It is unknown how many horses or burros may be available at this event; however, the animals available will be for adoption or sale.

Prospective adopters/buyers must be at least 18 years

old and able to provide access to feed, water, and adequate shelter. The basic adoption flat fee is \$25 for any animal at the event. Title to the animal will be awarded to the adopter at the end of one year if all conditions of the adoption agreement have been met.
