## Local Veteran Kids' Camp gets helping hand

When the Hovlands spoke of beginning a camp for at-risk kids, it was just a dream for years. However, after COL (Retired) Michele Hovland retired in August 2012, she and husband CW3 (Retired) Darrell Hovland decided to make their kids' camp a reality.

Already having the land nestled around beautiful Flat Creek in Jenkins, the next phase became how and to whom the camp would benefit.

Kids of Our Heroes Adventure Camp is slated to begin in full-swing the summer of 2014. Each week-long session will focus on a different group of kids (ages 11-17) and their struggles. One camp will be for the children of military vets who lost their lives in service. Another will be for kids who lost a sibling in service. The third camp will be for kids living with a severely wounded veteran.

Darrell stated, "Michele had wanted to do something like this for a long time. Being in the military, we went to too many memorial services with kids sitting in the front row, scared and lost.

So we thought, why not do something for our gold star kids?" Gold star children are the surviving children of fallen U.S. military heroes.

From there, the Hovlands went out and formed a board of veterans, almost all combat vets, filed for non-profit status, and went to work. For months, Darrell frequented Lowe's in Monett's professional services' counter to purchase materials to make their wilderness camp dream a reality.

After his frequent visits, Kathy Stepp, a Lowe's employee, asked what he was building. Darrell explained their dream of a camp for kids of fallen veterans. From there, Stepp introduced Darrell to the Lowe's manager Brad Huskey to tell him about their project.

Each year, Lowe's stores choose a charitable project locally to help out on. This year, the Lowe's employees chose Kids of our Heroes to donate their materials and time to.

During the summer of 2013, the camp had a dry run to test their facilities and see what improvements needed to be made before the camp

was opened up for real. It became apparent that the tents got extremely hot in the sunshine and platforms needed to be built in the treeline to provide more circulation and also a break from the blaring sun in the field.

The first platform's materials were provided by the Eagles of Cape Fair. The second platform's \$2,000 worth of materials were provided by Lowe's. On Saturday, November 2, both groups went out to the Hovland's creek-

front property to build the platforms for the camp.

Huskey, when asked why their store chose this project, replied, "What they do in the summertime is an amazing thing. I met with [Darrell] and this being an actual building project was right up our alley."

The Eagles had six people come out and volunteer to build the 20 x 20 foot platform. Lowe's had 12 employees and family members make the drive to build the

second platform on their day off.

Huskey went on to state, "All of this volunteering is on their day off. It is a day of giving back on their own time." The employees agreed that it was well worth their effort because of the cause it supports.

With this phase of the project completed, it gets the camp one step closer to being ready for the children

## Without 911 address signs, safety questionable

Many changes have come about for the Eagle Rock-Golden-Mano Fire Department with the introduction of a new 911 address system. The department has switched to a much more reliable system, but this introduced many changes not only to the fire department, but to residents of the three towns.

"The old system wasn't as reliable. We accessed the information from the lo-

cal video store that was only open from 8 a.m. until 5 p.m., Monday through Friday," stated Assistant Chief Pamela Stilwell.

When an emergency would be called in, the resident would give their address, and the owner of the video store would then key in their address to find the corresponding fire number place cards. Once the fire

## Wheaton Fire levy passes 118 to 84

On Tuesday, November 5, voters approved the Wheaton Fire Protection District levy and elected five directors for the department. The approved levy was for 30 cents per \$100 assessed.

"We are thrilled it passed so we can try to give people a better fire department," stated Bob Lombard, Fire Chief of Wheaton. "We are also trying to work towards a better ISO rating to assist with lower home and farm owner insurance," Lombard added on. This will also go toward fire fighting equipment. The levy passed 118-84.

The Wheaton Fire Dept. Board was decided including results from McDonald and Newton counties. Dwayne Pettengill received 132 votes for a six-year term. Larry Pre-witt and Nolan G. McNeill II will serve four years with 130 and 127 votes respectively.

Randall L. Wallace, 125 votes, and Steve E. Williams, 114 votes, will be serving two years each.

## BC Collector mails out over 40,000 tax statements

Barry County Collector Janice Varner mailed out over 40,000 tax statements to Barry County residents on Monday, November 4.

Each year, tax statements are mailed out in early November to give residents time to make arrangements to pay their balance by the end of 2013.

This year, taxes to be collected in the county is \$21,124,799.14, an in-

crease of \$565,969.03 from 2012. Real estate taxes account for \$15,273,281.77, \$5,051,395.78 from personal property, and \$800,121.59 from railroad and utilities.

Statements mailed out totaled 42,110, an increase of 107 statements from 2012.

Varner stated that if you are a Barry County taxpayer, and you have not received your tax statements by No-

For the residents at Red Rose Health and Rehab, kissing pigs is a very good thing. The facility is hosting a fundraiser where different staff members will have to

The fundraiser is running to raise money for the activities department at the center. Each year, the activity direc-

tor, Terri Desrochers, plans games like bingo, outings and more for the residents to keep them entertained throughout the year.  
This year, Desrochers took the group to the circus in Springfield, the Ozark Empire Fair and to a Springfield Cardinals game where they sat in the Red Roost and were given all of the food and drinks they desired. number was found, emergency responders would be dispatched and would find the residents by locating the white fire number sign. The system was inefficient and is no longer used. If residents do not give their new 911 address and place signs up for their own protection, they will have less of a chance to be found.  
The fire number white place cards, beginning with G, E or M, are no longer in use, and residents who rely on these have a false sense of security. These signs can no longer aid in the response of emergency vehicles. Every resident has received a 911 address, and this must be posted at the top of each drive to ensure each house can be located in a timely matter. The lack of 911 address signs and ineffective placement is resulting in slower response times and concerned residents.  
"Signs are being put on mailboxes that aren't right next to a house. If you live down a road where there are multiple boxes at the top of the road, having your 911 number on your mailbox will not help the emergency responders find you," stated Stilwell.  
Some signs are also being posted directly on the house itself, and this is becoming a challenge for the emergency

responders. "If we can't see their house clearly from the road, we can't see the numbers. If their emergency is in the middle of the night, most emergency vehicles' headlights can't reflect the sign," stated Stilwell.  
The best way for residents of this area to place their 911 reflective address plates is to think about these two things: could I find my house in the middle of the night for the first time, and what would I need to find my house for the very first time in the dark? When asking these questions, residents can better understand where they might need to place signs and how many they might need.  
An ordinance was recently passed requiring all residences and commercial businesses to have the numbers of their street addresses posted for the use of fire protection services. A fine may be imposed if those who violate the order don't put up signs within 15 days following a warning.  
The Eagle Rock-Golden-Mano Fire Department is hoping to make all community members aware of the change regarding 911 address signs. If anyone has questions regarding signage, please contact the fire department at (417) 271-3642.

## Mother charged for assault

Dawn Marie Bell, of Purdy, was arrested on November 3 for trespassing in the first degree, possession of up to 35 grams marijuana, and endangering the welfare of a child in the first degree.

Around 7:50 p.m. on Sunday, Bell allowed her four small children to ride in a vehicle with an intoxicated driver with a blood alcohol content of 0.111 to an address on Farm Road 2147 in Wheaton, according to affidavits of probable cause.

Upon arrival, she entered into the victim's house without permission and assaulted the resident by punching and hitting him. At the time, she was in possession of a green, leafy substance believed to have been marijuana.

Bell was released from the Barry County Jail on November after posting a \$12,000 bond.

next summer. Each of the 18-foot by 18-foot tents will sleep four to five campers, with the camp eventually expanding to 16 kids per session.

The camp will be run by combat veteran counsellors aside from one licensed professional. The basis of the camp will be counseling, but the kids will get plenty of wilderness experience in the thrilling adventure camp.

The whole basis is to support the kids involved through counseling, coping skills and support. The primitive camp will give them the experiences of floating, hiking and seeking nature adventures without technology. The camp also plans to take the kids on a zip-lining trip in Branson to complete the experience.

Through this camp, kids who may not have anyone to connect with in their experiences can learn that they don't have to go through their journey alone. ## Barry County sales tax sees increase for October

Barry County saw a slight increase in sales tax revenue for the month of October in 2013. This year the county received \$136,607.35 in tax revenue, an increase of 2.65 percent over last year. In 2012, sales tax revenue was \$133,084.83 for the month of October.

The additional \$3,522.52 received for the month from

2013 over 2012 is a trend continuing for the past few months in the county. July, August, September and October all saw increases of some degree, but the county is still down 1.50 percent for the year comparatively.

Cassville City sales tax amounts are expected to be available next week following the monthly city council meeting.



## Red Ribbon Week promotes drug-free

During the last week of October each year more than 80 million young adults show their commitment to a drug-free life by wearing or displaying the red ribbon associated with Red Ribbon Week. While it remains a popular event in schools around the United States, many people do not know the origins of the weekly activity that brings awareness to substance abuse among youth.

Red Ribbon Week started to honor Enrique (Kiki) S. Camarena, who spent 15 years in law enforcement. However, there is much more to the story. In May of 1973, after one year at the Calexico Police Department, Camarena started working as a Narcotics Investigator with the El Centro Police Department. That promotion then led him to join the Drug Enforcement Administration (DEA) in 1974. Camarena received a transfer order for Mexico four years later.

For four and a half years, he was on the trail of the

largest marijuana/cocaine trafficker and multibillion dollar drug pipeline. This all came to a screeching halt when Camarena was kidnapped on February 7, 1985. On that tragic day, Camarena was surrounded by five armed men who threw him in a car, proceeding to speed away.

It is believed that Special Agent Camarena was killed March 3, 1985, at the age of 37. Camarena was taken from his wife, Mika, and their three children: Enrique, Daniel and Erik. During Camarena's life, he was awarded two Sustained Superior Performance Awards, a Special Achievement Award, and the Administrator's Award of Honor, which is the highest award granted by the DEA, postmortem.

After Camarena passed, Camarena Clubs were launched in his hometown of Calexico, California. Hundreds of students and club members wore red ribbons and pledged to lead drug-free lives in honor of Camarena and many others who made

sacrifices. Red Ribbon Week eventually spread throughout the United States as a way to help students realize the effects of drug use.

Cassville Schools have been celebrating Red Ribbon Week for over 15 years. Each year they have a spirit week ending with a parade. Oak Lodge, in Holiday Island, Ark., also shares a drug free presentation for the Intermediate School.

During spirit week, students are encouraged to participate in the many activities, such as wearing red one day or Duck Dynasty attire another. However, this year's parade was canceled due to weather. "Red Ribbon Week is always a success. The kids enjoy the activities and lessons," stated Cassville Intermediate School principal Eric White.

Cassville Intermediate also hosts an essay contest where students write about the importance of staying drug free. This year's winners were: Jordyn Stafford, Grayson Kirkpatrick and Ayasha Prillwitz.

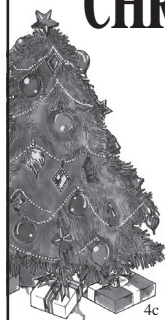

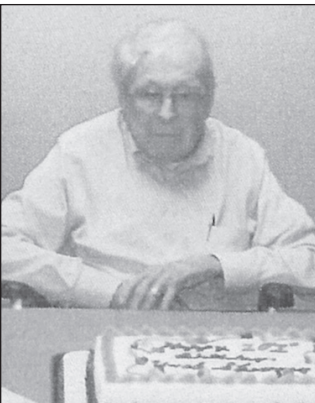
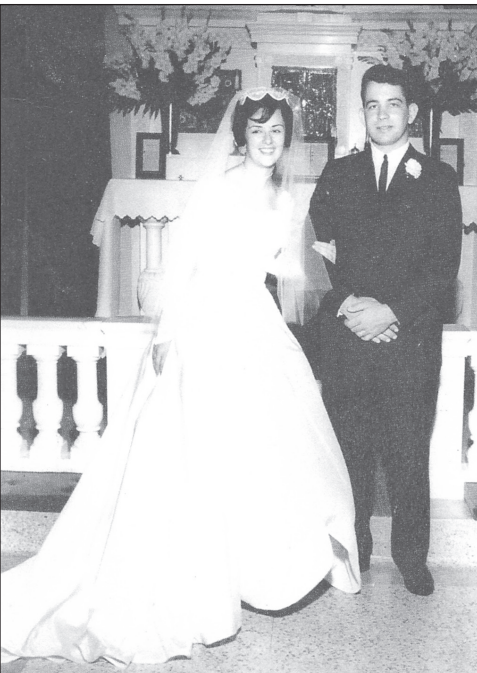

# Barry County sends multiple offenders to prison

**Roger Bland**, Rogers, Ark., received a suspended sentence for five years in incarceration after entering a guilty plea for class C felony receiving stolen property.

According to affidavits of probable cause, on November 26, 2012, Bland was found trying to sell a 2001 Chrysler PT Cruiser which was reported stolen from Green Forest, Ark., on November 12. Bland was attempting to sell the vehicle, valued at \$8,000, to Rebel Recycling in Cassville.

**Kathryn Deane Dailey**, of Seligman, pled guilty to class C felony theft/stealing. She received seven years in incarceration which was suspended to five years supervised probation.

On March 21, 2013, Jerry Trinkle, of Seligman, brought a game camera to the Barry County Sheriff's Office with photos of three individuals stealing various items from his property. Detective Doug Henry identified one suspect as Dailey according to the affidavit of probable cause. Stolen were a 1991 Ford F-150, a

flatbed utility trailer and other antique and metal items.

**John Durosette**, of Seligman, pled guilty to class C felony possession of a controlled substance. He received four years incarceration to run concurrently with another sentence.

On May 15, 2013, Deputy Justin Ruark of the Barry County Sheriff's Office did a warrant search of a property on Farm Road 1045 in Seligman. Durosette was found hiding near a bed underneath a blanket in a back bedroom. Drug paraphernalia in the room field tested positive for methamphetamine, according to the affidavit of probable cause.

Durosett admitted to using methamphetamine knowing of its illegal nature. He also had a history of drug abuse and possession charges.

**Tina Ann Easley**, of Exeter, pled guilty to class C felony theft/stealing. She received a suspended imposition of her five year sentence and was placed on supervised probation slated to end October, 2, 2018.

On February 25, 2010, Easley filed for unemployment benefits with the State of Missouri Division of Employment Security at a time when she was actively

employed. Easley received \$6,110 in unemployment benefits during that time. In a face-to-face interview with Zac Jenkins, investigator, she confessed to filing a series of falsified claims for unemployment insurance.

**Jody Lynn Fisher**, of Monett, pled guilty to class C felony domestic assault in the second degree resulting in a five year sentence with the execution of sentence suspended. His supervised probation is set to end November 13, 2018.

According to the affidavit of probable cause, Fisher hit the victim in the face and forehead several times with keys in his hands. Fisher then kicked the victim in the stomach two times, preventing her from breathing.

Marks and bruising were seen on her upper thigh with a lump on the back of her head and forehead. The victim also claimed she was kicked in the crotch, right hip and buttocks. The altercation was witnessed by their six year old son.

**Jose Garcia-Conzalez**, of Purdy, pled guilty to statutory sodomy in the first degree and child molestation in the first degree, both felonies. He received two ten-year incarceration sentences.

According to the affida-

vit of probable cause, Garcia-Gonzalez molested two young girls, ages five and seven, on October 21, 2012, at an Exeter residence.

**Larry S. Gilbert**, of Monett, pled guilty to possession of a controlled substance, a class C felony, resulting in five years supervised probation. His original five year sentence was suspended.

Gilbert was in possession of opened 25 mcg/h Fentanyl patch and two syringes. Gilbert admitted that he had used Fentanyl, "cut" with apple juice, and injected it into his blood stream. He also possessed an additional five unopened Fentanyl patches and two syringes he had hidden in a restroom in Cassville.

**Megan M. Haebler**, of Purdy, pled guilty to unlawful use of drug paraphernalia and was sentenced to 90 days incarceration with the execution of sentence suspended. She is serving one year unsupervised probation.

The crime took place on May 5, 2012, at approximately 7:30 p.m. Haebler was found to have a nine year old boy in the front seat of a truck with a shake and bake methamphetamine lab within reach. She also had digital scales, a razor blade, ziplock bags and

other materials used for the manufacture and distribution of methamphetamine.

**Robert W. Hipkins II**, of Exeter, pled guilty to theft/stealing, possession of a controlled substance and theft/stealing of a firearm. He was sentenced to 5 years incarceration.

Hipkins was pulled over for a traffic stop for lane violations on State Highway 76 by Deputy Bill Watkins with the Barry County Sheriff's Office on June 8, 2013. Hipkins gave verbal consent for a vehicle search where the deputy found a 9mm pistol with seven live rounds inserted.

There was also a knife case containing a clear glass pipe with a white residue that field tested positive for methamphetamine in the truck along with four baggies with white residue.

**Keisha D. Jester**, of Washburn, entered an Alford plea for possession of any methamphetamine precursor with intent to manufacture.

On February 2, 2013, Southwest Missouri Drug Task Force Agent John Luckey observed Jester in a vehicle with other passengers purchasing pseudoephedrine caplets used in the manufacture of methamphetamine. Jester's bag contained an empty box of capsules, while a total of 50 pills were seized from the vehicle. Other pas-

sengers had methamphetamine on their persons.

**Alex E. Lindsey**, of Humansville, pled guilty to second degree robbery and receiving stolen property in November 2011 resulting in a suspended imposition of a five year sentence. His probation was revoked, and he is slated to be incarcerated until June 20, 2017.

On June 14, 2011, Lindsey approached the victim, stole his wallet and pushed him to the ground, causing a red mark on the arm. Lindsey admitted to the crime when confronted by officers.

**Michael P. Lingo**, of Seligman, pled guilty to second degree domestic assault and was sentenced to 5 years incarceration.

**Justin A. Martin**, of Pleasant Hope, pled guilty to possession of a controlled substance, unlawful use of drug paraphernalia and forgery, and was sentenced to three years incarceration.

On June 15, 2012, a Missouri State Highway Patrolman observed Martin and a woman pull a bag from his pocket containing methamphetamine. Martin then injected the woman and himself with a substance in a syringe which field tested positive for methamphetamine.

Officers arrested both suspects. It was later determined

that Martin gave a false name when he was arrested, resulting in the forgery charge.

**Marcus J. Nelson**, of Monett, pled guilty to forgery in 2011. He is currently serving supervised probation until October 22, 2018.

On April 11, 2011, Nelson stole checks from the victim, James Hughes, and proceeded to write checks to cash, receiving \$125 from the crime.

**Eric L. Patterson**, of Purdy, pled guilty to theft/stealing in 2009. Patterson received a suspended execution of a five year sentence before his probation was revoked. He has since been placed back on probation set to end October 21, 2018.

**Omer Pearson**, of Shell Knob, pled guilty to possession of marijuana and received a suspended sentence of six months incarceration and one year unsupervised probation.

On May 29, 2012, Deputy T. Burgess of the Barry County Sheriff's Office located prescription bottles full of marijuana seeds and 42 marijuana plants at Pearson's residence on Farm Road 1250 in Shell Knob. The marijuana plants ranged in height from 12" to 36".

**Jeffrey S. Pedersen**, of Stark City, pled guilty to debit/credit fraud, and was sentenced to two years incarceration.

On January 3, 2013, Pederson used a debit card belonging to Julia Wolfe at the Purdy Ramey's Store and

the Country Corner Convenience Store. He also used the card to withdraw money from her account in Purdy and at the Downstream Casino in Quawpaw, Okala.

Pederson admitted to using the stolen card to officers. The total charges were \$932.52.

**Lori A. Pruitt**, of Wheaton, pled guilty to possession of a controlled substance and second degree burglary and received a suspended imposition of a five year sentence. Her supervised probation will end October 22, 2018.

On September 20, 2012, Pruitt entered the Cassville Mercy Cafeteria through a door accidentally left unlocked by an employee. She made a sandwich, fixed a soft drink, and then left. Officers identified Pruitt, and she admitted to entering the cafeteria.

**Leeds J. Regan**, of Vero-

na, pled guilty to possession with intent to manufacture a controlled substance, and was sentenced to five years incarceration.

On June 28, 2011, officers with the Southwest Missouri Drug Task Force made contact with Leeds, stating that they had been tracking his pseudoephedrine purchases. At that point, Leeds admitted that everything in his trailer was his and allowed officers to conduct a search.

The search yielded a variety of methamphetamine manufacturing materials, including shake-n-bake bottles and many items that field tested positive for methamphetamine.

**Timothy D. Sain** entered an Alford plea for receiving stolen property receiving supervised probation. Probation has since been revoked.

**Dennis M. Schmidt**, of Verona, pled guilty to driv-

ing with revoked/suspended license and possession of controlled substance and received four years incarceration.

On September 12, 2012, a Monett Police Department stopped a vehicle for exceeding the posted speed limit by ten mph. The driver was not wearing a seat belt, and the MULES system showed him to have a suspended driver's license.

Then, on February 15, 2013, Missouri Highway Patrol found an abandoned vehicle with paperwork belonging to Schmidt in the glove box. Schmidt had two misdemeanor warrants and a felony warrant at that time.

Troopers then attempted to serve the warrants to Schmidt's address, but no one would respond to officers. While on the property, they observed an ATV that was found to have been re-

ported stolen.

Officers requested a search warrant from Barry County Detective Doug Henry given the circumstances.

Once Sheriff's deputies arrived, officers prepared to enter the house when Schmitt announced, "I'm coming out," and exited the residence with a female.

Various items in the residence field tested positive for methamphetamine following a search.

**Brandon J. Scott**, of Golden, pled guilty to two charges of first degree burglary and was sentenced to six years incarceration.

On February 15, 2013, Scott entered into the victims' residence in Golden without permission and attempted to remove pajama bottoms from a woman while she slept. Another resident of the home punched Scott and


chased him from the residence.

Scott returned two hours later, entering through a window. He then pulled a knife on the nine-year-old girl in the home, sexually assaulted her, causing her to scream. Scott then fled the residence. Scott was on parole at the time and is a registered sex offender.

**Richard L. Swore**, of Washburn, pled guilty to possession of controlled substance and received a suspended imposition of a five year sentence. He is serving supervised probation until October 9, 2018.

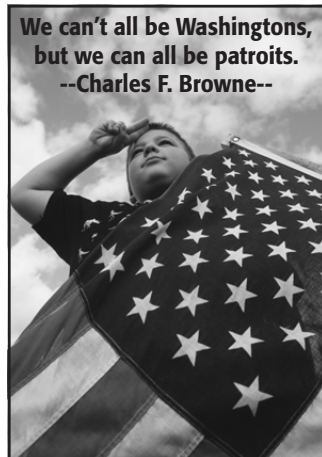

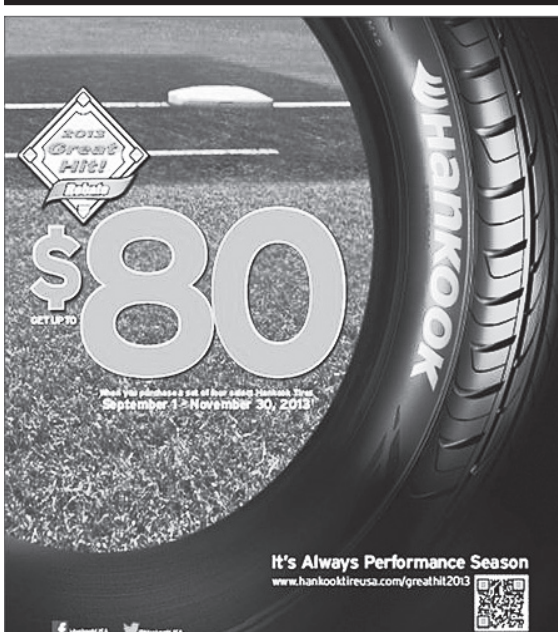
