Hillbilly Chili Bash feeds a crowd

Sunny weather, a cool breeze and smells of simmering pots of chili drew out a crowd on Saturday for the annual Chili Cook-Off. This year's theme, Hillbilly Chili Bash, also encouraged everyone to step out in their overalls and participate in the community tradition looked forward to each year.

The day started at 8 a.m. with the YMCA Chili Run. The 5K and one-mile fun run began at 8:30 a.m. at the square. The Overall Male winner was Ron Bouchard with a time of 21:45. The Overall Female winner was Courtney Beagle with 24:48. Masters Male and Female were Dennis Jacobs (24:42) and Sherri Cook (25:43). A total of 111 booths around the square, decorated to the hilt in hillbilly style, opened at 8 a.m. Prior to the chili and salsa tasting, the crowd enjoyed music by the Flyin' Buzzards, a Pet parade sponsored by Herrin Animal

Hospital and more.

Sonic's Fifth Annual Chili Dog Contest saw a new champion. As the all-men competitor table scarfed down their chili dogs, William Naugle, of Cassville, blew the competition away by knocking back five chili dogs in two minutes.

Following the Chili Dog Contest, Sonic brought out their three trick skaters to wow the crowd. Wesley Waters, Katie Sewell and Jeffrey Brophy performed to music with twists, turns, flips and more. Sewell recently competed in the National Skate-Off for trick skating carhops as one of the eight top competitors in the nation.

Once the Chamber opened up the tasting, bells rang out as people travelled to each booth, judging each for their decorations, spirit, best chili and best salsa. Some booths had obvious draws, like the pooch stationed outside RealLife Worship Center's booth laid next to a "Please Feed Me" sign. RealLife won for the Best

Decorate Booth this year, with Barry Electric Cooperative earning Most Spirited. This year, 15 booths cooked chili and six entered salsa.

Outside of the Chili Contest, a variety of businesses and organizations raffled off items for different causes. Kornerstone's Teen Mom Program benefitted from a successful raffle of four gas cards presented to Tom Miller of Shell Knob, Kathy Bernsen of Shell Knob, John Walker of Mission, Kan., and Chris Kilts of Cassville.

According to Mindi Artherton with the Cassville Area Chamber of Commerce, "Our committee worked tirelessly all day Saturday and in the months prior to the cook-off to make sure it was a success. This event requires all hands on deck for our cook-off committee and the chamber is so thankful for all their hard work. We also really appreciate the hard work of our chili and salsa cooks. It is not easy to prepare gallons upon gallons of chili and salsa.

Evening shows were held on Thursday and Saturday at 7:30 p.m. with a day program on Sunday at 2:30 p.m., and concessions were provided during the entertainment by Cassville High School Project Graduation.

Over 20 acts were performed each night for the show. This included performers who were new to the stage, and those who have been a part of the Fall Show for many years. Leslie Smith

has been apart of the show on and off for 21 years. She still recalls her first performance on the stage where she sung I'm So Excited by The Pointer Sisters and Wind Beneath My Wings by Bette Midler. "I love the gratitude and the opportunity to be apart of something in the community," stated Smith.

Angela Seymour is another long time participant of the show. She has been singing since she was a kid, mostly in church and she loves to entertain. This year, Seymour wowed the crowd with her performances, singing Blue by Leann Rimes and Solider Boy by the Shirelles with Kaye Hughes. "The band is incredibly talented. The Wheaton Community building will have an open house and plaque dedication on November 3 from 2 p.m. to 4 p.m. The event will be to showcase the new multipurpose building to the community and honor the community and honor the late Donnie Powell who was instrumental in making the city building a possibility.

Powell was a lifetime resident of Wheaton. He was the east ward alderman from 1998 until 2007 when he was elected mayor. Powell's goal was to ensure that the building became a reality for the

community as there was no other space available for residents of the area to host family reunions, receptions and gatherings.

The building used to be the lumberyard facility, but thanks to the efforts of Powell and his son, Jerad, the building was completed last month, just a short time after Powell passed away on July 11.

Jerad put in an additional bathroom, installed kitchen cabinets donated to the building, made the area

The warm, pastry smell of fresh-baked pies filled the lobby of the Barry County Courthouse on the square on Saturday morning. Many showed up bright and early to enter their pies in the Berry Pie Contest sponsored by the Garden Sass

Farmers' Market Association. Pies filled the judging table while the ladies of the Silver Leaf Benefit Club sampled each entry and wrote down their favorites for grand prize, best overall, taste, appearance and crust.

Farmers set up their tents around the square to sell their last garden wares while the judging took place inside. The bluegrass/gospel group Ozark Mountain Revival played to the crowd as people milled around perusing booths, watching the judges and entering a quilt raffle.

Following the judging, pies were auctioned off to raise money for the Barry County Senior Center Meals-on-Wheels program. The final amount donated was \$508.50. Ozark Mountain Revival was supposed to receive a fee for playing, but the band graciously gave their money back to the fundraiser instead.

Steve Burcham, Garden Sass interim president, stated, "We were excited to see the generosity of the community. It was uplifting on a cold, bitter morning to see the good folks turn out and help us help the Senior Center Meals on Wheels program. It was an honor and

a privilege. Special thanks to the Silver Leaf Benefit Club." Garden Sass presented the check to the Cassville Senior Center on October 29. Adena Cox-Holloway, Senior Center administrator, stated, "This is very much needed and appreciated. It helps to continue to provide meals to our home-bound seniors."

The donation made will go to provide 87 meals to seniors in the area that would otherwise have a hard time getting meals. The Center also provides meals at their facility for those who are able to travel there.

Meals - On - Wheels serves Cassville, Wheaton, Seligman, Golden, Eagle Rock, and Jenkins through volunteer drivers. Drivers are always needed for those willing to help out the community's senior citizens.

The non-profit organization provides 4,500 to 4,800 meals per month between their congregant and delivery programs.

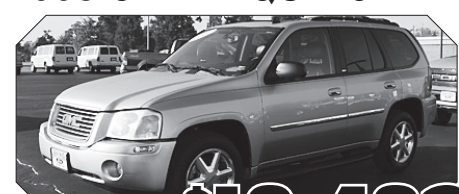

Active deer mean danger for drivers

Driving some of the roads and highways in Barry County can be treacherous as is. Add deer mating season into that, and you have a recipe for disaster for motorists.

For American Family Insurance policyholders, 40,387 claims for animals hits were made between August 1, 2012 and August 1, 2013. Of the claims for this year, 59 percent came from Minnesota, Missouri and Wisconsin.

The most common animal to be hit and cause vehicle damage are deer. According to the Insurance Institute

for Highway Safety, those crashes are three and a half times more likely in November than in August. August typically has the fewest number of hits whereas November has the highest.

The average claim for an animal collision wreck is \$2,271.58 for American Family Insurance drivers. In Missouri, over 7,000 claims were made totalling almost \$16 million. Missouri is only surpassed by Wisconsin in those numbers.

Tips offered to help prevent and reduce the chances of a deer-vehicle collision are:

- Fasten your seatbelt.
- Pay attention to deer-crossing signs.

• Be particularly alert at dawn and dusk when deer are most active.

• Keep an eye out for where deer came from. Since they travel in single-file, more may be crossing the roadway in your path.

• If you see a deer, brake firmly and safely slow the vehicle followed by honking your horn.

• If a crash is unavoidable, don't swerve, it may result in a roll over or hitting another vehicle or a more dangerous object.

If you hit a deer, contact authorities.

Following those tips may mean the difference between life and death when it comes to a deer-vehicle collision.

Travelling back in time on the Seligman train ride

Our morning began at Seligman City Hall where we signed in for our journey. I ran into friends, family and old acquaintances that I didn't expect. Then the weather gave us a chance to board the train. There was still a heavy sprinkle, not bad compared to the typhoon earlier.

Boarding the train was just one of the most memorable events in store for me that day. We crossed the road to see a path surrounded by trees. The sun had not shown itself due to the weather and time, and through the trees with the rain and distant flashes of lightening, created such an experience as only going back in time could give: the 1927 train car before us sat at the end of the path.

Had everyone dressed in period-style clothing, we surely would have thought that it was the roaring 20s. The conductor yelled, "All aboard," and we boarded a car in its beautiful original appearance. One of the cars had been used in the movie Biloxi Blues and dated back to 1917. The cars' deep wood trim with green velvet seats fit two to a seat and allowed you to turn your seat to face either direction, coming or going.

The windows were very authentic, from the interesting latches to the red velvet curtains that roll up or down to your liking. The windows raised up where you can enjoy all the scenery and air you cared to. While they suggested keeping your hands inside the cars, a friendly wave to the locals waiting for you to pass is encouraged and well-received.

The car had a very elegant look and feel, and you could hear the laughter from family and friends, waiting in anticipation for the journey to begin. The railway we travelled on was constructed

in 1880's by the Atlantic and Pacific railroads. Right away, we were welcomed and assured that if that we needed anything to let them know.

We wanted for nothing during our whole trip. Muffins and refreshments were offered in the morning, snacks and drinks the rest of the day. We were entertained by our very pleasant hosts and were given history lessons on the cars, railroad, sites and much more.

We traveled through the Arkansas Boston Mountains, which extend across northern Arkansas and southern Missouri. The Boston Mountains extend 20 to 35 miles wide and 200 miles long. Travel across the mountains was very difficult before modern conveniences. A fun fact included the name of the mountains is perhaps a corruption of a French phrase for "rough road," other sources have noted that "a Boston" was slang in the American West for any difficult task.

The leaves had not changed to their autumn color yet, but this did nothing to take away from the beauty of the scenery. On the way to Van Buren on the right side of the car, I noticed that you could see remnants of very old telephone or electric poles with the glass insulators still on them. Glass insulators were first produced in the 1850's for use with telegraph lines. As technology developed, insulators were needed for telephone lines, electric lines and other applications. Some still had wire hanging on them. Only a few were left standing along our journey.

We also traveled over three high trusses which added to the beautiful scenery out and below us. The trusses had no sides on them, so you could see all around without seeing any form of tracks. It was like

floating in the air.

We traveled through the quarter mile famous Winslow Tunnel. In 1876, the rail service between Little Rock and Van Buren began. Constructing a railroad line through the Boston Mountains, the tunnel work began on September 26, 1881. The 1,693 ft. long tunnel was finished in July 1882 and opened to rail traffic the next month. The cost was about \$200,000 to construct, a very large sum for 1882.

An outbreak of smallpox swept through the tunnel workforce of 300 men and caused dozens of deaths. You could see the crosses that honor the fallen workers along the tracks. The conductor made sure to point them out so that we would not miss this historic monument. The history of the Winslow Tunnel is a very interesting story for history lovers, I highly recommend the read.

When we reached our destination, we unloaded on historic Main Street with its Victorian charm in downtown Van Buren where the annual fall festival was taking place. There were booths on both sides all the way down Main with all types

of crafts and vendors. They had a live band and plenty of food with benches along the stores to enjoy down time from shopping.

Aside from the crafts, there was plenty to see, including the Victorian style, historic train depot with its museum, and six blocks of art galleries, antique shops, restaurants and unique shops located along the historical street. The stores along the strip were a wonderful display of historical buildings from an era long ago.

Main Street was featured in a couple movies: The Blue and Gray and Frank and Jesse. My friends and I enjoyed a great lunch at the Boomerang Diner that was once the Anheuser-Busch Brewing Company. The building was kept as original as possible. I particularly enjoyed the store that had the reenactment clothing. The two store clerks was dressed as cowboys with their own jail inside the store, a great photo opportunity.

When the time came, we loaded back on the train to enjoy our ride home. I recommend that you sit on the other side of the seats that you came down on to en-

joy all of the scenery that the ride has to offer. The staff made the trip so enjoyable, as did seven of my dear friends that went with me on this voyage. Friends that make you laugh are a treasure in life that you can't replace. A special thanks goes to Cleta Stanley for the opportunity. I highly recommend this trip to anyone who would love a nice trip to get away for awhile. Travel back in time without leaving the future. I will be enjoying this ride once again when the time permits.

Renovations bring life back to historic Bayless home

For one old Cassville house, it has taken 13 years and a lot of TLC to start to resemble what it was in its glory days. The Bayless-Salyer home on Townsend Street sat in a state of disrepair for a number of years, eventually being condemned by City of Cassville before the Barry County Genealogical and Historical Society took notice and purchased it.

The home was originally built in the late 1870's by John M. Bayless. By 1879, Bayless wrote in his journal that they were living comfortably in the home. His complete journal has been copied and archived to be displayed in the home once the renovation is complete.

Bayless and his brother, W. K. Bayless, originally lived in Washburn. He would eventually become a well-known and respected community member, serving as a county official. Bayless came from humble beginnings, but worked his way up to owning a mercantile store and lumberyard, as well as beginning the first private bank in Barry County. This sparked the movement to create the first Barry County Bank in 1889, which was the first state-chartered bank in Barry County. Shortly thereafter, in

1896, that led to the completion of the railroad from Cassville to the Frisco Line in Exeter, which operated for 60 years.

Bayless lived in Cassville until 1901 when he moved to Claremore, Oklahoma where he lived until his death in 1907. The iconic house on Townsend would become part of his heritage and history.

Following the Bayless family, the home was purchased by the Salyer family who made a variety of changes, including a different porch and conversion of the interior to house apartments in the 1930s.

John Q. Hammons even lived as a tenant there for a stint, sparking his generous donation to help reclaim the house and preserve it for historical reasons.

In 2000, the Society purchased the property from the wife of the late Dr. Johnson. Dr. Johnson also had an office built next door to the property.

The renovations to the home have been dramatic to bring the two-story red brick home up to code while

maintaining historical integrity. The back portion of the building had to be completely rebuilt when the brick walls collapsed.

Room by room, the Bayless-Salyer house is taking shape into what it once was. Each remodelling decision is being made to keep the house as historically accurate as possible. Once complete, the Society hopes to rent the building to various clubs and organizations to help maintain the upkeep on the property.

The roof had to be redone, including the clay tiles. The porch's ceiling is adorned with custom-made tin tiles matching the originals. Inside, each room is completed and remodeled as funding is available. The entire project is done on donations.

The originally collapsed back portion is now the Roden room, dedicated to Loren and Mildred Roden for their efforts in raising funds for the project. The Roden room will be a research room, including a donated

microfilm reading machine.

The Lee room sits next to the Roden room and houses old marriage records from the Courthouse. Mrs. Bob Lee of Shell Knob gave funding to finish that room in memory of her husband. For the home, most donations have been made in honor or memory of a loved one with ties to the area. Each window will don a plaque beside it, stating whose honor it was in.

While the building is taking shape, much is yet to be done. Former Barry County Genealogical and Historical Society president Georgia Hart stated, "We've come a long way. It has taken a lot of hard work and many volunteers. We're really proud of how far we've come, now we

just need to finish it out."

The house was opened up to visitors on Saturday, October 26, during the annual Chili Cook-Off. People could view the inside and see the work completed, and importantly, what still needs to be done.

Currently, the Society is seeking general donations, or donations to replace the pillars out front which are experiencing severe decay. To sponsor a pillar, the cost is \$395.

CPD busts two in meth house raid

Two men from Cassville were arrested on methamphetamine charges last week. Scott Boden, age 51, and Ernest Jenkins, age 51, were charged with manufacturing a controlled substance. On October 24, Officer Clinton Danforth of the Cassville Police Department arrived at Dennis Raines's residence during a narcotics-related investigation.

When Raines opened the door, Officer Danforth noticed a strong chemical smell and asked if he could enter the residence. While inside of the house, he first noticed that an outside trash can had a strong chemical smell and found inside was an empty box of lithium batteries, instant ice compresses and lithium strips, along with their receipts.

Officer Danforth also noticed a white coffee filter rolled up on the ground and a spot where white and green granular substance was dumped. Evidence was consistent with the shake and bake method of manufacturing methamphetamine.

While the search was being conducted, Raines stated that he was not involved with the meth production and that he was sleeping in his chair only to be woken up by a strong chemical smell coming from the back of the trailer.

During the investigation, Ernest Jenkins pulled up to the residence and was found to be carrying methamphetamine. Ernest and Scott were arrested by officers, admitting that they had been manufacturing methamphetamine. Both men are being held in the Barry County Jail in lieu of \$25,000 bonds.

This year, once again, the Cassville Police Department participated in the state-wide Prescription Drug Take Back (P2D2) Day, an initiative to help the community safely dispose of medications that could otherwise cause accidental poisonings or threaten the cleanliness of the local water supply.

The Cassville Police Department held their P2D2 event on Saturday, October

26. They accepted prescription medications from 30 different people and collected 74.4 pounds of medications.

Last year, Cassville collected 90 pounds of prescription medications. In 2011, they collected 70 pounds.

The importance of drug take-back events is not just for the environment, but also to prevent drug abuse and accidental poisonings. According to the P2D2 website,

some medications can become toxic once they expire, posing a danger to the person taking them.

According to the Center for Disease Control's website, 86 people a day die from accidental poisonings with 91 percent of those from prescription medications. Properly disposing of any unused or expired medications helps in preventing poisonings.

Cassville Police Department has been participat-

ing in the event for the last several years. Programs are instrumental in preventing children or adults from poisonings and people from disposing of medications by flushing them down the toilet or dumping them in the trash where they could pose environmental hazards.
