

# Pythagoras Lodge 383 celebrates 150th anniversary

The Pythagoras Lodge 383 celebrated its 150th anniversary in 2022, but due to scheduling conflicts, it could only commence last Saturday, August 12. Members of the community were invited to join the fraternal brotherhood in celebration.

Though the Masonry came to Barry County initially in May of 1852, the then Barry Lodge 130 was short-lived as its charter was removed three years later. The John Dade Lodge 144 succeeded the Barry Lodge in 1855 and was destroyed during the Civil War in 1861.

On April 3, 1871, District Deputy Grand Master Brother W.S. Street came to Cassville and set up Pythagoras Lodge, where it worked under dispensation until it was granted a charter to become Pythagoras Lodge 383 on October 16, 1872.

The first communication of the Pythagoras was held on November 14 of the same year with

District Deputy Grand Master (D.D.G.M.) Brother James Robinson presiding. The following officers were elected at the time: Worshipful Master (W.M.) Charles S. Bryan, Senior Warden (S.W.) John Ray, Junior Warden (J.W.) William Noel, Southern Deacon (S.D.) M. Horine, Junior Deacon (J.D.) J.B.W. Bennington, Treasurer W.G. Townsend, Secretary R.R. McGuire, and J.W. Hawk Tyler. The fraternity was housed on the southeast corner of the Cassville Square. The frame building burned down on April 18, 1893, and was rebuilt immediately after, and the first meeting was held in the new building on November 18, 1893, and was in use for the next 96 years.

On April 17, 1984, the brethren voted to sell the building and build a new hall away from

Control announced the arrest of Maynard Burlen Lipscomb, 70, of Washburn.

Lipscomb was arrested on August 10, 2023, for sexual misconduct involving a child following an investigation by the Missouri State Highway Patrol's Division of Drug and Crime Control/Troop D Criminal Investigative Unit. Investigators with the Michigan State Police assisted in the investigation.

On July 26, 2023, investigators received information from the Michigan State Police of a juvenile female who

## Tyson Foods announce closure of Noel plant

Tyson Foods announced they are closing the Noel chicken processing plant in October of this year. The closure will eliminate over 1500 jobs associated with the plant.

# Hobbs State Park-Conservation Area to host nationally known bird expert in talk about Ozark chinquapin trees

*From Arkansas State Parks*  
 Hobbs State Park-Conservation Area will host Joe Neal, a nationally known bird expert, on Sunday, August 20, at 2 p.m. at the park's visitor center, located at 20201 E. Highway 12, in Rogers, Arkansas. Neal will discuss his recent study of the Ozark chinquapin tree and the birds and pollinators that visit them. The event is free and open to the public; reservations are not required.  
 A chestnut blight that hit northwest Arkansas 65 years ago brought Arkansas's native chinquapin tree near extinction. The species is making a recovery, including trees planted at Hobbs State Park-Conservation Area.  
 Earlier this summer, Neal studied the trees at Hobbs State Park-Conservation Area, photographing birds and insects that visited the trees' male catkins. Neal's observations reveal the numerous pollinators drawn to the trees, including the specific birds that visit to eat insects. Until now, his data has not been shared with the public. Neal will discuss his observations and how learning more about the Ozark chinquapin's pollinators can help restore this species to its native range.  
 Hobbs State Park-Conservation Area is the largest of Arkansas's 52 state parks. This day-use park includes a 54-mile trail system and is the only state park in Arkansas to allow regulated hunting.  
 Arkansas State Parks is a division of the Arkansas Department of Parks, Heritage and Tourism.  
 Arkansas state parks and museums cover 55,006 acres of forest, wetlands, fish and wildlife habitat, outdoor recreation

reported she was the victim of a sexual assault alleged to have occurred in Barry County in the summer of 2022. On August 10, 2023, investigators with the Missouri State Highway Patrol's Division of Drug and Crime Control interviewed the suspect in the sexual assault, Maynard Burren Lipscomb, who confessed to having had inappropriate sexual contact with the juvenile female.

On August 11, 2023, Lipscomb was formally charged by the Barry County Prosecutor with two counts of sexual misconduct involving a child. He is currently held in the Barry County Jail on a \$50,000 cash-only bond.

The above charges are mere accusations and are not evidence of guilt. Evidence supporting these charges must be presented before a court of competent jurisdiction whose duty is to determine guilt or innocence.

the application. School officials may verify current income or other information provided on the application at any time during the school year.

Foster children may be eligible regardless of the income of the household with whom they reside. Households with children who are eligible under the foster, Head Start, homeless, migrant, or runaway programs should contact the school for assistance in receiving meal benefits. Special Supplemental Nutrition Program for Women, Infants, and Children (WIC) participants may be eligible for free or reduced price meals.

Children who are members of households currently certified as receiving Food Stamps, TANF or FDPIR are eligible for free meals. To complete an application, the household must provide the names of the children, a statement that the household receives the qualifying benefits, the Food Stamps/TANF/FDPIR case number, and the signature of the adult household member making application. When known by the school that members of a household are receiving assistance from Food Stamps, TANF or FDPIR, households will be notified of their children's eligibility for free school meals. If any children in the household were not listed on the eligibility notice or not listed on the application, the household should contact the school to have benefits extended to all children in the household.

If a family member becomes unemployed or if family size changes, the family should contact the school to file a new application. Such changes may make the children of the family eligible for these benefits.

Under the provisions of the policy, the Cassville R-IV School District will review the applications and determine eligibility. If a parent is dissatisfied with the ruling of the determining official, they may wish to discuss the decision with the hearing official on an informal basis or he/she may make a request either orally or in writing to the Cassville R-IV School District, 1501 Main, Cassville MO 65625. Hearing procedures are outlined in the policy. A complete copy of the policy is on file in each school and in the central office where any interested party may review it.

# MDC managed waterfowl reservations open Sept. 1

From Missouri Department of Conservation

The Missouri Department of Conservation (MDC) reminds hunters that the pre-season reservation period for managed waterfowl hunts this season will run Sept. 1-18 with results posted Oct. 1. The in-season weekly drawings will take place on Monday afternoons with a seven-day application period that opens the Tuesday before and closes the Monday



of the draw at 3 p.m. Missouri residents and qualifying non-residents, such as students from out of state or members of the military stationed in Missouri, can apply online for a reservation to guarantee them an opportunity to hunt on a specific day on a specific area. Residents and nonresidents can also arrive at a managed waterfowl hunting area the morning they wish to hunt and wait in line for the possibility of getting a hunting spot. Applicants for waterfowl reservations must have their required permits to apply, and their Federal Duck Stamp to hunt. MDC offers managed waterfowl hunting on more

than a dozen conservation areas specially managed with a focus on wetlands. Hunters can apply for a reservation or participate in a daily morning drawing for opportunities to hunt at these areas. MDC also offers waterfowl hunting on other conservation areas. In addition to MDC areas, Missouri offers waterfowl hunting opportunities at numerous other public and private locations around the state. For this fall, the MDC waterfowl reservation system will offer 50 percent of daily hunting positions for the managed-hunt areas through online reservations. Of the 50 percent of spots through online reservations, half will be for pre-season applications and half will be allocated during a weekly in-season application period. The remaining 50 percent of spots will be held for hunters who participate in the daily morning drawing and wait in the "poor line" for the possibility of getting a hunting spot. Successful pre-season and in-season reservation applicants will be notified after their respective draws via

email or text message with their hunt date, location, and pill assignment. "Pills" designate the order hunting parties select their hunting locations on the area. The lower the number, the sooner hunting parties get to select their hunting location. Only one member from each hunting party will be allowed to have a staff member pull a pill for their respective party. Residents and nonresidents can hunt with a reservation holder and hunting parties are limited to a maximum of four people. Hunters with disabilities can apply to use ADA hunting blinds through the online reservation system during the same timeframe as the preseason application period. ADA blinds that are not selected and allocated during the preseason drawing will be placed in the weekly in-season draws. Monarch butterflies are a delight to see and a marvel of nature. Learn about their transformative life cycle and impressive migrations when the Missouri Department of Conservation (MDC) and the Mid-Continent Public Library will co-host a free virtual Monarch Mania program from 6:30 to 7:30 p.m. on Tuesday, Aug. 29. The butterflies start life as a tiny egg, hatch into a growing caterpillar, form a pupa, and then emerge as a large orange and black creature that sips nectar from flowers. This workshop will cover how the monarchs transition between life stages, and how adults in autumn make migrations south in autumn and back northward in spring to keep the species a part of the natural landscape. ### RSV and Older Adults

I did an article last winter about the severe RSV outbreak affecting infants and young children. Now I wanted to let you know about RSV infection's effects on older adults and adults with chronic medical conditions. RSV season in most regions of the U.S. starts in the fall and peaks in winter.

RSV infections can be dangerous for certain adults. Each year, it is estimated that 60,000-160,000 older adults in the United States are hospitalized, and 6,000-10,000 die due to RSV infection. Adults at highest risk for severe RSV infection include:

- Older adults
- Adults with chronic heart or lung disease
- Adults with weakened immune systems
- Adults with certain other underlying medical conditions
- Adults living in nursing homes or long-term care facilities.

RSV vaccine can help protect adults aged 60 years and older from RSV. Talk to your healthcare provider to see if a vaccination is right for you. If you are at high risk for severe RSV infection, or if you interact with an older adult, you should take extra care to keep them healthy:

- Wash your hands often with soap and water for 20 seconds or use alcohol-based hand sanitizer.
- Keep your hands off your face.
- Avoid close contact with sick people.
- Cover your coughs and sneezes.
- Clean and disinfect surfaces that people frequently touch, such as doorknobs, mobile devices, and toys.
- Stay home when you are sick.

Adults with RSV infection typically have mild cold-like symptoms, but some may develop a lung infection or pneumonia. RSV can sometimes lead to worsening serious conditions such as Asthma, Chronic obstructive pulmonary disease, and Congestive heart failure. Older adults who get very sick from RSV may need to be hospitalized. Older adults are at greater risk than young adults of severe complications from RSV because our immune systems weaken with age.

# Stock Market Insights

## No Visible Cracks

A major crack appeared in a roller coaster's support beam last month. The tallest roller coaster in North America was shut down after a dad watched his kids ride it and noticed a cracked support beam. Cracks are signs of future calamity, but thankfully this earnings season shows no visible cracks in the market.

This quarter's earnings reporting season is mostly behind us, with about 85% of S&P 500 companies having reported their results. There weren't any rock-star results that said stocks were about to jump, but the numbers were good enough to lessen the chance of a big downturn.

Here are a couple of my takeaways from this earnings season:


1. Company earnings (profits) have probably hit their lows for this cycle. With 424 of the S&P 500 companies having reported results, 80% beat their projections. This past April, May, and June will probably mark the low point for this earnings cycle.
2. Profit margins have been surprisingly stable this year so far. Coming into earnings season, I was concerned about how the companies in the market would continue to make money while overall sales went down. They provided value to their stockholders by keeping costs down enough to stay profitable.

So while this past quarter's earnings results were better than most expected, I don't see stocks going on a run in the next month or two. However, I am encouraged by the numbers. The economy might slow some in the second half of this year, but I also wouldn't be surprised if the market climbed because the economy continues to exceed expectations.

For example, this month's CPI inflation report and this week's jobless claims report were both good enough to make the market think that the Federal Reserve won't raise interest rates in September. The market also thinks the Fed might lower rates in a few months. A Fed pause in September would be good for bonds and is a good reason for long-term investors to stay fully invested.

I'm a roller coaster guy, but this story about the crack brought back every fear I had about the Screamin' Eagle coaster in the 90s. The strange thing about that crack in the roller coaster was that it had been there for ten days before the dad took the video of the beam swaying. With investments or anything else important, you need a good team to watch for cracks.

The river is going to be rough for a few days. It had dropped some, and now it is going back up. We have had a bit more rain depending on how much we get remains to be known, but I expect the river will be dirty for a few days.

Power bait will be key if you want to catch a mess of trout. Yellow and pink have been pretty good. If you want to fish a fly rod, glo balls, San Juan worms, big woolly buggers, and flies of that sort will catch fish. You can get away with 4X or 5X Tippet, so there should be no problems breaking off for a while. You will also get away with a 2-pound or 4-pound line for a while; a 2-pound will still work best because it will sink quicker. You will be able to get away with 4-pound. It will be less visible for at least a few days.

Spinners will still work, and they might work a little better in this murky water, but I would not use them all day. They are still good, mainly in the morning, but they will work better in this kind of water if you want to throw it all day.

You can also do pretty well nymph fishing in the upper end. As the water comes up, the fish will continue to feed. Fish will move around a lot more looking for food. Sometimes this will make for a very good day of fishing. You will need to add extra weight and still use at least a 9' leader 6X. You might even get away with a heavier tip-pet, which will work well for a few days.

Best Medical Alert Systems You Don't Have to Wear

Dear Savvy Senior,

Are there any monitored medical alert devices that you know of that don't require pushing a wearable help button? My 82-year-old father, who lives alone, has fallen twice during the past year but doesn't like wearing an SOS pendant button.

Searching Daughter  
Dear Searching,

Yes, there are actually several monitored medical alert systems and other technologies on the market today that have voice-activated capabilities that let seniors call for help using voice commands, without pushing a wearable help button.

These new technologies are very helpful for elderly seniors that live alone who forget, or prefer not to wear a help button, as well as for those who have physical challenges that makes using a help button difficult.

By simply speaking the "wake words" these devices will connect your dad to a trained dispatcher at a 24/7 monitoring center who will find out what the problem is, and get him the help he needs, whether it's calling

emergency services, or contacting a family member, friend or neighbor to come and help him.

All of these technologies also offer family/caregiver smartphone apps that will help you keep tabs on your dad from afar and notify you know if a problem occurs.

Hands-Free Medical Alerts

Some of the best voice-focused medical alert systems available today are GetSafe, Aloe Care Health and HandsFree Health.

Rated by U.S. News & World Report as their No. 1 medical alert system for 2023, GetSafe (GetSafe.com) comes with a cellular base console, voice-activated and push wall buttons, an optional personal help button and fall detection sensors. To call for help your dad would simply say "Call 911" twice and he would be connected to GetSafe's 24/7 monitoring service. Prices for GetSafe start at \$79 plus a \$30 monthly monitoring fee.

Another highly rated system is Aloe Care Health (AloeCare.com), which comes with a voice-activated Smart Hub and optional wearable help button with fall detection capabilities. This system

would connect your dad to the Aloe Care 24/7 monitoring center by simply saying "Emergency" repeatedly until connected. It can also make voice command non-emergency calls to pre-assigned contacts. Prices start at \$150 plus a monthly fee of \$30.

The WellBe by HandsFree Health (HandsFreeHealth.com) is a nice third option to consider. This comes with the WellBe Medical Alert Speaker that would let your dad call for help by saying "OK WellBe Call Emergency."

WellBe also offers hands-free calling and messaging to contacts, will answer health questions, and provide reminders for medications and doctor appointments.

It also offers a medical alert watch and pendant (sold separately) with fall detection capabilities. WellBe starts at \$100 plus \$20/month.

Smart Home Solution

Instead of a traditional medical alert system, another terrific hands-free way to call for help is to get your dad an Amazon Echo device (prices range from \$50 to \$250) and sign him up for Alexa Together (Amazon.com/AlexaTogether). This is remote caregiving service that will turn his Echo into a medical alert system. To get help your dad would say "Alexa, call for help" to be connected to their 24/7 Urgent Response center.

Alexa Together, which costs \$20/month, also works with compatible third-party

fall detection devices like Vayyar and AltumView. If a fall is detected, Alexa can ask your dad if he needs help, then connect him to the Urgent Response line and alert his emergency contacts.

Amazon Echo devices

also provide a bevy of other features your dad may find useful. For example, Echo's will let your dad make hands-free calls, receive reminders, set timers and alarms, control smart home devices, check the weather, play his favorite

music and much more.

# From the Roots Up

Greetings Friends!  
Rain, rain, and more rain. The weeds are growing at alarming rates, and the garden is blooming like crazy. It takes a lot of work to keep up with it all. I hope you have deep mulch down to discourage weed growth. If not, and you have a lot of weeds, it is best to only worry about the weeds once the ground dies a little. I know they are easier to pull when wet, but at this stage, too much soil clings to the roots when you pull up from the ground. This can disturb the roots and weaken the plant you want left in the ground. Walking on wet ground also harms the soil; it compacts it.

While I encourage you to keep walking in the garden at a minimum, I encourage you to keep up with harvesting those veggies. Veggies left on the vines for too long will tell

the plant it is done reproducing, and then the plant will begin to die off. To keep the plants healthy, the produce must be picked. That triggers the plant to bloom again and produce more. Also, with all this rain, we need to be vigilant with pruning, especially our tomatoes, peppers, and summer squash. Excess foliage is not good for the plant. Trim off the yellowed, wilted leaves on the summer squash to prevent squash bug growth and encourage new growth. Keep those tomato and pepper vines off the ground. Trim off dead and diseased leaves from the bottom of the plant up—the new growth at the top needs to be staked. I raise mine up against cattle panels and tie it up with fabric strips. Tomatoes need airflow to keep from getting mildew or fungus.

Trim, stake, harvest. Con-

tinual cycle. So my tomatoes are like going wild; what do I do with all those tomatoes? What is another way to serve my tomatoes? How about good old southern Tomato Pie?

To make a Tomato Pie, take a 9-inch pie shell, bake it in the oven at 350 for 10 minutes. Fry up four slices of bacon, drain, crumble, and set aside. Then you take five large tomatoes, peel and slice them. To peel, drop into boiling water for a minute, then into cold water to make peeling easier. Take one sweet onion and either slice or dice, depending on your preference. Line the baked pie shell with a layer of tomatoes, then add a layer of onions. Use salt and pepper to taste. Add another layer of tomatoes and onions. Then take ½ cup mayonnaise, 1 ½ c. shredded sharp cheddar cheese, 2 T. Milk and mix together. Add in the crumbled bacon. Spoon this mixture over the tomatoes and onions. Pat down firmly. Crush enough Ritz crackers to make ¼ cup. Sprinkle this over the top of the pie, and dot it with a little butter. Bake at 350 for 30 minutes. Remove from oven and garnish with two diced green onions. Serve hot. Absolutely delicious. I serve with fresh green beans and cornbread for a delicious evening meal fit for company. Until next week, happy gardening!
